Kragtens die bevoegdheid my verleen by Artikel vyf van die Ordonnansie op Paaië 1953 (Ordonnansie No. 17 van 1953), verklaar ek hierby dat al die paaië in die distrik van Windhoek geproklameer voor 1 Junie 1953 gesluit sal wees, die paaië in die distrikte van Windhoek en Gobabis geproklameer na 1 Junie 1953 beskryf in Bylae I hiervan geproklameer sal wees soos daarin verklaar, die paaië beskryf in Bylae II hiervan Publieke Paaië sal wees, die paaië beskryf in Bylae III hiervan Publieke Paaië met die status van Distrikpaaië sal wees en die pad beskryf in Bylae IV hiervan 'n Publieke Pad met die status van 'n Grootpad sal wees.

Under and by virtue of the powers in me vested by Section five of the Roads Ordinance, 1953 (Ordinance No. 17 of 1953), I do hereby declare that all the roads in the district of Windhoek proclaimed prior to June 1st 1953 shall be closed, the roads in the districts of Windhoek and Gobabis proclaimed after June 1st 1953 in Schedule I hereto shall be amended as stated therein, the roads described in Schedule II hereto shall be Public Roads, the roads described in Schedule III hereto shall be Public Roads with the status of District Roads and the road described in Schedule IV hereto shall be a Public Road with the status of a Main Road.

DISTRICT OF GOBABIS.

Description of Road:

Portion closed:

ALTERATION OF STATUS.

PUBLIC ROAD No. 1402:

From a point on District Road No. 1982 on the farm Koam No. 304 generally northwards in the district of Windhoek along or near the course of the Koam River via the farms Koam No. 304, Portion 1 called Okasume of Koam No. 304, Kobos No. 305, Bergkrans No. 370 and Homusas No. 307 to a point on the lastmentioned farm; thence generally northwards along or near the course of the Koam River via the farms Homusas No. 307, Tsawis No. 308, Freben No. 345, Kuan No. 309, Dagbrek No. 365 and Keises No. 312 to connect with District Road No. 1405 at a point on the lastmentioned farm.

PUBLIC ROAD No. 1403:

From a point on Main Road No. 52 on the farm Nausgomb No. 301 generally northwards in the district of Windhoek via the farms Nausgomb No. 301, Garums No. 300 and Sannieshof No. 357 to connect with Public Roads Nos. 1404 and 1979 at a point on the lastmentioned farm.

PUBLIC ROAD No. 1404:

From a point at the junction of Public Roads Nos. 1403 and 1979 on the farm Sannieshof No. 357 generally east-southeastwards in the district of Windhoek via the farms Sannieshof No. 357 and Garums No. 300 to a point on the lastmentioned farm; thence generally northeastwards via the farms Garums No. 300, Tsammas No. 310 and Moorivier No. 360 to a point on the lastmentioned farm; thence generally eastwards via the farms Moorivier No. 360 and Auchab No. 311 to connect with District Road No. 1953 at a point on the lastmentioned farm.

PUBLIEKE PAD No. 1407:

Vanaf 'n punt op Distrikspad No. 1406 ten noorde van die opstal op die plans Goeib No. 322 algemeen weswaarts in die distrik van Windhoek oor die plaas Goeib No. 322 en Doornkloof No. 352 om aan te sluit met Publieke Pad No. 1408 by 'n punt naby die opstal op laasgenoemde plans.

PUBLIEKE PAD No. 1408:

Vanaf 'n punt op Grootpad No. 52 op die plans Aub No. 328 algemeen noord-noordweswaarts in die distrik van Windhoek oor die plaas Aub No. 321, Innisfree No. 350, Doornkloof No. 352 en Gorogoneib No. 314 om aan te sluit met Distrikspad No. 1406 by 'n punt naby die opstal op laasgenoemde plaas; vanlaar algemeen oos-noordweswaarts oor die plans Gorogoneib No. 314 om aan te sluit met Publieke Pad No. 1409 by 'n punt op laasgenoemde plans.

PUBLIEKE PAD No. 1409:

Vanaf 'n punt op Grootpad No. 52 op die plaas Karanab No. 328 algemeen noord-noordweswaarts in die distrik van Windhoek oor die plaas Karanab No. 328 en Goab No. 323 tot by 'n punt op laasgenoemde plaas; vandaar algemeen noordweswaarts oor die plaas Goab No. 323 en Uithou No. 343 tot by 'n punt op laasgenoemde plaas; vandaar algemeen wes-suidweswaarts oor die plaas Uithou 343, noord van Goab dam verby en Gorogoneib No. 314 tot by 'n punt op laasgenoemde plaas; vandaar algemeen noordwaarts oor die plaas Gorogoneib No. 314 en Hureb Suid No. 349 tot by 'n punt naby die opstal op laasgenoemde plans.

PUBLIEKE PAD No. 1410:

Vanaf 'n punt op Grootpad No. 52 op die plans Terra Rossa No. 359 algemeen noordwaarts in die distrik van Windhoek oor die plaas Terra Rossa No. 359 en Innisfree No. 350 tot by 'n punt op laasgenoemde plaas; vandaar algemeen noordweswaarts oor die plaas Innisfree No. 350 en Ganams No. 316 om aan te sluit met Publieke Pad No. 1407 by 'n punt op laasgenoemde plans.

PUBLIEKE PAD No. 1411:

Vanaf 'n punt op Grootpad No. 52 op die plaas Terra Rossa No. 359 algemeen suidwaarts in die distrik van Windhoek oor die plaas Terra Rossa No. 359, Urusis No. 317, Urugamas No. 358 en Ammams No. 318 tot by 'n punt op laasgenoemde plaas; vandaar algemeen wes-suidwaarts oor die plaas Ammams No. 318 tot by 'n punt naby die opstal op laasgenoemde plaas.

PUBLIEKE PAD No. 1412:

Vanaf 'n punt op Grootpad No. 52 op die plans Aub No. 321 algemeen suid-suidweswaarts in die distrik van Windhoek oor die plaas Aub No. 321, Sonderwater No. 361, wes van die Amalia Dam verby en Gurub No. 320 tot by 'n punt op laasgenoemde plaas; vandaar algemeen suid-suidweswaarts oor die plaas Gurub No. 320, Sonderwater No. 361 en Gedeelte A van Westende No. 10 tot by 'n punt op laasgenoemde plaas; vandaar algemeen suid-suidweswaarts oor die plaas Gedeelte A van Westende No. 10, suidwaarts oor die plaas Gedeelte A van Westende No. 9, Gedeelte B van Luvahole No. 9 en Gedeelte A van Jonkergrub No. 7 tot by 'n punt op die suidelike grens van laasgenoemde plaas; vandaar algemeen suidwaarts in die distrik van Rehoboth oor die plaas Gedeelte I van Hochland No. 37 om aan te sluit met Distrikspad No. 1982 by 'n punt op laasgenoemde plaas.

PUBLIEKE PAD No. 1413:

Vanaf 'n punt op Publieke Pad No. 1408 op die plans Innisfree No. 350 algemeen suidwaarts in die distrik van Windhoek oor die plaas Innisfree No. 350, Aub No. 321, die Hermannsriver te kruis en Innisfree No. 350 tot by die veepeos suid van die Hermannsriver op laasgenoemde plans.

I.W. Hierdie pad is geproklameer om die eienaar van Innisfree No. 350 toegang te verleen na die gedeelte van die plans suid van die Hermannsriver en is nie 'n deurpad na Grootpad No. 52 nie, so is dit onbeskikbaar vir trek.

PUBLIC ROAD No. 1407:

From a point on District Road No. 1406 north of the homestead on the farm Goeib No. 322 generally westward in the district of Windhoek via the farms Goeib No. 322 and Doornkloof No. 352 to connect with Public Road No. 1408 at a point near the homestead on the last-mentioned farm.

PUBLIC ROAD No. 1408:

From a point on Main Road No. 52 on the farm Aub No. 321 generally north-northwestwards in the district of Windhoek via the farms Aub No. 321, Innisfree No. 350, Doornkloof No. 352 and Gorogoneib No. 314 to connect with District Road No. 1406 at a point near the homestead on the last-mentioned farm; thence generally east-north-eastwards via the farm Gorogoneib No. 314 to connect with Public Road No. 1409 at a point on the last-mentioned farm.

PUBLIC ROAD No. 1409:

From a point on Main Road No. 52 on the farm Karanab No. 328 generally north-northwestwards in the district of Windhoek via the farms Karanab No. 328 and Goab No. 323 to a point on the last-mentioned farm; thence generally north-westwards via the farms Goab No. 323 and Uithou No. 343 to a point on the last-mentioned farm; thence generally west-southwestwards via the farms Uithou No. 343, passing north of the Goab dam, and Gorogoneib No. 314 to a point on the last-mentioned farm; thence generally northwards via the farms Gorogoneib No. 314 and Hureb Suid No. 349 to a point near the homestead on the last-mentioned farm.

PUBLIC ROAD No. 1410:

From a point on Main Road No. 52 on the farm Terra Rossa No. 359 generally northwards in the district of Windhoek via the farms Terra Rossa No. 359 and Innisfree No. 350 to a point on the last-mentioned farm; thence generally north-westwards via the farms Innisfree No. 350 and Ganams No. 316 to connect with Public Road No. 1407 at a point on the last-mentioned farm.

PUBLIC ROAD No. 1411:

From a point on Main Road No. 52 on the farm Terra Rossa No. 359 generally southwards in the district of Windhoek via the farms Terra Rossa No. 359, Urusis No. 317, Urugamas No. 358 and Ammams No. 318 to a point on the last-mentioned farm; thence generally west-southwestwards via the farm Ammams No. 318 to a point near the homestead on the last-mentioned farm.

PUBLIC ROAD No. 1412:

From a point on Main Road No. 52 on the farm Aub No. 321 generally south-southwestwards in the district of Windhoek via the farms Aub No. 321, Sonderwater No. 361, passing west of the Amalia dam and Gurub No. 320 to a point on the last-mentioned farm; thence generally south-southwestwards via the farms Gurub No. 320, Sonderwater No. 361 and Portion A of Westende No. 10 to a point on the last-mentioned farm; thence generally south-southwestwards via the farms Portion A of Westende No. 10, southeastern corner of Portion A of Luvahole No. 9, Portion B of Luvahole No. 9 and Portion A of Jonkergrub No. 7 to a point on the southern boundary of the last-mentioned farm; thence generally southwards in the district of Rehoboth via the farm Portion I of Hochland No. 37 to connect with District Road No. 1982 at a point on the last-mentioned farm.

PUBLIC ROAD No. 1413:

From a point on Public Road No. 1408 on the farm Innisfree No. 350 generally southwards in the district of Windhoek via the farms Innisfree No. 350, Aub No. 321 crossing the Hermann River and Innisfree No. 350 to the cattle post south of the Hermann River on the last-mentioned farm.

N.B. This road is proclaimed to give the owner of Innisfree No. 350 access to the portion of the farm south of the Hermann River and is not a through road to join Main Road No. 52, so is not available to treks.

PUBLIEKE PAD No. 1414:

Vanaf 'n punt op die Kuisebrivier in die suidwestelike hoek van die plaas Karium No. 330 algemeen noord-ooswaarts in die distrik van Windhoek oor die plaas Karium No. 330, Stanco No. 369 en Landmister No. 331 om aan te sluit met Publieke Pad No. 1416 by 'n punt op laasgenoemde plaas.

PUBLIEKE PAD No. 1416:

Vanaf 'n punt op Grootpad No. 52 op die plaas Heusis No. 329 algemeen suidooswaarts en ooswaarts in die distrik van Windhoek oor die plaas Heusis No. 329 en Landmister No. 331 tot by 'n punt naby die opstal op laasgenoemde plaas; vandaar algemeen suidwaarts, ooswaarts, suidwaarts, oos-suidooswaarts en suid-suidooswaarts oor die plaas Landmister No. 331 tot by 'n punt op die Kuisebrivier; vandaar algemeen oos-suidooswaarts oor die plaas Apies No. 287 bekend as Kelpie; vandaar algemeen noordooswaarts oor die plaas Gedeele 1 genoem Colvania van Apies No. 287 tot by 'n punt naby die opstal op laasgenoemde plaas.

PUBLIEKE PAD No. 1417:

Vanaf 'n punt op Publieke Pad No. 1408 op die plaas Doornkloof No. 352 algemeen wes-suidweswaarts in die distrik van Windhoek oor die plaas Doornkloof No. 352, Abelaibis No. 315, Gannams No. 316 en Kanan No. 309 om aan te sluit met Publieke Pad No. 1402 by 'n punt op laasgenoemde plaas.

PUBLIEKE PAD No. 1419:

Vanaf 'n punt op Grootpad No. 52 op die noordelike grens van die plaas Gedeele 5 van Gedeele B van Windhoek Dorp en Dorpsgronde No. 31 algemeen suid-suidweswaarts in die distrik van Windhoek oor die plaas Gedeele 5 van Gedeele B van Windhoek Dorp en Dorpsgronde No. 31; vandaar suidwaarts, weswaarts, suid-suidooswaarts en suidweswaarts met 'n algemene suidwestelike rigting oor die plaas Keres No. 39; vandaar weswaarts, suid-suidooswaarts, suidweswaarts en suidwaarts met 'n algemene suidelike rigting oor die plaas Friedenau No. 16; vandaar algemeen voortgaande suidwaarts oor die plaas Haris No. 22 tot by 'n punt naby die opstal op laasgenoemde plaas; vandaar algemeen ooswaarts oor die plaas Haris No. 22 om aan te sluit met Grootpad No. 49 by 'n punt op laasgenoemde plaas.

PUBLIEKE PAD No. 1420:

Vanaf 'n punt op Grootpad No. 52 op die plaas Baumgartbrunn No. 15 algemeen noord-noordooswaarts in die distrik van Windhoek oor die plaas Baumgartbrunn No. 15, Otjompane Süd No. 40 en Gedeele 1 van Hoehfels No. 41 tot by 'n punt op laasgenoemde plaas; vandaar algemeen noordweswaarts oor die plaas Gedeele 1 van Hoehfels No. 41, Khomas No. 334, noordoostelike hoek van Khomasop No. 354 en suidoostelike hoek van plaas No. 335 tot by 'n punt op laasgenoemde plaas; vandaar algemeen noord-noordooswaarts oor die plaas No. 335 en Okariro No. 282 tot by 'n punt op laasgenoemde plaas; vandaar algemeen noord-noordweswaarts oor die plaas Okariro No. 282, noordoostelike hoek van plaas No. 335, Okatore No. 336 en Gensbokke No. 346 tot by 'n punt op die noordelike grens van laasgenoemde plaas.

PUBLIEKE PAD No. 1421:

Vanaf 'n punt op Grootpad No. 52 op die suidelike grens van die Auguegas Naturelle Reserve No. 34 algemeen noordwaarts in die distrik van Windhoek oor die Auguegas Naturelle Reserve No. 34 en die plaas Hoehfels No. 41 tot by 'n punt naby die opstal op laasgenoemde plaas.

PUBLIEKE PAD No. 1422:

Vanaf 'n punt op Distrikspad No. 2107 op die plaas Ongos No. 38 algemeen wes-noordweswaarts in die distrik van Windhoek oor die plaas Ongos No. 38 tot by 'n punt op laasgenoemde plaas; vandaar algemeen noordwaarts oor die plaas Ongos No. 38, Onduno No. 48 en Gudeis No. 44 tot by 'n punt op die suidelike grens van die plaas Omhota No. 1 in die distrik van Okahandja.

PUBLIC ROAD No. 1414:

From a point on Main Road No. 52 on the farm Aub No. 321 generally southwards in the district of Windhoek via the farms Aub No. 321 and Karium No. 330 to a point near the homestead on the lastmentioned farm.

PUBLIC ROAD No. 1415:

From a point on the Kuiseb River in the southwestern corner of the farm Karium No. 330 generally north-eastwards in the district of Windhoek via the farms Karium No. 330, Stanco No. 369 and Landmister No. 331 to connect with Public Road No. 1416 at a point on the lastmentioned farm.

PUBLIC ROAD No. 1416:
