AMENDMENT OF THE FOURTH SCHEDULE TO THE MEDICAL, DENTAL AND PHARMACY ACT, 1928 (ACT NO. 13 OF 1928), AS AMENDED.

Under the powers vested in me by sub-section (3) of section *forty-eight* of the Medical, Dental and Pharmacy Act, 1928 (Act No. 13 of 1928), as amended by section *thirteen* of the Medical, Dental and Pharmacy Amendment Act, 1954, on the recommendation of the South African Medical and Dental Council and the South African Pharmacy Board, as provided in the said section, I hereby amend the Fourth Schedule to the said Act by the substitution for the existing schedule of the following:—

“DIVISION I.

Alkaloids and Glucosides. — All poisonous alkaloids and glucosides, and their salts, not specifically named in this schedule. Substances, preparations and admixtures containing in each single dose more than one half of the minimum dose of the poison as shown in any of the recognised formularies declared under section *sixty-five* of the Medical, Dental and Pharmacy Act, 1928 (Act No. 13 of 1928).

Aconite alkaloids and substances containing one fifty-fifth per cent or more of alkaloids of aconite.

Apomorphine and substances, preparations or admixtures containing one fifth per cent or more.

Brucine and substances, preparations or admixtures containing one fifth per cent or more.

Cocaine and substances, preparations or admixtures containing one fifth per cent or more.

Cotarnine and substances, preparations or admixtures containing one fifth per cent or more.

Calabar Bean alkaloids and their salts and substances, preparations or admixtures containing one fifth per cent or more.

Morphine and substances, preparations and admixtures containing one fifth per cent or more.

Papaverine and substances, preparations or admixtures containing one fifth per cent or more.

Stavesacre alkaloids and substances, preparations or admixtures containing one fifth per cent or more.

Strychnine and substances, preparations or admixtures containing one fifth per cent or more.

Thebaine and substances, preparations or admixtures containing one fifth per cent or more.

Atropine and substances, preparations or admixtures containing one tenth per cent or more.

Belladonna alkaloids and substances, preparations or admixtures containing one tenth per cent or more.

Coca alkaloids and substances, preparations or admixtures containing one tenth per cent or more.

Cocaine and substances, preparations or admixtures containing one tenth per cent or more.

- Barbituursuur. Barbituursuur soute. Barbituursuur derivate. Stowwe, preparate en mengsels wat meer as 'n kwart persent van enige van die voorafgaande bevat.
- Coinine and substances, preparations or admixtures containing one tenth per cent or more.
- Eugenine and substances, preparations or admixtures containing one tenth per cent or more.
- Gelsemium alkaloids and substances, preparations or admixtures containing one tenth per cent or more.
- Homatropine and substances, preparations or admixtures containing one tenth per cent or more.
- Hyoscine and substances, preparations or admixtures containing one tenth per cent or more.
- Hyoscyamine and substances, preparations or admixtures containing one tenth per cent or more.
- Solanaceous alkaloids not otherwise included in this Division and substances, preparations or admixtures containing one tenth per cent or more.

Beta-amino-propylbenzene. Alpha-methyl-phenethylamine. Derivatives of both the foregoing having any group substituted by another radical. Preparations and admixtures of all of the foregoing, except when contained in appliances for inhalation in which the poison is absorbed in inert solid material.

Chloral formamide.

Di-isopropyl fluorophosphonate and substances, preparations and admixtures containing it.

Butyl Chloral Hydrate. Substances, preparations and admixtures containing ten per cent or more.

Chloral Hydrate. Substances, preparations and admixtures containing ten per cent or more.

Cannabis indica and all solid preparations thereof except cannabis indica plasters.

Cantharidin and its poisonous derivatives. Substances, preparations and admixtures containing one hundredth per cent or more of the foregoing.

Chloroform.

Cocculus indicus (fish berries).

Cyanides of potassium and sodium. Hydrocyanic acid. Other poisonous cyanide substances, preparations and admixtures containing or yielding the equivalent of one tenth per cent or more of hydrocyanic acid.

Diamorphine or diacetyl-morphine, also known as heroin, including all preparations, salts, admixtures or derivatives prepared therefrom or therewith and containing one-tenth or more per cent of diamorphine or of any derivative of diamorphine.

Dinitroresols, dinitrophenols, nitrophenols, dinitronaphthols, dinitrothymols, except substances not intended for treatment of human ailments.

Elaterien.

Ergot of rye. Extracts of ergot. Tinctures of ergot. Substances containing the foregoing.

Fluaraetic acid. Fluoracetic acid salts. Substances containing one half per cent or more of the foregoing.

Rauwolfsia Serpentina and all substances, preparations or admixtures containing one tenth or more per cent of Rauwolfsia Serpentina alkaloids.

Savin and its oil and substances, preparations and admixtures containing them.

Sulphonal and alkyl sulphonals, and preparations and admixtures containing them.

Thallium, its salts and acids.

Trichloreëleen.

Tridione (3:5:5-Trimethyloxazolidine-2:4-Dione).

All poisonous urethanes and urecides.

DIVISION II.

All substances, preparations or admixtures which are not included in Division I of this schedule and contain a poison within the meaning of this Act, except substances, preparations or admixtures specifically excluded from Division II by the terms of this schedule, and except substances to which section *eighty-two* of this Act applies.

All substances, preparations and admixtures containing more than twenty per cent of chloroform.

Acetanilide and alkyl acetanilides.

Amyl nitrite.

Antimonial wine.

Barium salts except barium sulphate.

Cannabis indica and all liquid substances containing.

Carbolic acid (phenol), cresylic acid (creosol) and all preparations containing three or more per cent of any one, or of a mixture of these substances or of their derivatives. (This includes "lysol" and similar preparations under whatever name they be described or sold).

Chloride of zinc (except for industrial purposes).

Croton oil.

Ephetonin and other synthetic substitutes for ephedrine and all substances, preparations and admixtures containing them.

Essential oil of bitter almonds, unless free from hydrocyanic acid.

Lead acetate.

Lead plaster and its combinations (including machine-spread plasters), whether sold as diachylon or under any other name.

Amidopirien soute. Preparate en mengsels wat Amidopirien en sy soute bevat.

Antibiotiese, enige antimikrobiiese stof deur bakterieë, swamme of protosoë saamgevoeg, en enige stof waarvan die skeikundige eienskappe dieselfde is as of soortgelyk is aan sodanige antimikrobiiese stof maar wat nie uitlewende organismes voortgebring word nie, synde 'n stof wat vir die spesifieke behandeling van infeksies gebruik word, hulle soute en preparate en mengsels wat hulle bevat, behalwe daardie stowwe, preparate en mengsels wat ingevolge die bepalings van die Wet op Misstowe, Veevoedsel, Saad en Middels, 1947 (Wet No. 36 van 1947), geregistreer is en verkoop word.

AMENDMENT OF THE SIXTH SCHEDULE TO THE MEDICAL, DENTAL AND PHARMACY ACT, 1928 (ACT NO. 13 OF 1928), AS AMENDED.

Under the powers vested in me by sub-section (2) of section sixty-one bis of the Medical, Dental and Pharmacy Act, 1928 (Act No. 13 of 1928), as amended by section eighteen of the Medical, Dental and Pharmacy Amendment Act, 1954, on the recommendation of the South African Medical and Dental Council and the South African Pharmacy Board, as provided in the said section, I hereby amend the Sixth Schedule to the said Act by the substitution for the existing schedule of the following:—

"POTENTIALLY HARMFUL DRUGS.

Allilisopropylacetylurea.

Amidopyrine.

Amidopyrine salts. Preparations and admixtures containing Amidopyrine and its salts.

Antibiotics, any antimicrobial substance synthesized by bacteria, fungi or protozoa, and any substance the chemical properties of which are identical with or similar to any such antimicrobial substance but which is not produced from living organisms, being a substance which is used in the specific treatment of infections, their salts and preparations and admixtures containing them, except those substances, preparations and admixtures registered and sold under the provisions of the Fertilizers, Farm Feeds, Seeds and Remedies Act, 1947 (Act No. 36 of 1947).

Antihistaminic substances. Salts of antihistaminic substances. Preparations and admixtures containing antihistaminic substances, except when intended for external use and except their molecular compounds when intended specifically for the treatment of travel sickness.

Barbituric acid. Barbituric acid salts. Barbituric acid derivatives. Barbituric acid derivative salts. Compounds of the foregoing with any other substance except preparations and admixtures—

- (i) containing one quarter grain per dose or less of any of these in association with medicinal substances,
- (ii) containing not more than one half grain per dose of these substances in combination with—
 - (a) not less than five grains theobromine, or
 - (b) not less than one quarter grain of ephedrine, or
 - (c) not less than one and a half grains of theophylline ethylenediamine.

Beta-amino-propielbenseen. Alpha-methyl-phenethylamine. Derivatives of both the foregoing having any group substituted by another radical. Preparations and admixtures of all the foregoing, except when contained in appliances for inhalation in which the poison is absorbed in inert solid material.

Dicoumarol. Ethyl biscoumacetate. Anti-coagulants of a like nature.

Di-isopropyl fluorophosphonate and preparations and admixtures thereof.

Dinitrocresol. Dinitrophenols. Dinitronaphthols. Dinitrothiols. Preparations and admixtures containing the foregoing except preparations and admixtures not intended for the treatment of human ailments.

Hormones (natural or synthetic), except insulin, adrenaline and noradrenaline and those substances, preparations and admixtures registered and sold under the provisions of the Fertilizers, Farm Feeds, Seeds and Remedies Act, 1947.

Oestrogenic substances (natural or synthetic), preparations and admixtures thereof except those substances, preparations and admixtures thereof registered and sold under the provisions of the Fertilizers, Farm Feeds, Seeds and Remedies Act, 1947.

(1) 'n Dagvaarding om voor 'n komitee of ondersoekbeambte te verskyn in verband met 'n ondersoek deur die komitee of 'n ondersoekbeambte moet in die vorm van aanhangsel A.O. 1 geskik.

(2) So 'n dagvaarding kan bestel word aan diegene wat voor die komitee of ondersoekbeambte moet verskyn —

- (a) deur die dagvaarding of 'n afskrif daarvan aan hom af te lewer; of
- (b) deur die dagvaarding of 'n afskrif daarvan by sy woon-, sake- of werkplek te laat by iemand wat blykbaar minstens sesien jaar oud is en wat ook blykbaar daar woon of werk; of
- (c) deur die dagvaarding of 'n afskrif daarvan per aangekende pos aan sy woon-, sake- of werkplek, of sy posbusnommer, te stuur.

(3) 'n Getuie wat dagvaardig is om voor 'n komitee of ondersoekbeambte te verskyn —

- (a) moet vir sy reis of deel daarvan 'n vry spoorweg-order ontvang, as die reis of deel daarvan afgelê kan word per trein of per padmotordiens van die Spoorwegadministrasie, en hy moet daardie diens of dienste gebruik, tensy dit onder die omstandighede ondeonlik is;
- (b) moet, as die reis of deel daarvan nie deur gebruikmaking van die dienste wat paragraaf (a) noem, afgelê kan word nie, of as sodanige gebruikmaking onder die omstandighede ondeonlik is, met enige ander publieke vervoermiddel (buiteng lug- of skeepvaartdiende) reis, tensy dit onder die omstandighede ondeonlik is, en die werklike vervoerdaag moet aan hom betaal of terugbetaal word;
- (c) moet, as die reis of deel daarvan nie met een van die vervoerdienste wat paragraaf (a) of (b) noem, geskied nie, of as gebruikmaking daarvan onder die omstandighede ondeonlik is, enige ander vervoermiddel, ook sy eie, gebruik, en ten opsigte van die koste van sodanige vervoer moet daar aan hom 'n toelae betaal word teen die skaal van een sjelling per myl vir elke myl van sodanige reis of deel daarvan;
- (d) kan, as hy, na die komitee of ondersoekbeambte meen, weens sy verskyn op grond van die dagvaarding 'n geldelike verlies gehad het, die bedrag daarvan, of, na gelang van watter ook al die minste is, 'n bedrag van £1 per dag of deel daarvan betaal word.

(4) Wanneer ook al daar ingevolge paragraaf (b) van subregulasie (3) reiskoste aan 'n getuie betaal of terugbetaal moet word, moet die bedrag daarvan bereken word ooreenkomsdig die soort van klas reisgeleenthed wat die getuie, na die Sekretaris van Suidwes-Afrika meen, met inagneming van die omstandighede, na gewone verwagting sou gebruik het as hy op eie koste moes gereis het.

(5) Die Sekretaris van Suidwes-Afrika kan na goeddunke die spoorwegorders, lasbriewe, of ander opdragte uitreik sodat die getuie op die plek van die ondersoek sal kan verskyn, en ten opsigte van die toelae wat ingevoegde paragrafe (b), (c) of (d) van subregulasie (3) aan die getuie betaal moet word, kan die Sekretaris die bedrag wat hy bepaal aan die getuie voorskipt in afwagting van die uiteindelike vaststelling van die bedrag wat die getuie ingevolge die genoemde paragrafe kan eis. Wanneer sodanige spoorwegorders, lasbriewe of ander opdragte uitgereik word, moet die aangebode reisgeleenthed van die soort of klas wees wat die getuie, na die Sekretaris van Suidwes-Afrika meen, met inagneming van die omstandighede, na gewone verwagting sou gebruik het as hy op eie koste moes gereis het. Wanneer ook al 'n spoorwegorder, lasbrief of ander opdrag uitgereik is, moet die getuie dienooreenkomsdig reis. As so 'n getuie egter enige ander soort of klas reisgeleenthed as hierdie genoemde reisgeleenthed gebruik of die reisgeleenthed ten opsigte van die reis of deel daarvan nie benut nie, kan sy reiskoste hom, met die Sekretaris van Suidwes-Afrika se goedkeuring, geheef of gedeeltelik vergoed word, maar ten opsigte van daardie reis of deel daarvan kan die getuie geen aanspraak maak op die terugbetaaling van meer reiskoste as die bedrag waarmee publieke fondse ten opsigte van sodanige spoorwegorders, lasbriewe of opdragte gedebiteer kan word nie.

(1) A subpoena to appear before a Committee, or an Investigating Officer in connection with any investigation by the Committee or the Investigating Officer shall be in the form of Annexure A.O. 1.

(2) Any such subpoena may be served on the person required to appear before the Committee or the Investigating Officer —

- (a) by delivering it, or a copy thereof, to him; or
- (b) by leaving it, or a copy thereof, at his place of abode or business or employment with some person apparently not less than sixteen years of age and apparently residing or employed there; or
- (c) by dispatching it, or a copy thereof, by registered post to his place of abode or business or employment or his post office box number.

(3) A witness who is subpoenaed to appear before a Committee or Investigating Officer —

- (a) shall, if the journey, or any portion thereof, can be performed by using the rail or motor road service of the Railway Administration, be furnished with a free rail-warrant for such journey, or portion thereof, and shall use such service unless the use thereof is impracticable in the circumstances;
- (b) shall, if the journey or any portion thereof, cannot be performed by using any of the services referred to in paragraph (a) or, if it is impracticable in the circumstances to make use thereof, travel by means of any other public transport service (other than by an air or shipping service) unless the use thereof is impracticable in the circumstances and shall be paid or refunded the actual fare;
- (c) shall, if the journey, or any portion thereof, cannot be performed by using any of the means of transport referred to in paragraph (a) or (b), or, if it is impracticable in the circumstances to make use thereof, use any other means of transport, including his own, and shall be paid an allowance towards the cost of such transport at the rate of one shilling per mile for each mile of such journey or portion thereof;
- (d) may, if, by reason of his obedience to the subpoena, he has, in the opinion of the Committee or the Investigating Officer, suffered any pecuniary loss or been put to any expense other than travelling expenses be paid the amount thereof, or an amount of £1 per day or part of a day, whichever is less.

(4) Whenever any payment or refund is, in terms of paragraph (b) of sub-regulation (3), to be made to any witness, the amount thereof shall be calculated according to the type or class of facility which, in the opinion of the Secretary for South West Africa, the witness, having regard to the circumstances, would ordinarily be expected to use if he were travelling on his own account.

(5) The Secretary for South West Africa may, in his discretion, issue such rail-warrants, orders, or other instructions as will enable the witness to attend at the place where the enquiry is to be held and advance such amount towards the allowance payable to such witness in terms of paragraphs (b), (c) or (d) of sub-regulation (3) as he may decide, pending the final adjustment of any claim by the witness in terms of the said paragraphs. In issuing any such rail-warrants, orders, or other instructions, the facility to be furnished shall be of the type or class of facility which, in the opinion of the Secretary for South West Africa, the witness, having regard to the circumstances, would ordinarily be expected to use if he were travelling on his own account. Whenever any rail-warrant, order or other instruction is issued, the witness shall travel in accordance therewith; if, however, such witness uses any type or class of facility other than that specified or fails to take advantage thereof in respect of the journey or any portion thereof, he may, if the Secretary for South West Africa approves, be reimbursed the whole, or any portion, of the travelling expenses incurred by him, but he shall not be entitled to be refunded in respect of travelling expenses for that journey, or portion thereof, more than the amount chargeable against public funds in accordance with such rail-warrants, orders or instructions.

(b) 'n Lid van 'n vakleerlingkomitee kan, as hy weens die nakomming van sy amptsplike as lid, na die Sekretaris van Suidwes-Afrika meen, geldelike verlies gely het of van ekoste buiten reiskoste aangegaan het, die bedrag daarvan, of anders 'n bedrag van £4.4.0 per dag of dagdeel, watter oor al die minste is, vergoed word.

3. Leerlingkontrak.

(1) Die leerlingkontrak moet in die vorm gestel word wat aanhangsel A.O. 2 aandui.

(2) Elke leerlingkontrak wat ingevolge artikels vier en vyf van die Ordonnansie geregistreer moet word, moet middels die sekretaris van die betrokke vakleerlingkomitee by die Inspekteur ingediend word.

(3) Elke leerlingkontrak wat ingevolge artikels vier en vyf van die Ordonnansie ter registrasie ingediend word, moet van 'n duplikaat vergesel gaan, en na die registrasie moet die inspekteur die duplikaat behou en moet die werkewer die oorspronklike eksemplaar behou totdat die kontrak voltooi, oorgedra of nietig verklaar is.

(4) By voltooiing van 'n leerlingkontrak deur tydsverloop moet die werkewer binne sewe dae daarna die sertifikaat van voltooiing van die kontrak invul en teken en die voltooiende kontrak middels die betrokke sekretaris van die vakleerlingkomitee by die inspekteur indien ter aantekening van die voltooiing. Die voltooiende kontrak moet daarop gestuur word aan die persoon wat sy vakleerlingskap daardingevolge voltooi het, en word sy eiendom.

(5) (a) Wanneer ook al 'n leerlingkontrak ingevolge sub-artikel (1) van artikel tien van die Ordonnansie oorgedra word, moet al die kontraktaante tot die oordrag 'n oordragsaanstekening op die kontrak, asook 'n afskrif daarvan, sodra doeklik onderteken, en binne veertien dae na die ondertekening moet die kontraktaant in wie se besit hulle is, albei dokumente middels die sekretaris van die betrokke vakleerlingkomitee by die inspekteur indien.

(b) Wanneer 'n leerlingkontrak ingevolge sub-artikel (2) van artikel tien van die Ordonnansie as oorgedra gegang word, moet die persoon van vennootskap wat die kontrak in bewaring het, die kontrak sodra doeklik middels die sekretaris van die betrokke vakleerlingkomitee by die inspekteur indien.

(c) Na die registrasie van die oordrag in albei gevalle, moet die nuwe werkewer die kontrak behou totdat dit voltooi, oorgedra of nietig verklaar word.

(6) As 'n leerlingkontrak ingevolge die bepalings van artikel nege van die Ordonnansie herroep word, moet die werkewer die kontrak middels die sekretaris van die betrokke vakleerlingkomitee by die inspekteur indien ter aantekening van sodanige herroeping.

4. Gesondheidsertifikaat.

In opdrag van 'n magistrant van 'n amptenaar wat die Sekretaris van Suidwes-Afrika in oorelog met 'n vakleerlingkomitee behoorlik daartoe gemagtig het, moet 'n distriksgenesheer 'n sertifikaat van liggamlike geskiktheid van ongeskiktheid om 'n leerlingkontrak aan te gaan kosteloos aan 'n aantastende vakleerling of aan die vakleerlingkomitee uitrek, maar 'n sertifikaat op die selfde vorm deur enige genesheer wat in die Unie en Suidwes-Afrika geregistroer is, kan aangeneem word. Hierdie sertifikaat moet in die vorm van aanhangsel A.O. 3 gestel word.

5. Register vir Werkure en Lone.

Elke werkewer moet ten opsigte van elke vakleerling register hou of in die vorm van aanhangsel A.O. 4 of in die vorm van —

(a) die aantekeningen oor werkure en lone wat sub-artikel (1) van artikel nege van die Ordonnansie op Fabrieks-, Masjinerie en Bouwerk 1952 voorskryf; of

(b) die boekhouding wat artikel ses-en-sestig van die Ordonnansie op Lone en Nywerheidsversoening 1952 voorskryf.

(6) (a) The provisions of paragraphs (a), (b) and (c) of sub-regulation (3) and sub-regulations (4) and (5) of regulation 2 shall, *mutatis mutandis*, apply in respect of any member of an apprenticeship committee who is performing his duties as such.

(b) A member of an apprenticeship committee may, if, by reason of the performance of his duties as such, he has suffered any pecuniary loss or been put to any expense other than travelling expenses, be paid the amount thereof, or an amount of £4.4.0 per day or part of a day, whichever is less.

3. Contract of Apprenticeship.

(1) The form of contract of apprenticeship shall be as set out in Annexure A.O. 2.

(2) Every contract of apprenticeship which, in terms of sections four and six of the Ordinance must be registered, shall be lodged with the Inspector through the Secretary of the Apprenticeship Committee concerned.

(3) Every contract of apprenticeship lodged for registration in terms of sections four and six of the Ordinance shall be in duplicate. After registration, the duplicate copy shall be retained by the Inspector and the original shall be retained by the employer until termination, transfer, or rescission of the contract.

(4) Upon the termination of any contract of apprenticeship by effluxion of time the employer shall, within seven days of such termination, complete and sign the certificate of termination of the contract and lodge the terminated contract with the Inspector through the Secretary of the Apprenticeship Committee concerned for noting of termination. The terminated contract shall thereafter be transmitted to and become the property of the person who has completed his apprenticeship in terms thereof.

(5) (a) Whenever any contract of apprenticeship is transferred in terms of sub-section (1) of section ten of the Ordinance, an endorsement of transfer on the contract, together with a copy thereof, shall be signed by all parties to the transfer as soon as practicable and within fourteen days of such signature both documents shall be lodged by the party in whose possession they are with the Inspector through the Secretary of the Apprenticeship Committee concerned.

(b) If a contract of apprenticeship is deemed to be transferred in terms of sub-section (2) of section ten the person or partnership in whose custody the contract is, shall lodge the contract as soon as practicable with the Inspector through the Secretary of the Apprenticeship Committee concerned.

(c) After registration of the transfer in either case the contract shall be retained by the new employer until termination, transfer or rescission.

(6) In the event of the cancellation of a contract of apprenticeship in accordance with the provisions of section nine of the Ordinance, the employer shall lodge the contract with the Inspector through the Secretary of the Apprenticeship Committee concerned for endorsement of the fact of cancellation.

4. Medical Certificate.

A certificate as to his physical fitness or otherwise to enter into contract of apprenticeship shall be issued free of charge to a prospective apprentice or the Apprenticeship Committee by a district surgeon on the instructions of a magistrate or an official duly authorised thereto by the Secretary for South West Africa, acting in collaboration with an Apprenticeship Committee, but a certificate on the same form by any medical practitioner registered in the Union and South West Africa may be accepted, his certificate shall be in the form of Annexure A.O. 3.

5. Hours and Wages Records.

Each employer shall keep a record in respect of each apprentice in the form of Annexure A.O. 4 or in the form of —

(a) the hours and wages record prescribed under sub-section (1) of section nine of the Factories, Machinery and Building Work Ordinance, 1952, or

(b) the record prescribed under section sixty-six of the Wage and Industrial Conciliation Ordinance, 1952.

6. Gewaarmerkte Duplikeate: Afskrifte van Kontrakte.

Op aansoek moet die inspekteur aan enige van die kontrakte by 'n geregistreerde leerlingkontrak 'n gewaarmerkte afskrif daarvan uitrek. Elke so 'n aansoek moet vergees gaan van 'n inkostesel van 5s, wat op die gewaarmerkte afskrif van die kontrak geplak moet word en deur die inspekteur gerooier moet word.

7. Geboorte- en Onderwyssertifikate.

Bewys van die geboortedatum en onderwyssstanderd van 'n aanstaande vakleerling moet aan die sekretaris van die vakleerlingkomitee gelewer word in die vorm wat die Sekretaris van Suidwes-Afrika goedgekeur het.

8. Indiensneming van Minderjariges in Aangewese Bedrywe.

Elkeen wat 'n minderjarige (buitens 'n vakleerling) in diens neem in 'n bedryf wat ingevolge die Ordonnansie aangewys word, moet binne drie weke na die datum van sy indiensneming die besonderhede wat aanhangsel A.O. 5 vereis by die sekretaris van die betrokke vakleerlingkomitee inlewer.

9. Elkeen wat 'n minderjarige (buitens 'n vakleerling) ontslaan uit 'n bedryf wat ingevolge die Ordonnansie aangewys word, moet onmiddellik die sekretaris van die betrokke vakleerlingkomitee daarvan verwittig in die vorm van aanhangsel A.O. 6.

10. Strafbepalings.

Elkeen wat die bepalings van hierdie Ordonnansie by daad of versuui verontgaansaam, is skuldig aan 'n oortreding, en is by skuldigbevinding strafbaar met 'n boete van hoogstens vyf-en-twintig pond of met gevangenis van drie maande met of sonder dwangarbeit.

11. Betaling van Klas- of Kursus- en Eksamengelde.

Elke vakleerling wat, na vereiste, voorgeskrewe klasse of kursusse moet volg, is aanspreeklik vir die betaling van die aangewese klas- of kursusgeld aan die betrokke inrigting: Met dien verstande dat die werkgever sodanige geld aan die begin van elke halfjaarlike tydperk aan die betrokke inrigting moet voorskiet, en dan die voorskot in dele van hoogstens vier sjielings per week van die vakleerling se loon kan aftrek: Met dien verstande voor dat as die vakleerling 'n certifikaat van die betrokke inrigting kan voorstel dat hy 'n bevredigende simbool vir vlyt en vordering behaal het en sowel in sy vrye tyd as onder sy gewone werktyd minstens 75 persent van die moonltike lesure bygewoon het, of, by 'n korrespondensiakursus, minstens 75 persent van die volle aantal vraestelle bevredigend beantwoord het, die werkgever die aldus afgetrekte bedrag aan die vakleerling terug moet betaal.

6. Duplicate Certified Copies of Contracts.

The Inspector shall, upon application, issue to any of the parties to a registered contract of apprenticeship, a certified copy of such contract. Each application shall be accompanied by a 5s. revenue stamp, which shall be affixed to the certified copy of the contract and shall be cancelled by the Inspector.

7. Certificates of Birth and Standard of Education.

Evidence of date of birth and standard of education of a prospective apprentice shall be furnished to the Secretary of the Apprenticeship Committee in a form approved by the Secretary for South West Africa.

8. Employment of Minors in Designated Trades.

Every person who employs a minor (other than an apprentice) in any trade designated under the Ordinance shall, within three weeks from the date upon which such minor is employed, furnish the Secretary of the Apprenticeship Committee concerned with particulars in the form of Annexure A.O. 5.

9. Every person who discharges a minor (other than an apprentice) employed by him in any trade designated under the Ordinance shall forthwith notify, in the form of Annexure A.O. 6, the Secretary of the Apprenticeship Committee concerned.

10. Penalties.

Any person who contravenes or fails to comply with any of these regulations shall be guilty of an offence and liable, on conviction, to a fine not exceeding twenty-five pounds or three months' imprisonment with or without compulsory labour.

11. Payment of Class or Course and Examination Fees.

Every apprentice, who is required to attend or take any prescribed classes or courses, shall be liable to pay the fees therefor to the institution concerned; provided that, in the case of class or course fees, the employer shall advance such fees at the beginning of each half-yearly session to the institution concerned and may deduct such amount from the wages of the apprentice in instalments not exceeding 4/- per week; provided, if the apprentice produces a certificate from the institution concerned that he has obtained a satisfactory mark in diligence and progress, and has attended both in his own time and during ordinary working hours at least 75 per cent of the possible number of classes, or in the case of a correspondence course, has satisfactorily completed at least 75 per cent of the full number of papers during that calendar year, the sum so deducted shall be refunded to the apprentice by the employer.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Harry de Lacy Burnham, Price Controller, hereby throughout South West Africa and the port and settlement of Walvis Bay:—

In terms of regulation 3 of War Measure No. 49 of 1946, I, Harry de Lacy Burnham, Price Controller, prescribe throughout South West Africa and the port and settlement of Walvis Bay, as follows:—

1. The maximum prices of fertilizers and fertilizer mixtures are:—

- (1) Where the total quantity sold is 1,000 lb. or more the maximum prices are at the rates per ton specified in the Schedules (excluding the Fourth Schedule) hereto.
 - (2) Where the quantity sold is less than 1,000 lb. but not less than 100 lb. the maximum prices are proportionate to the prices per ton specified in the aforesaid Schedules plus an amount calculated at a rate not exceeding 8s. per ton.
 - (3) Where any such fertilizer or fertilizer mixture is purchased for resale and is resold from the reseller's stock the maximum prices are those specified in sub-paragraph (1) or sub-paragraph (2) above (whichever may be applicable) plus

 - (ii) the railage and/or cartage actually paid on such fertilizer or fertilizer mixture from the station of the supplier thereof to the store of the reseller;
- provided that where any such fertilizer or fertilizer mixture is sold otherwise than for cash with order, the maximum price for such fertilizer or fertilizer mixture, as prescribed in the relevant Schedules hereto, may, subject to the provisions of paragraph 2 hereof,

THE SOUTH AFRICAN MEDICAL AND DENTAL COUNCIL.

REGULATIONS REGARDING THE DEGREES, DIPLOMAS OR CERTIFICATES ENTITLING MEDICAL PRACTITIONERS AND DENTISTS TO REGISTRATION.

His Excellency the Governor-General has been pleased, under the powers vested in him by sections *twenty-two* and *twenty-three* of the Medical, Dental and Pharmacy Act, 1928 (Act No. 13 of 1928), read with sub-section (I) of section *ninety-four*, and after considering a recommendation of the South African Medical and Dental Council, to substitute the following regulations regarding the degrees, diplomas or certificates entitling medical practitioners and dentists to registration under the Act, for the regulations published under Government Notice No. 398 of the 19th March, 1937, as amended from time to time:—

MEDICAL PRACTITIONERS.

(I) Subject to the provisions of the Medical, Dental and Pharmacy Act, No. 13 of 1928, and the rules and regulations in force thereunder, any of the following degrees, diplomas or certificates shall entitle the holder thereof to registration as a medical practitioner: Provided that—

(a) no person shall be so registered unless the degrees, diplomas or certificates held singly or conjointly by him show that he has passed qualifying examinations in medicine, surgery and midwifery; and

(b) such degrees, diplomas or certificates shall only be recognised for registration if the course of study in professional subjects covered a period of at least five academic years and, in addition, the last three years of professional study for admission to the examination for such degree, diploma or certificate were taken at a university or medical school in the country or state in which the degree, diploma or certificate was granted, save that—

(i) this proviso shall not apply to degrees, diplomas or certificates held by a British subject born in the Union or domiciled in the Union when he commenced his professional studies, who proceeded therefrom prior to the 17th April, 1936, for the prosecution of his studies; and

(ii) the requirement relating to the last three years of professional study shall not apply to degrees, diplomas or certificates recognised by the Council as at the 1st January, 1950, and granted to any person prior to the 17th April, 1936; and
