WEIGELDE BERSEBA-NATURELLERESERVAAT.

Kragtens die bevoegdheid hom verleen by artikel *drie* van die Wet op die Administrasie van Naturellesake in Suidwes-Afrika 1954 (Wet No. 56 van 1954), het dit die Goewerneur-generaal behaag om ooreenkomsdig artikel *ses* van die Naturelle Reservaten-Trustfonds Administrasie Proklamatie 1924 (Suidwes-Afrika-proklamasie No. 9 van 1924), soos gewysig by artikel *ses-en-twintig* van die Naturelle Administrasie-Proklamasie 1928 (Suidwes-Afrika-proklamasie No. 15 van 1923), en artikel *twee* van die Naturelle Reservate Trustfonds Wysigingsproklamasie, 1936 (Suidwes-Afrika-proklamasie No. 21 van 1936) die volgende bylae vervang van die bylae wat verskyn in Suidwes-Afrika-gouewermentskennisgewing No. 167 van 1938, soos gewysig deur Suidwes-Afrika-gouewermentskennisgewing No. 301 van 1951, goed te keur met ingang van 1 April 1955; onderstaande bylae is by 'n eenparige besluit goedgekeur op 'n vereenwoerdige vergadering van die volwasse Naturellemans wat in die Berseba-reservaat woon of daar wesenlike belangheyt het, op 'n vergadering bycengeroep na genoegsame kennisgewing deur die Naturellekommissaris van Keetmanshoop.

BYLAE.

GEWYSIGDE TARIEF VAN WEIGELD WAT MET INGANG VAN 1 APRIL 1955 IN DIE BERSEBA-RESERVAAT BETAALBAAR IS.

GROOTVEE, uitsluitende bulle wat deur die Reservaat-superintendent of Naturellekommissaris goedgekeur is, donkies en ongespeende kalwers en vullens:—

Pruibulle : : : 8d. stuk per maand.
Ander grootvee : : : 6d. stuk per maand.

DONKIES, uitsluitende ongespeende vullens:—

Reuns en Merries : : : 6d. stuk per maand.

Hingste : : : 8d. stuk per maand.

KLEINVEE, uitsluitende lammers en boklammers jonger as ses maande:—

Van 1 tot 200 : : : ½d. stuk per maand.

Meer as 200 : : : 1d. stuk per maand.

GRAZING FEES: BERSEBA NATIVE RESERVE.

Under the powers vested in him by section *three* of the South-West Africa Native Affairs Administration Act, 1954 (Act No. 56 of 1954), the Governor-General has been pleased, in terms of section *six* of the Native Reserves Trust Funds Administration Proclamation, 1924 (South-West Africa Proclamation No. 9 of 1924), as amended by section *twenty-six* of the Native Administration Proclamation, 1928 (South-West Africa Proclamation No. 15 of 1928), and by section *two* of the Native Reserves Trust Funds Amendment Proclamation No. 21 of 1936, to approve of the substitution with effect from the 1st April, 1955, of the following schedule for that contained in South-West Africa Government Notice No. 167 of 1938, as amended by South-West Africa Government Notice No. 301 of 1951, the schedule hereunder having been approved by the adoption of a unanimous resolution at a representative meeting of the adult native males resident or possessing substantial interests in the Berseba Reserve, duly convened after adequate notice at the instance of the Native Commissioner of Keetmanshoop.

SCHEDULE.

AMENDED TARIFF ON GRAZING FEES PAYABLE IN BERSEBA RESERVE AS AND FROM THE 1st APRIL, 1955.

LARGE STOCK, excluding bulls approved by the Reserve Superintendent or Native Commissioner, donkeys and unweaned calves and foals:—

Scrub bulls : : 8d. per head per month.
Other large stock : : 6d. per head per month.

DONKEYS, excluding unweaned foals:—

Geldings and mares : : 6d. per head per month.
Donkey jacks : : 8d. per head per month.

SMALL STOCK, excluding lambs and kids under six months old:—

From 1 to 200 : : ½d. per head per month.
More than 200 : : 1d. per head per month.
