#### LEVY OF ANNUAL RATE: BASUBIA AND MAFUE (BAYEYI) TRIBES: EASTERN CAPRIVI ZIPFEL.

It is hereby notified that, in terms of sub-sections (6), (7) and (8) of section two of the Caprivi Zipfel Affairs Proclamation, 1930 (Proclamation No. 27 of 1930), issued by the Administrator of South West Africa, read with section three of the Eastern Caprivi Zipfel Administration Proclamation, 1939 (Proclamation No. 147 of 1939), issued by the Governor-General, the Minister of Native Affairs—

(1) has levied an annual rate of 10/-, with effect from the year 1956, upon the members of the Basubia and Mafue (Bayeyi) Tribes for which Trust Funds have been established by Government Notice No. 160 of 1930 (South West Africa); and

(2) has determined that the rate hereby levied falls due on the 30th May, 1956, in respect of the year 1956, and on the 1st January of each succeeding year during whi chit is in force.

Government Notice No. 616 of 1940 is hereby withdrawn.

It is hereby notified for general information that the Minister of Native Affairs has, in terms of paragraph (b) of sub-section (11) of section two of the Caprivi Zipfel Affairs Proclamation, 1930 (Proclamation No. 27 of 1930), issued by the Administrator of South West Africa, as amended by section one of the Eastern Caprivi Zipfel Trust Funds Amendment Proclamation, 1940 (Proclamation No. 73 of 1940), issued by the Governor-General of the Union of South Africa, generally exempted in respect of the years 1950 to 1955 all persons liable to pay the rate levied upon members of the Basubia and Mafue (Bayeyi) Tribes in the Eastern Caprivi Zipfel by Government Notice No. 616 dated the 19th April, 1940.

**CUSTOMS ACT, 1955.****TEMPORARY SUSPENSION OF DUTY.**

I, ERIC HENDRIK LOUW, Minister of Finance, in terms of the powers vested in me by section eighty-two of the Customs Act, No. 55 of 1955, hereby suspend until further notice the duty provided for in item 58 of the customs tariff in respect of unmanufactured air-cured tobacco of a free on board price not exceeding three shillings per pound weight and imported into the Union by manufacturer of pipe tobacco in terms of a permit issued by the Secretary for Agriculture.
