The Minister of Bantu Administration and Development has been pleased, under and by virtue of the powers vested in him by subsection (4) of section *thirty-two* of the Natives (Urban Areas) Proclamation, 1951 (No. 56 of 1951) (South West Africa), read with section *three* of the South West Africa Native Affairs Administration Act, 1954 (No. 56 of 1954), and section *two* of the South West Africa Native Affairs Administration Proclamation 1958 (No. 119 of 1958), to approve of the undermentioned amendment of the Native Location Regulations published under Government Notice 324 of 1953:-

VILLAGE MANAGEMENT BOARD OF MALTAHÖHE.

AMENDMENT OF LOCATION REGULATIONS.

Substitute the following for regulation 14:-

"14. (1) Every registered occupier or other resident in the location or person liable to obtain a permit shall pay the Board, in advance at the office of the Secretary, such of the amounts set out hereunder in respect of rent, water supply and sanitary services rendered by the Board, as may be applicable:-

(a) By the holder of a residential permit, or any person who is required to be the holder of such permit, monthly — 4/-.

(b) By the holder of a lodger's permit, or any person who is required to be the holder of such permit, monthly — 2/-.

(2) If any person fails to pay any sum for which he is liable in terms of this regulation, within one month of the date on which such sum becomes due and payable, the Superintendent may, on giving such person one month's notice in writing of his intention to do so, cancel any permit issued to such person to be or reside in the location with effect from the date set out in such notice.
