The Administrator has been pleased under and by virtue of the powers in him vested by Section *five* of the Post Office Administration Proclamation 1931 (Proclamation No. 15 of 1931) to amend certain postal rates appearing in Government Notice No. 83 of 1950 amended by Government Notices Nos. 126 of 1950, 147 of 1952, 216 of 1952, 143 of 1954 and 52 of 1959, and to approve of the subjoined postal tariffs fixed by the Director of Posts and Telegraphs with effect from 1st April, 1959.
