PROCLAMATION

BY THE HONOURABLE DANIEL THOMAS DU PLESSIS VILJOEN, ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 7 of 1962.]

Under and by virtue of the powers in me vested by sub-section (1) and paragraph (c) of sub-section (2) of section two of the Establishment of a Coloured Council Ordinance, 1961 (Ordinance 34 of 1961), I do hereby declare that a Coloured Council consisting of eleven Coloured members shall be established for the Territory with effect from the 30th March, 1962, and I further define hereby the extent of the regions to be represented by the said eleven members as set forth in the schedule hereto.

Proclamation 2 of 1962 is hereby repealed.

Given under my hand and seal at Windhoek this 22nd day of March, 1962.

SCHEDULE

Central Region:

The Magisterial districts of Windhoek, Gobabis and Rehoboth but excluding that portion of the Rehoboth district known as the Rehoboth Gebiet, the boundaries whereof are defined in the first Schedule of the 1923 Agreement as contained in Proclamation 28 of 1923.

Northern Region:

The Magisterial districts of Swakopmund, Okahandja, Karibib, Omaruru, Otjiwarongo, Outjo, Tsumeb and Grootfontein.

Southern Region:

The Magisterial districts of Warmbad, Bethanie and the portion of the magisterial district of Keetmanshoop situated west of the 19th degree of longitude east.

Eastern Region:

The magisterial districts of Gibeon and Maltahöhe and the portion of the magisterial district of Keetmanshoop situated east of the 19th degree of longitude east.

Western Region:

The magisterial districts of Walvis Bay and Luderitz.
