AANSTELLING VAN KOMMISSIE VAN ONDERSOEK NA AANGELEENTHEDE VAN SUIDWES-AFRIKA

Hierby word vir algemene inligting bekend gemaak dat dit die Staatspresident behaag het om 'n Kommissie van Ondersoek na Aangeleenthede van Suidwes-Afrika aan te stel, met die volgende opdrag:

Om,lettende op wat reeds beplan en gedoen is, 'n deurtastende ondersoek in te stel na die verdere bevo-

promoting the material and moral welfare and the social progress of the inhabitants of South West Africa, and more particularly its non-White inhabitants, and to submit a report with recommendations on a comprehensive five year plan for the accelerated development of the various non-White groups of South West Africa, inside as well as outside their own territories, and for the further development and building up of such native territories in South West Africa.

With a view to this investigation, the attention of the Commission is particularly directed to the task of ascertaining — while fully taking into consideration the background, traditions and habits of the native inhabitants — how further provision should be made for their social and economic advancement, effective health services, suitable education and training, sufficient opportunities for employment, proper agricultural, industrial and mining development in respect of their territories, and for the best form of participation by the natives in the administration and management of their own interests. The Commission is empowered to investigate any other matter which in its opinion may be of importance in this connection, including the financial implications and the manner in which any appropriation of funds should take place.

And in order that the Commission may be better able to carry out this Commission, it is granted full power and authority to interrogate at its discretion all persons who in its opinion are able to furnish information on the subjects mentioned in its terms of reference or on matters relating thereto; to obtain, inspect and make extracts from all books, documents, papers and registers of the Government or of the Administration of South West Africa which in its opinion contain information on the said subjects; and to conduct investigations into the subject matter of this enquiry in any other authorised manner.

Instructions have further been given that, owing to his exceptional knowledge of South West Africa and its native population, Mr. HERBERT JOSCELYN ALLEN should render special assistance to the Commission whenever necessary.

The Commission has been requested to report to the State President as soon as possible, preferably within twelve months, on its findings and recommendations.

dering van die stoflike en morele welsyn en die sosiale vooruitgang van die inwoners van Suidwes-Afrika, en wel meer bepaald die nie-Blanke inwoners, en verslag met aanbevelings uit te bring oor 'n omvattende vyfjaarplan vir die versnelde ontwikkeling van die verskillende nie-Blanke groepe van Suidwes-Afrika, sowel in hul eie gebiede as daarbuite, en vir die verdere ontwikkeling en opbou van sodanige inboorlinggebiede van Suidwes-Afrika.

Met die oog op hierdie ondersoek word die aandag van die Kommissie in die besonder daarby bepaal dat, met inagneming van die inboorlinge se agtergrond, tradisies en gewoontes, vasgestel moet word hoe verder gesorg kan word vir hul maatskaplike en ekonomiese opheffing, doeltreffende gesondheidsdienste, geskikte onderwys en opleiding, voldoende arbeidsgeleenthede, geskikte landboukundige, nywerheids- en mynbouontwikkeling ten opsigte van hul gebiede, en vir die beste vorm van deelname deur die inboorlinge aan die administrasie en bestuur van hul eie belangte. Die Kommissie word gemag om enigtes verder te ondersoek wat hiermee mag saamhang na sy oordeel, insluitende die finansiële implikasies en die wyse waarop enige bewilliging van fondse moet geskied.

En ten einde die Kommissie beter in staat te stel om hierdie opdrag uit te voer, word volle bevoegdheid en gesag aan hom verleent om na goedunke alle personele onderverwa wat volgens sy oordeel inligting kan verstrek oor die onderwerpe wat in sy opdrag genoem word of oor aangeleentheide wat daarmee in verband staan; om alle boeke, dokumente, stukke en registers van die Regering of van die Administrasie van Suidwes-Afrika wat volgens sy oordeel inligting kan bevat oor die genoemde onderwerpe te verkry, te ondersoek en uittreksels daarvan te maak; en om op enige ander geoorloofde wyse navraag te doen betreffende die onderwerpe van hierdie ondersoek.

Verder is opdrag gegee dat spesiale hulp, wanneer nodig, aan die Kommissie verleent sal word deur mnr. HERBERT JOSCELYN ALLEN, vanweë sy besondere kennis van Suidwes-Afrika en sy inboorlingbevolking.

Die Kommissie is versoeek om so gou doenlik, verkiesslik binne twaalf maande, aan die Staatspresident verslag te doen oor sy bevindings en aanbevelings.
