**PROCLAMATION**

BY THE HONOURABLE WENTZEL CHRISTOFFEL  
DU PLESSIS, ADMINISTRATOR OF SOUTH WEST  
AFRICA.

No. 9 of 1966.]

WHEREAS by section 19 (2) of the South West Africa Constitution Act, 1925, of the Parliament of the Republic of South Africa, it is provided that the first Sitting of any Session of the Legislative Assembly for the Territory of South West Africa, shall take place on such date as the Administrator may fix by proclamation;

AND WHEREAS it is expedient that the Legislative Assembly should be summoned to meet;

NOW, THEREFORE, under and by virtue of the power and authority vested in me, I do by this Proclamation summon the Legislative Assembly to meet on Friday, 18th February, 1966, and I hereby declare that the First Sitting of the Sixth Session of the Eighth Legislative Assembly shall be held at Windhoek at 2.30 p.m. on the said date, for the dispatch of business.
