SNELHEIDSGRENS: GEDEELTE VAN HOOFPAD 1, SEKSIE 5: DISTRIK WINDHOEK.

SPEED LIMIT: PORTION OF TRUNK ROAD 1, SECTION 5, WINDHOEK DISTRICT.

Kragtens die bevoegdheid my verleen by artikel 82 van die Padverkeersordonnansie 1961 (Ordonnansie 21 van 1961) word hierby kennis gegee dat 'n algemene snelheidsgrens van 35 myl per uur voorgeskryf word vir daardie gedeelte van hoofpad 1, seksie 5, vanaf 'n punt op die suidelike grens van die stedelike gebied van Windhoek tot by 'n punt 500 jrts. suid van die uitdraaipad na die inryteater, vanaf die datum hiervan.

Under and by virtue of the powers in me vested by section 82 of the Road Traffic Ordinance, 1961, (Ordinance 21 of 1961) it is hereby notified that a general speed limit of 35 miles per hour is prescribed for that portion of trunk road 1, section 5, from a point on the southern limit of the urban area of Windhoek to a point 500 yards south of the turn-off road to the drive-in-cinema, as from the date hereof.
