Tot aanwending van 'n bedrag van hoogstens eenhonderd miljoen, negehonderd en een duisend, drie honderd rand, ten behoeve van die diens van die Gebied Suidwes-Afrika vir die boekjaar wat op die een-en-dertigste dag van Maart 1967 eindig.

(Goedgekeur 11 Mei 1966)

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN:—

Gebiedsinkomstefonds belas met R75,770,300 op Inkomsterekening.

1. Die Gebiedsinkomstefonds word hiermee belas met die somme geld wat nodig mag wees vir die diens van die Gebied vir die boekjaar wat op die een-en-dertigste dag van Maart 1967 eindig, maar gesamentlik hoogstens vyf-en-sewentig miljoen, sewehonderd en sewentig duisend, drie honderd rand op die inkomsterekening soos uiteengesit in Kolom 1 van die Eerste Bylae.

Gebiedsinkomstefonds belas met R22,000,000 op Leningsrekening.

2. Ingevolge artikel 15 van Ordonnansie 1 van 1926, soos gewysig, word die Gebiedsinkomstefonds verder belas met die somme geld wat nodig mag wees vir die diens van die Gebied vir die boekjaar wat op die een-en-dertigste dag van Maart 1967 eindig, maar gesamentlik hoogstens twee-en-twintig miljoen rand ten laste van die Leningsrekening soos uiteengesit in Kolom 1 van die Eerste Bylae.

Administrasie-rekening belas met R1,000,000 op die Reserwerekening van die Gebiedsontwikkelings- en -Reserwefonds.

3. Ingevolge artikel 6 (2) van Ordonnansie 13 van 1944, soos gewysig deur Ordonnansie 27 van 1957, word die Administrasie-rekening van die Gebied Suidwes-Afrika belas met die somme geld wat nodig mag wees vir die diens van die Gebied, maar gesamentlik hoogstens een miljoen rand op die Reserwerekening van die Gebiedsontwikkelings- en -Reserwefonds, soos uiteengesit in Kolom 1 van die Tweede Bylae.

Administrasie-rekening belas met R2,131,000 op die Kapitaal Gebeurlikheidsrekening van die Gebiedsontwikkelings- en -Reserwefonds.

4. Ingevolge artikel 6 (2) van Ordonnansie 13 van 1944, soos gewysig deur Ordonnansie 27 van 1957, word die Administrasie-rekening van die Gebied Suidwes-Afrika verder belas met die somme geld wat nodig mag wees vir die diens van die Gebied, maar gesamentlik hoogstens twee miljoen eenhonderd een-en-dertig duisend rand op die Kapitaal Gebeurlikheidsrekening van die Gebiedsontwikkelings- en -Reserwefonds, soos uiteengesit in Kolom 1 van die Derde Bylae.

Hoe geld aangewend moet word.

5. Die geld wat deur hierdie Ordonnansie beskikbaar gestel word, moet aangewend word vir die dienste in besonderhede vermeld in die Bylaes en meer omstandig uiteengesit in die Begroting van Uitgawes (S.W.A. 3—1966) soos deur die Wetgewende Vergadering goedgekeur, en behoudens artikel ses hiervan, en vir geen ander doel nie.

Die Administrateur kan 'n afwyking goedkeur.

6. Met die goedkeuring van die Administrateur kan 'n besparing onder die een subhoof van 'n begrotingspos aangewend word tot dekking van 'n oorskryding onder enige ander subhoof, of van uitgawe onder 'n nuwe subhoof van dieselfde begrotingspos: Met dien verstande dat die somme wat in Kolom 2 van die Eerste Bylae voorkom, nie oorskry mag word nie, en besparings daarop ewemin aangewend mag word vir enige ander doel as dié waarvoor die geld hierby toegestaan word soos in die gemelde Bylaes aangedui. Ingelyks is hierdie goedkeuring ook van toepassing op die Reserwerekening en die Kapitaal Gebeurlikheidsrekening.

**ORDINANCE**

To apply a sum not exceeding one hundred million, nine hundred and one thousand, three hundred rand towards the service of the Territory of South West Africa for the financial year ending on the thirty-first day of March, 1967.

(Assented to 11th May, 1966)

(Afrikaans text signed by the Administrator)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa:—

1. The Territory Revenue Fund is hereby charged with such sums of money as may be required for the service of the Territory for the financial year ending on the thirty-first day of March, 1967, not exceeding in the aggregate seventy-five million, seven hundred and seventy thousand, three hundred rand on revenue as shown in Column 1 of the First Schedule.

2. In terms of section 15 of Ordinance 1 of 1926, as amended, the Territory Revenue Fund is further charged with such sums of money as may be required for the service of the Territory, for the financial year ending on the thirty-first day of March, 1967, not exceeding in the aggregate twenty-two million rand on Loan Account as shown in Column 1 of the First Schedule.

3. In terms of section 6 (2) of Ordinance 13 of 1944, as amended by Ordinance 27 of 1957, the Administration Account of the Territory of South West Africa is charged with such sums of money as may be required for the service of the Territory, not exceeding in the aggregate one million rand on the Reserve Account of the Territorial Development and Reserve Fund as shown in Column 1 of the Second Schedule.

4. In terms of section 6 (2) of Ordinance 13 of 1944, as amended by Ordinance 27 of 1957, the Administration Account of the Territory of South West Africa is further charged with such sums of money as may be required for the service of the Territory, not exceeding in the aggregate two million, one hundred and thirty-one thousand rand on the Capital Contingencies Account of the Territorial Development and Reserve Fund as shown in Column 1 of the Third Schedule.

5. The money appropriated by this Ordinance shall be applied to the services detailed in the Schedules, and more particularly specified in the Estimates of Expenditure (S.W.A. 3—1966), as approved by the Legislative Assembly, and subject to Section *six* hereof, and to no other purpose.

6. With the approval of the Administrator a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head of the same vote: Provided that the sums appearing in Column 2 of the First Schedule shall not be exceeded, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedules. Likewise this approval also applies to the Reserve Account and the Capital Contingencies Account.

## ORDINANCE

To amend the Native Housing Levy Ordinance, 1961.

(Assented to 11th May, 1966)

(English text signed by the Administrator)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, with the consent of the State President in so far as such consent is necessary previously obtained and communicated to the Legislative Assembly by message from the Administrator in accordance with the provisions of section 26 of the South West Africa Constitution Act, 1925 (Act 42 of 1925) of the Parliament of the Republic of South Africa, as follows:—

1. Section 3 of the Native Housing Levy Ordinance, 1961 (Ordinance 33 of 1961) is hereby amended by the substitution for the words "at a rate not exceeding fifty cents per week" in sub-section (1) of the words "at a rate not exceeding one rand per week".

Amendment of section 3 of Ordinance 33 of 1961.

2. This ordinance shall be called the Native Housing Levy Amendment Ordinance, 1966.

## ORDINANCE

To amend the Transfer of Credits Ordinance between the Grain Board Suspense Account and the Farming Interests Fund, 1963.

(Assented to 11th May, 1966)

(English text signed by the Administrator)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Section 1 of the Transfer of Credits Ordinance between the Grain Board Suspense Account and the Farming Interests Fund, 1963 (Ordinance 4 of 1963) is hereby amended by the substitution for the words "an amount of one hundred and twenty-one thousand rand" of the words "any moneys as from time to time required".

Amendment of Section 1 of Ordinance 4 of 1963.

2. This ordinance shall be called the Transfer of Credits Amendment Ordinance between the Grain Board Suspense Account and the Farming Interests Fund, 1966.

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN:—

Wysiging van artikel 2 van Ordonnansie 16 van 1959 soos gewysig by artikel 1 van Ordonnansie 26 van 1960, artikel 1 van Ordonnansie 14 van 1961, artikel 1 van Ordonnansie 26 van 1962, artikel 1 van Ordonnansie 2 van 1963 en artikel 1 van Ordonnansie 12 van 1964.

1. Artikel 2 van die Ordonnansie op Spesiale Onderstand aan Boere 1959 (Ordonnansie 16 van 1959) word hierby gewysig deur subartikel (2) deur die volgende subartikel te vervang:—

„(2) Die raad kan behoudens die bepalings van hierdie ordonnansie en uit gelde wat die Wetgewende Vergadering spesiaal daartoe bewillig het aan enigiemand vir wie die bepalings van paragrafe (a) en (b) van subartikel (1) geld, en wat op of voor 'n datum deur die Administrateur by proklamasie bepaal, daarom aansoek gedoen het, en wat, omdat sy middele nadelig getref is deur die heersende droogtetoestande, geen redelike middele het om vir die behoud van sy vee krag- of ander voer aan te koop of weiding te huur nie, 'n lening toestaan om sodanige krag- of ander voer aan te koop of sodanige weiding te huur: Met dien verstande dat die Administrateur die maksimum bedrag van sodanige lening van tyd tot tyd kan bepaal.”

## ORDINANCE

To amend the Farmers' Special Relief Ordinance, 1959, to grant to the Administrator authority to determine the date up to when application can be made for a loan for concentrates or other fodder or grazing, and to determine the maximum amount of such loan.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Section 2 of the Farmers' Special Relief Ordinance, 1959, (Ordinance 16 of 1959) is hereby amended by the substitution for sub-section (2) of the following sub-section:—

“(2) The Board may subject to the provisions of this ordinance, and from moneys specially voted therefor by the Legislative Assembly, grant to any person to whom the provisions of paragraphs (a) and (b) of sub-section (1) apply, and who has applied therefor on or before a date determined by the Administrator by proclamation, and who by reason of his means having been adversely affected by the prevailing conditions of drought, has no reasonable means of buying concentrates or other fodder or hiring grazing for the sustenance of his stock, a loan for the purpose of purchasing such concentrates or other fodder or hiring such grazing; Provided that the Administrator may from time to time determine the maximum amount of such loan.”

“Provided further that the provisions of paragraph (c) shall not be applicable to a schoolgoing child who raises funds solely for *bona fide* school or school hostel funds or to a child who is a member of a youth organization recognized by the Administrator and as a member of a group or a team under control and supervision of an adult attached to such an organization, raises funds solely for the benefit of such organization of which he is a member.”
