VERSAMELING VAN MOSSELS EN ROOI-AAS.

Dit behaag die Administrateur om kragtens en ingevolge die bevoegdheid hom verleen by artikel *vyf-en-twintig* van die Ordonnansie op Robbevangs en Visserye 1949 (Ordonnansie 12 van 1949), paragraaf 3 van regulasie 7 van die regulasies afgekondig by Goewermentskennisgewing 215 van 1949, soos gewysig by Goewermentskennisgewings 269 van 15 Desember 1956 en 72 van 15 Mei 1965, verder te wysig deur —

- (a) die woorde „of gedeelte van 'n jaar” na die woorde „R1-00 per jaar” in te voeg; en
- (b) aan die einde daarvan die volgende woorde te voeg — „of vir sodanige korter tydperk wat die Administrateur bepaal.”

COLLECTION OF MUSSELS AND RED BAIT.

The Administrator has been pleased under and by virtue of the powers vested in him by section *twenty-five* of the Sealing and Fisheries Ordinance, 1949 (Ordinance 12 of 1949), further to amend paragraph 3 of regulation 7 of the regulations made under Government Notice 215 of 1949, as amended by Government Notices 269 of 15 December 1956, and 72 of 15 May 1965, by —

- (a) the insertion of the words “or portion of a year” after the words “R1-00 per year” and
- (b) the addition at the end thereof of the words “or for such shorter period as may be determined by the Administrator.”
