WHEREAS by section 19 (2) of the South West Africa Constitution Act, 1925, of the Parliament of the Republic of South Africa, it is provided that the First Sitting of any Session of the Legislative Assembly for the Territory of South West Africa, shall take place on such date as the Administrator may fix by proclamation;

NADEMAAL artikel 19 (2) van die Zuidwest Afrika Konstitutie Wet 1925 van die Parlement van die Republiek van Suid-Afrika, bepaal dat die Eerste Sitting van enige Sessie van die Wetgewende Vergadering vir die Gebied Suidwes-Afrika sal plaasvind op sodanige datum soos die Administrateur by proklamasie bepaal;

AND WHEREAS it is expedient that the Legislative Assembly should be summoned to meet;

EN NADEMAAL dit dienstig is om die Wetgewende Vergadering byeen te roep;

NOW, THEREFORE, under and by virtue of the power and authority vested in me, I do by this Proclamation summon the Legislative Assembly to meet on Monday, 13 March, 1967, and I hereby declare that the First Sitting of the Second Session of the Ninth Legislative Assembly shall be held at Windhoek at 2.30 p.m. on the said date, for the dispatch of business.

SO IS DIT DAT EK, kragtens die mag en bevoegdheid my verleen, die Wetgewende Vergadering by hierdie Proklamasie byeenroep om op Maandag 13 Maart 1967, byeen te kom en verklaar ek hierby dat die Eerste Sitting van die Tweede Sessie van die Negende Wetgewende Vergadering gehou sal word te Windhoek om 2.30 nm. op die genoemde datum, vir die afhandeling van sake.
