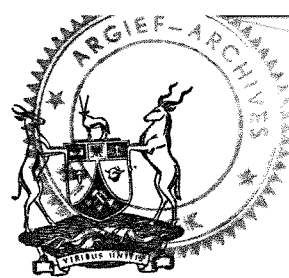

NATIVES (URBAN AREAS) PROCLAMATION, 1951 (SOUTH WEST AFRICA) (PROCLAMATION NO. 56 OF 1951): ABOLITION AND REMOVAL OF OLD LOCATION, WINDHOEK.

I, MICHEL COENRAAD BOTHA, Minister of Bantu Administration and Development, hereby give notice in terms of the powers vested in me by section 3 (4) of the Natives (Urban Areas) Proclamation, 1951 (South West Africa) (Proclamation No. 56 of 1951), and after consultation with the urban local authority concerned, of my intention to approve the abolition and removal of the native location defined in Government Notice No. 132 of 1937 and situate in the area of jurisdiction of the Municipality of Windhoek, since it appears to me that the conditions under which Natives are living in the said location are such that unless the said location is abolished and removed, the health and safety of the public generally and of the said Natives in particular may be endangered.

PROKLAMASIE OP INBOORLINGE IN STEDELIKE GEBIEDE, 1951 (SUIDWES-AFRIKA) (PROKLAMASIE NO. 56 VAN 1951): AFSKAFFING EN VERWYDERING VAN OU LOKASIE, WINDHOEK.

Ek, MICHEL COENRAAD BOTHA, Minister van Bantoe-administrasie en -ontwikkeling, gee hierby kennis kragtens die bevoegdheid my verleen by artikel 3 (4) van die Proklamasie op Inboorlinge in Stedelike Gebiede, 1951 (Suidwes-Afrika) (Proklamasie No. 56 van 1951), en na oorlegpleging met die betrokke stedelike plaaslike bestuur, van my voorneme om my goedkeuring te heg aan die afskaffing en verwydering van die inboorlinglokasie omskryf by Goewermentskennisgewing No. 132 van 1937 en geleë in die regsgebied van die Munisipaliteit van Windhoek, aangesien dit my blyk dat die toestande waarin inboorlinge in gemelde lokasie woon sodanig is dat, tensy gemelde lokasie afgeskaf en verwyder word, die gesondheid en veiligheid van die publiek oor die algemeen en van genoemde inboorlinge in die besonder in gevaar gestel kan word.
