DEPARTMENT OF BANTU ADMINISTRATION AND DEVELOPMENT.

MUNICIPALITY OF WINDHOEK, SOUTH WEST AFRICA: ABOLITION OF LOCATION.

WHEREAS I, MICHEL COENRAAD BOTHA, Minister of Bantu Administration and Development, by Government Notice No. 110 dated 15th July, 1968, gave notice of my intention to approve the abolition and removal of the location described in Government Notice No. 132 of 15th July, 1937, and situate in the area of jurisdiction of the Municipality of Windhoek;

NOW THEREFORE, I do hereby after reference to the urban local authority of Windhoek in terms of the powers vested in me by section 3 (8) of the Natives (Urban Areas) Proclamation, 1951 (Proclamation No. 56 of 1951) (South West Africa), declare that with effect from the 1st day of September, 1968, the abovementioned location shall be abolished.

Government Notice No. 132 of 1937 is hereby repealed.
