PROCLAMATION

BY THE STATE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA.

No. 5 of 1969 (Republic).]

HOUSE OF ASSEMBLY BY-ELECTION: WINDHOEK.

WHEREAS it has been brought to my notice that a vacancy has occurred in the representation of the electoral division of Windhoek in the House of Assembly by reason of the resignation of the Honourable Johannes Gert Hendrik van der Wath;

NOW, THEREFORE, under and by virtue of the powers and authority vested in me by sections *thirty-five* and *eighty-eight* of the Electoral Consolidation Act, 1946 (Act No. 46 of 1946), I do hereby —

- (1) declare that a vacancy exists in the representation of the electoral division of Windhoek in the House of Assembly;
- (2) determine —
 - (a) that Wednesday, the twenty-ninth day of January, 1969, shall be the day on which a nomination court will sit to receive nominations of candidates for election as a member of the House of Assembly for the aforesaid electoral division;
 - (b) that the nomination court shall sit in Room 18, Marie Neef Building, Windhoek;
 - (c) that the nomination court shall sit at ten o'clock in the forenoon of the aforesaid day;

VOLKSRAADTUSSENVERKIESING: WINDHOEK.

NADEMAAL dit tot my kennis gebring is dat daar 'n vakature in die verteenwoordiging van die kiesafdeling Windhoek in die Volksraad ontstaan het weens die bedanking van Sy Edele Johannes Gert Hendrik van der Wath;

SO IS DIT dat ek kragtens die bevoegdheid en gesag my verleen by artikels *vyf-en-dertig* en *aght-en-tagtig* van die Wet tot Konsolidasie van die Kieswette, 1946 (Wet No. 46 van 1946), hierby —

- (1) verklaar dat daar 'n vakature in die verteenwoordiging van die kiesafdeling Windhoek in die Volksraad bestaan;
- (2) bepaal —
 - (a) dat Woensdag, die nege-en-twintigste dag van Januarie 1969 die dag is waarop 'n nominasiehof sitting sal hou om nominasies te ontvang van kandidate vir verkiesing tot lid van die Volksraad vir voormelde kiesafdeling;
 - (b) dat die nominasiehof sitting sal hou in Kamer 18, Marie Neefgebou, Windhoek;
 - (c) dat die nominasiehof om tienuur in die voormiddag van voormelde dag sitting sal hou;
