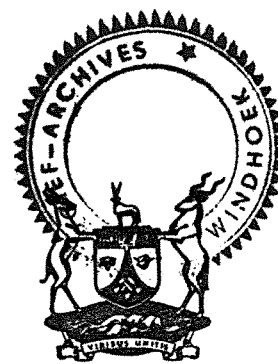

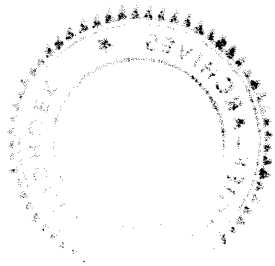

DRAFT ORDINANCE

To amend the Reservation of State Land for Natives Ordinance 1967 to provide that state land set apart and reserved for the use and occupation of Natives may be used for the purpose of rescinding certain existing reserves.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, with the consent of the State President, in so far as such consent is necessary, previously obtained and communicated to the Legislative Assembly by message from the Administrator in accordance with the provisions of section 22 of the South West Africa Constitution Act, 1968 (Act 39 of 1968), of the Republic of South Africa, as follows:—

Amendment of section 1 of Ordinance 35 of 1967.

1. Section 1 of the Reservation of State Land for Natives Ordinance, 1967 (Ordinance 35 of 1967) — hereinafter referred to as the principal ordinance — is hereby amended by the substitution of the full stop by a colon and the addition of the following proviso at the end thereof:

“Provided that such land or portion of such land, set apart and reserved as aforesaid, may in terms of section 5 of the South West Africa Native Affairs Act, 1954 (Act 56 of 1954) be used for the purpose of rescinding the reservation of setting apart of the Aminuis, Bondelswarts, Warmbad, Neuhoff, Ovitoto and Otjimbingwe reserves, set aside in terms of the Native Administration Proclamation, 1922 (Proclamation 11 of 1922).”

Amendment of the schedule to Ordinance 35 of 1967.

2. The schedule to the principal ordinance is hereby amended —

(a) by the insertion under the appropriate district in numerical sequence according to the number in the second column, of the state land as set out hereunder:—

ONTWERPORDONNANSIE

Ter wysiging van die Ordonnansie op die Reservering van Staatsgrond vir Inboorlinge 1967 om voorsiening te maak dat staatsgrond wat afgesonder en gereserveer is vir gebruik en besit deur Inboorlinge gebruik mag word vir die herroeping van sekere bestaande reservate.

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika, met die toestemming van die Staatspresident dermate sodanige toestemming nodig is, vooraf verkreeë en deur boodskap van die Administrateur aan die Wetgewende Vergadering meegedeel ooreenkomstig die bepalings van artikel 22 van die Wet op die Konstitusie van Suidwes-Afrika, 1968 (Wet 39 van 1968), van die Republiek van Suid-Afrika, VERORDEN:—

1. Artikel 1 van die Ordonnansie op die Reservering van Staatsgrond vir Inboorlinge 1967 (Ordonnansie 35 van 1967) — hierna heet dit die hoofordonnansie — word hierby gewysig deur aan die einde daarvan die punt te vervang deur 'n dubbelpunt en die volgende voorbehoudsbepaling toe te voeg:—

Wysiging van artikel 1 van Ordonnansie 35 van 1967.

„Met dien verstande dat sodanige grond of gedeelte van sodanige grond wat afgesonder en gereserveer is soos voornoemd, ingevolge die bepalings van artikel 5 van die Wet op die Administrasie van Naturellesake in Suidwes-Afrika 1954 (Wet 56 van 1954) gebruik mag word vir die doeleindes van die intrekking van die reservering en afsondering van die Aminuis, Bondelswarts, Warmbad, Neuhoff, Ovitoto en Otjimbingwe reservate wat gereserveer is kragtens die bepalings van die Naturelle Administrasie Proklamasie 1922 (Proklamasie 11 van 1922).”.

2. Die bylae tot die hoofordonnansie word hierby gewysig —

"UNSURVEYED STATE LAND.

Commencing on the point where the southern boundary of the magisterial district of Okavangoland joins the boundary common to the Republic of Botswana and the Territory of South West Africa; thence southwards along the boundary of the Territory of South West Africa to the north-eastern corner beacon of the farm No. 885, district of Gobabis; thence westwards along the northern boundaries of the said farm No. 885 and farms Nos. 884, 883, 882, 881, 880, 879, 833 and 832, district of Gobabis, to the south-eastern corner beacon of Epukiro No. 329, district of Gobabis; thence northwards along the eastern boundary of the said Epukiro No. 329 to the south-eastern corner beacon of Eastern N.R. No. 792, district of Gobabis; thence north-westwards along the north-eastern boundary of the said Eastern N.R. No. 792 and Otjituuo No. 235, district of Grootfontein, to the south-eastern corner beacon of the farm Klapperhof No. 960, district of Grootfontein; thence northwards along the eastern boundary of the said farm Klapperhof No. 960 and the farms Sandplaas No. 959, Swarthaak No. 958 and Oorkant No. 953, district of Grootfontein, to the south-western corner beacon of farm No. 1118, district of Grootfontein; thence north-eastwards along the south-eastern boundary of the said farm No. 1118 and farms Rumara No. 993 and Horabe No. 994, district of Grootfontein, to the south-eastern corner beacon of the said farm Horabe No. 994; thence northwards along the eastern boundary of the said farm Horabe No. 994 and the farms Hieromtrent No. 995, Vreugde No. 1000, Rooidag No. 1001, Talita No. 1006, Hero No. 1007, Verskyn No. 1012, No. 1013, No. 1018 and No. 1019, district of Grootfontein, to the north-eastern corner beacon of the said farm No. 1019; thence westwards along the northern boundaries of the said farm No. 1019 and farms Nos. 1020, 1021, 1022, 1027, 1028, 1033, 1034, 1039, 1040, 1046, 1047, 1052, 1053 and 1058, district of Grootfontein, to the point where the northern boundary of the said farm No. 1058 intersects the east line of longitude 18° 15' E; thence northwards along the line of longitude 18° 15' E to the southern boundary of the magisterial district of Okavangoland; thence eastwards along the southern boundary of the magisterial district of Okavangoland to the point of commencement."

Short title.

3. This ordinance shall be called the Reservation of State Land for Natives Amendment Ordinance 1969 and shall be deemed to have come into operation on the 28th day of November 1967.

Begin by 'n punt waar die suidelike grens van die Landdrosdistrik Okavangoland by die Republiek van Botswana en die Gebied Suidwes-Afrika se gemeenskaplike grens aansluit; daarvandaan suidwaarts langs die Gebied Suidwes-Afrika se grens tot by die noordoostelike hoekbaken van plaas No. 885, distrik Gobabis; daarvandaan weswaarts langs genoemde plaas 885 en plase Nos. 884, 883, 882, 881, 880, 879, 833, 832, distrik Gobabis se noordgrense tot by die suidoostelike hoekbaken van Epukiro No. 329, distrik Gobabis; daarvandaan noordwaarts langs genoemde Epukiro No. 329 se oosgrense tot by die suidoostelike hoekbaken van Oostelike N.R. No. 792, distrik Gobabis, daarvandaan noordweswaarts langs genoemde Oostelike N.R. No. 792 en Otjituuo No. 235, distrik Grootfontein, se noordoosgrense tot by die suidoostelike hoekbaken van plaas Klapperhof No. 960, distrik Grootfontein; daarvandaan noordwaarts langs genoemde plaas Klapperhof No. 960 en plase Sandplaas No. 959, Swarthaak No. 958 en Oorkant No. 953, distrik Grootfontein, se oosgrense tot by die suidwestelike hoekbaken van plaas No. 1118, distrik Grootfontein; daarvandaan noordooswaarts langs genoemde plaas No. 1118 en plase Rumara No. 993 en Horabe No. 994, distrik Grootfontein, se suidoosgrense tot by die suidoostelike hoekbaken van genoemde plaas Horabe No. 994; daarvandaan noordwaarts langs genoemde plaas Horabe No. 994 en plase Hieromtrent No. 995, Vreugde No. 1000, Roodag No. 1001, Talita No. 1006, Hero No. 1007, Verskyn No. 1012, No. 1013, No. 1018 en No. 1019, distrik Grootfontein, se oosgrense tot by die noordoostelike hoekbaken van genoemde plaas No. 1019; daarvandaan weswaarts langs genoemde plaas No. 1019 en plase Nos. 1020, 1021, 1022, 1027, 1028, 1033, 1034, 1039, 1040, 1046, 1047, 1052, 1053 en 1058, distrik Grootfontein, se noordgrense tot by die punt waar genoemde plaas No. 1058 se noordgrens die ooslengtelyn 18° 15' sny; daarvandaan noordwaarts langs die ooslengtelyn 18° 15' tot by die suidelike grens van die Landdrosdistrik Okavangoland; daarvandaan ooswaarts langs die suidelike grens van die Landdrosdistrik Okavangoland tot by die beginpunt.”.

3. Hierdie ordonnansie heet die Wysigingsordonnansie op die Reservering van Staatsgrond vir Inboorlinge 1969 en word beskou as in werking met ingang van die 28ste dag van November 1967. Kort titel.
