ALGEMENE REGISTRASIE VAN KIESERS.

GENERAL REGISTRATION OF VOTERS.

NADEMAAL by subartikel (1) van artikel *agt* van die Wet tot Konsolidasie van die Kieswette, 1946 (Wet No. 46 van 1946) soos gewysig, bepaal word dat 'n algemene registrasie van kiesers dwarsdeur die Republiek en die gebied Suidwes-Afrika in 1969 sal plaasvind vanaf 'n datum by proklamasie in die Staatskoerant vasgestel te word;

WHEREAS by subsection (1) of section *eight* of the Electoral Consolidation Act, 1946 (Act No. 46 of 1946) as amended, it is provided that a general registration of voters shall take place in 1969 throughout the Republic and the Territory of South West Africa as from a date to be fixed by proclamation in the Government Gazette;

SO IS DIT dat ek, kragtens die gesag en bevoegdheid my verleen, by hierdie Proklamasie verklaar dat die sewentiende dag van November 1969, vasgestel is as die datum waarop 'n algemene registrasie van kiesers dwarsdeur die Republiek en die gebied Suidwes-Afrika 'n aanvang sal neem;

NOW, THEREFORE, by virtue of the powers and authority vested in me, I do by this Proclamation declare that the seventeenth day of November, 1969, has been fixed as the date from which a general registration of voters throughout the Republic and the Territory of South West Africa shall commence;

GEGEE onder my Hand en die Seël van die Republiek van Suid-Afrika te Pretoria op hierdie Vyf-entwintigste dag van September Eenduisend Negehonderd Nege-en-sestig.

GIVEN under my Hand and the Seal of the Republic of South Africa at Pretoria on this Twenty-fifth day of September One thousand Nine hundred and Sixty-nine.
