SCHEDULE.

NEW ELECTORAL WARDS:

WINDHOEK MUNICIPALITY.

WARD 1

That portion of the municipal area of Windhoek bounded as follows:

From the intersection of the centre lines of Leutwein Street and Schanzenweg, eastwards along the centre line of Schanzenweg to Orban Street; thence along the centre line of Orban Street southwards to Hügel Street; westwards along the centre lines of Hügel Street, Gobabis Road; southwards along the centre line of Leutwein Street; westwards along the centre lines of Kalk Street, Garten Street to Tal Street; thence along the centre line

That portion of the municipal area of Windhoek bounded as follows:

From the intersection of the centre lines of Schanzenweg and Sinclair Road northwards along the centre line of Schanzenweg; northwestwards along the centre line of Klein Windhoek Road, Promenadenweg to the intersection of Promenadenweg and Mont Blanc Street and thence westwards along the centre line of Mont Blanc Street to where the extension of the centre line of Mont Blanc Street intersects the Windhoek-Okahandja railway line. From this point along the railway line southwards to where the extension of the centre line of Körner Street meets the railway line. From this point eastwards along the centre line of Körner Street; southwards along the centre line of Leutwein Street and again eastwards along the centre line of Schanzenweg to the point of beginning.

WARD 3

That portion of the municipal area of Windhoek bounded as follows:

From this point northwestwards along the boundary between Windhoek Town and Townlands 31 and Windhoek to the point where the extension of the said boundary meets the centre line of Bach Street. From that point southwards along the centre line of Bach Street; northeastwards along the centre line of John Meinert Street; eastwards along the centre line of Verdi Street; southwards along the centre line of Haydn Street; eastwards along the centre line of Brahms Street and southeastwards along the centre line of van Rhyn Street to the point of beginning.
