## ORDINANCE

To amend the Expropriation Ordinance, 1967 (Ordinance 32 of 1967), to extend the powers of expropriation of local authorities.

*(Assented to 22 June 1970)*  
*(Afrikaans text signed by the Administrator)*

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Section 15 of the Expropriation Ordinance, 1967 (Ordinance 32 of 1967) is hereby amended by the deletion of the words "which is by ordinance empowered to expropriate land,".
