ORDONNANSIE

Ter wysiging van die Ordonnansie op Huisvestingsinrigtings en Toerisme 1967 (Ordonnansie 29 van 1967) om die bepaling ten opsigte van die toestaan van lenings in verband met huisvestingsinrigtings uit te brei.

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN soos volg:—

Wysiging van artikel 12 van Ordonnansie 29 van 1967 soos gewysig by artikel 3 van Ordonnansie 11 van 1969.

1. Artikel 12 (1) van die Ordonnansie op Huisvestingsinrigtings en Toerisme 1967 (Ordonnansie 29 van 1967) word hierby gewysig deur paragraaf (r) deur die volgende paragraaf te vervang:—

„(r) die toestaan van lenings in verband met huisvestingsinrigtings.”

ORDINANCE

To amend the Accommodation Establishments and Tourism Ordinance, 1967 (Ordinance 29 of 1967) to extend the powers in respect of the granting of loans in connection with accommodation establishments.

(Assented to 22 June 1970)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Section 12 (1) of the Accommodation Establishments and Tourism Ordinance, 1967 (Ordinance 29 of 1967) is hereby amended by the substitution for paragraph (r) of the following paragraph.

Amendment of section 12 of Ordinance 29 of 1967, as amended by section 3 of Ordinance 11 of 1969.

“(r) the granting of loans in connection with accommodation establishments.”

2. This ordinance shall be called the Accommodation Establishments and Tourism Amendment Ordinance, 1970.
