## ORDINANCE

To amend the Prohibited Areas Proclamation, 1928 (Proclamation 26 of 1928) to amend the entry into and residence of persons in certain areas.

(Assented to 2 December 1970)

(Afrikaans text signed by the Administrator)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:—

1. Section 3 (1) (b) and (c) of the Prohibited Areas Proclamation, 1928 (Proclamation 26 of 1928), hereinafter called the Proclamation, is hereby repealed.

Amendment of section 3 of Proclamation 26 of 1928, as amended by section 1 of Ordinance 9 of 1942, section 2 of Ordinance 4 of 1955, section 1 of Ordinance 26 of 1957, section 36 of Ordinance 34 of 1959 and section 77 of Ordinance 31 of 1967.

2. The second schedule to the Proclamation is hereby repealed.

Repeal of the second schedule of Proclamation 26 of 1928, as amended by Government Notices 114 of 1941, 181 of 1942, 375 of 1947, 247 of 1958 and 20 of 1966.

3. The third schedule to the Proclamation is hereby repealed.

Repeal of the third schedule of Proclamation 26 of 1928, as inserted by section 2 of Ordinance 26 of 1957.

4. This ordinance shall be called the Prohibited Areas Amendment Ordinance, 1970.
