## DRAFT ORDINANCE

To amend the Accommodation Establishments and Tourism Ordinance, 1967 (Ordinance 29 of 1967), in order to provide for the registration of holiday farms and pensions as accommodation establishments and for incidental matters.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Section 1 of the Accommodation Establishments and Tourism Ordinance, 1967 (Ordinance 29 of 1967), hereinafter referred to as the principal ordinance, is hereby amended by the substitution for paragraph (iii) of the following paragraph:

“(iii) “accommodation establishment” means any premises in or on which the business of providing accommodation and meals for reward to tourists is or is intended to be conducted and includes a rest camp, guest farm, holiday farm, pension, caravan park and safari undertaking where accommodation with or without other services for reward to tourists is provided”;

2. Section 12 of the principal ordinance is hereby amended by the substitution for paragraph (h) of subsection (1) of the following paragraph:

“(h) the exemption of any accommodation establishment from all or any of the requirements for registration under this ordinance”.

3. This Ordinance shall be called the Accommodation Establishments and Tourism Amendment Ordinance, 1971.

## ONTWERPORDONNANSIE

Ter wysiging van die Ordonnansie op Huisvestingsinrigtings en Toerisme 1967 (Ordonnansie 29 van 1967), om voorsiening te maak vir die registrasie van vakansieplase en pensions as huisvestingsinrigtings en vir aanverwante sake.

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN soos volg:—

1. Artikel 1 van die Ordonnansie op Huisvestings-inrigtings en Toerisme 1967 (Ordonnansie 29 van 1967), hierna die hoofordonnansie genoem, word hierby gewysig deur paragraaf (iii) deur die volgende paragraaf te vervang:

„(iii) „huisvestingsinrigting”, enige perseel waarin of waarop die besigheid om huisvesting en etes teen vergoeding aan toeriste te verskaf, gedryf word of na voorname gedryf gaan word en sluit in 'n rus-kamp, gasteplaas, vakansieplaas, pension, karavaanpark en safari-onderneming waar huisvesting met of sonder ander dienste teen vergoeding aan toeriste verskaf word”;
2. Artikel 12 van die hoofordonnansie word hierby gewysig deur paragraaf (h) van subartikel (i) deur die volgende paragraaf te vervang:

„(h) die vrystelling van enige huisvestingsinrigting van al of enige van die vereistes vir registrasie ingevolge hierdie ordonnansie”.
3. Hierdie Ordonnansie heet die Wysigingsordonnansie op Huisvestingsinrigtings en Toerisme, 1971.
