**AMENDMENT OF GENERAL REGULATIONS
RELATING TO NATURE CONSERVATION.**

The Administrator has been pleased, under and by virtue of the powers in him vested by section 45 of the Nature Conservation Ordinance, 1967 (Ordinance 31 of 1967) to approve the following amendments of the regulations published under Government Notices 51 and 186 of 1968:

1. Regulation 1, Chapter 1, is hereby amended by the insertion of the following definition at the end thereof:
 " 'Sandwich Harbour' means the entire seaboard of the Namib Desert Park, one kilometre wide, measured from the low-water mark."
2. Subregulation (2) of regulation 2, Chapter 1 is hereby amended by the substitution of "R2-00" for the "R1-00" scale of tariff where it appears under the heading "Namib Desert Park".
3. The following subregulation is hereby substituted for subregulation (e) of regulation 29, Chapter 2:
 "(e) visit Sandwich Harbour —
 (i) after 7 o'clock p.m. and before 7 o'clock a.m., or on Sundays;
 (ii) over land, or in a vehicle which is not a four-wheel drive vehicle or which has not, to the satisfaction of the nature conservator on duty, been adapted specially for similar drives, or with a vehicle with a carrying capacity in excess of one ton, or drive a vehicle further southward than the point indicated by a notice board."
4. Subregulation (i) of regulation 29, Chapter 2, is hereby amended by the insertion of the word "immediately" between the words "it" and "at" where they appear in the second and third lines.
5. The following subregulation is hereby inserted after subregulation (r) of regulation 29, Chapter 2 —
 "(s) break a bottle, or cause or allow it to be broken, at places where vehicles are driven or where anglers catch fish;
 (t) place or throw baited hooks, or bait attached to lines, or leave them at places where they can be picked up by sea-birds, or deliberately catch sea-birds with a line, or with hook and line;

 (ii) oorland, of in 'n voertuig wat nie vierwielgedrewe is of, ten genoë van die diensdoende natuurbewaarder, spesiaal vir soortgelyke ritte ingerig is, of met 'n voertuig met 'n dravermoë van meer as een ton, besoek nie of verder suidwaarts met 'n voertuig ry as die punt wat deur 'n kennisgewingsbord aangedui is nie;"
4. Subregulasie (i) van regulasie 29, Hoofstuk 2, word hierby gewysig deur die woord „onmiddellik" tussen die woorde „dit" en „minstens", waar hulle in die tweede reël voorkom, in te voeg;
5. Die volgende subregulasies word hierby na subregulasie (r) van regulasie 29, Hoofstuk 2, ingevoeg:—
 „(s) 'n bottel breek, of toelaat of veroorsaak dat dit breek nie, op plekke waar voertuie ry of hengelaars visvang nie;
 (t) hoeke met aas, of aas aan lyne, plaas of uitgooi, of laat waar seevoëls dit kan optel nie, of seevoëls opsetlik met lyn, of hoek en lyn, vang nie;

(u) be in possession of more than one fishing rod per angler, or have more than two hooks to one line;

(v) catch fish in the lagoon at Sandwich Harbour."

6. The following regulation is hereby inserted after regulation 30:

"30A. Permits of admission shall be in the holders' possession whenever they are in the area known as Sandwich Harbour, and shall be produced when requested to do so by an officer."
