ORDINANCE

To amend the Finance and Audit Amendment Ordinance 1969, so as to provide that the said Ordinance shall be deemed to have come into operation with retrospective effect.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:—

Substitution of
section 12 of
Ordinance 28
of 1969.

1. The following section is hereby substituted for section 12 of the Finance and Audit Amendment Ordinance 1969, (Ordinance 28 of 1969):

"Short title
and commence-
ment.

12. This Ordinance shall be called the Finance and Audit Amendment Ordinance, 1969, and shall be deemed to have come into operation on the first day of April, 1969.".
