ORDINANCE

To amend the Reservation of State Land for Natives Ordinance, 1967, to provide for the setting apart and reservation of further state land for the use and occupation of Natives.

*(Assented to 22 July, 1971)
(Afrikaans text signed by the Administrator)*

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, with the consent of the State President previously obtained and communicated to the Assembly by message from the Administrator as follows:-

1. The Schedule to the Reservation of State Land for Natives Ordinance, 1967, (Ordinance 35 of 1967) is hereby amended —
