### REGULASIES VIR DIE HAWENS VAN DIE REPUBLIEK VAN SUID-AFRIKA EN VAN SUID- WES-AFRIKA

Dit het die Staatspresident behaag om kragtens artikel 3 van die Konsolidasiewet op die Beheer en Bestuur van Spoerweë en Hawens, 1957 (Wet 70 van 1957), goedkeuring te verleen aan die volgende wysigings van Regulasie 168, Deel A, van die Regulasies vir die Hawens van die Republiek van Suid-Afrika en van Suidwes-Afrika, afgekondig by Goewermentskennisgiving R. 290 van 2 Maart 1962:

#### Paragraaf (18)

Deur in subparagraph (1) die woorde "Alle buigsame slange wat vir die hanteer van skeepsvrag en vir bunkerwerk gebruik word, kan van of die elektriese geleitipte of die nie-geleitipte wees maar moet aan die vereistes aangedui in paragraaf (29) voldoen. Die nie-geleitipte slang moet wit geverf wees. Die slange moet soos volg getoets word:" deur die woorde "Alle buigsame slange wat vir die hanteer van skeepsvrag en vir bunkerwerk, behalwe soos in subparagraph (29) (c) bepaal, gebruik word, moet van die elektriese geleitipte wees en alle metaalpantsering moet deurlopend en behoorlik aan die flense van elke gedeelte verbind wees. Hierdie buigsame slange moet aangebring word soos in paragraaf (29) hiervan aangedui is, Die buigsame slange moet soos volg getoets word:" te vervang, en deur subparagraph (c) deur die volgende subparagraph te vervang:

"(c) Wanneer die eerste keer aangebring, en gereeld daarna, moet die slange deur die gebruiker getoets word om seker te maak dat hulle van die elektriese geleitipte is. Die Administrasie kan, te eniger tyd, gelas dat elektriese kontinuiteitstoete onderneem word om vas te stel dat die buigsame slange elektries gelei."

#### Paragraaf (29)

Deur hierdie paragraaf deur die volgende paragraaf te vervang:

"(29) Ten einde teen die gevare van elektriese swerstrome gedurende vragantering en bunkerwerk te waak, moet op 'n doeltreffende wyse te werk gegaan word om die vloei van sulke strome in lossingspypkleidings te voorkom deur een van die volgende drie vorms van isolering toe te pas:

(a) Twee geïsoleerde lasse in elke aaneenlopende stuk vaste pypwerk. Dié lasse moet ten minste twee meter van mekaar wees.

(b) Een geïsoleerde las in elke aaneenlopende stuk pypwerk. Dié (enkele) las moet voldoende beskerm wees en aan die buitekant vir 'n lengte van ten minste twee meter geïsoleer wees om onopsetlike oorbrugging van die las se flense deur metaalkontak te voorkom.

(c) 'n Enkele stuk elektriese buigsame nie-geleislang van ten minste twee meter in lengte en sonder tussenmetaallanse, moet in die buigsame slang van die skip na die wal ingevoeg word. Dié gedeelte van die nie-geleislang moet dikwels deur die gebruiker getoets word om die isoleringsvermoë daarvan te bewys. Dit moet wit geverf word en nougeset so gehou word om verwarring met die elektriese geleitipte gedeeltes van die buigsame slang te voorkom."

#### Paragraaf (30) (a)

Deur subparagraph (i) te skrap en die oorblywende subparagraphe (ii), (iii) en (iv) te hernommer.

### REGULATIONS FOR THE HARBOURS OF THE REPUBLIC OF SOUTH AFRICA AND OF SOUTH- WEST AFRICA

The State President has been pleased in terms of section 3 of the Railways and Harbours Control and Management (Consolidation) Act, 1957 (Act 70 of 1957), to approve of the following amendments to Regulation 168, Part A, of the Regulations for the Harbours of the Republic of South Africa and of South-West Africa, published under Government Notice R. 290 of 2 March 1962:

#### Paragraph (18)

By the substitution in subparagraph (1) for the words "All flexible hoses used in cargo handling and bunkering operations may be either of the electrical conducting or non-conducting type but shall comply with the requirements indicated in paragraph (29). The non-conducting type of hose shall be painted white. The hoses shall be tested as follows:", of the words "All flexible hoses used in cargo-handling and bunkering operations, except as provided for in subparagraph (29) (c), shall be of the electrically conducting type and shall have all metallic armouring continuous and securely bonded to the flanges of each section. These flexible hoses shall be installed as indicated in paragraph (29) hereof. The flexible hoses shall be tested as follows:", and by the substitution for subparagraph (c) of the following subparagraph:

"(c) On first installation, and regularly thereafter, the hoses shall be tested by the user to ensure that they are of the electrically conducting type. The Administration may, at any time, require that electrical continuity tests be undertaken to confirm that the flexible hoses are electrically conducting."

#### Paragraph (29)

By the substitution for this paragraph of the following paragraph:

"(29) To guard against the dangers of stray electric currents during cargo-handling and bunkering operations, an effective means of preventing the flow of such currents in discharge pipelines shall be provided by means of one of the following three forms of insulation:

(a) Two insulated joints in each continuous length of fixed pipework. These insulated joints shall be separated by not less than two metres of pipe.

(b) One insulated joint in each continuous length of pipework. This (single) insulated joint shall be adequately protected and insulated externally for a length of not less than two metres, to prevent inadvertent metallic contact across the flanges of the joint.

(c) A single length of electrically non-conducting flexible hose, not less than two metres in length and without any intermediate metallic flanges, inserted in the ship-to-shore flexible hose. This section of non-conducting hose shall be tested frequently, by the user, to confirm its insulating properties. It shall be painted white, which colour shall be maintained carefully, to avoid confusion with electrically conducting type sections of the flexible hose."

#### Paragraph (30) (a)

By deleting subparagraph (i) and renumbering the remaining paragraphs (i), (ii), (iii) and (iv).

**1. Regulasie 7 (3)**

Vervang die woorde "een-sesde (1/6)" deur die woorde "n twaalfde (1/12)".

**2. Regulasie 9 (1) (b) (i)**

Vervang die bestaande subparagraph deur die volgende subparagraph:

"(i) dat die voorgeskrewe opleidingstydperk (insluitende enige opleidingstydperk wat ingewerk moet word) teen die einde van die tweede maand wat volg op die maand waarin die eksamen afgeneem word, voltooi sal word;".

**3. Regulasie 11 (2)**

Vervang die bestaande paragraaf deur die volgende paragraaf:

"(2) Die eksamen word drie keer per jaar in die maande Januarie, Mei en September afgeneem en aansoek om toelating of hertoelating moet op of voor 7 Oktober, 7 Februarie en 7 Junie by die raad ingedien word."

**AMENDMENT OF THE REGULATIONS FOR THE COURSE FOR THE CERTIFICATE FOR ENROLMENT AS AN AUXILIARY NURSE**

The minister of Health, in terms of section 11 (1) of the Nursing Act (Act 69 of 1957), has approved the following amendments to the regulations for the course for the certificate for enrolment as an auxiliary nurse, made by the South African Nursing Council and published under Government Notice R. 45 of 9 January 1970:

**1. Regulation 7 (3)**

For the words "one sixth (1/6)" substitute the words "a twelfth (1/12)".

**2. Regulation 9 (1) (b) (i)**

For the existing subparagraph, substitute the following subparagraph:

"(i) that the prescribed period of training (including any period of training which has to be made up) will be completed by the end of the second month following the month in which the examination is held;".

**3. Regulation 11 (2)**

For the existing paragraph, substitute the following paragraph:

"(2) The examination shall be held three times a year during the months January, May and September and applications for admission and re-admission shall be lodged with the council on or before 7 October, 7 February and 7 June."

4. The amendments under paragraphs 2 and 3 shall come into operation in respect of examinations conducted after 31 December 1971.

5. These amendments shall also apply in the territory of South-West Africa.

## 1. Regulasie 1

(a) *Paragraaf (1).*—Vervang die woorde "Algemene Verpleegster: Dof kersrooi" deur die woorde "Algemene Verpleegster/Verpleër: Dof kersrooi" en skrap die woorde "Algemene Verpleër: Bruin".

(b) *Paragraaf (3).*—Vervang die bestaande paragraaf deur die volgende paragraaf:

"(3) Waar 'n persoon in twee of meer vertakkings van verpleging geregistreer is, of as 'n vroedvrou en in een of meer vertakkings van verpleging geregistreer is en waar—

(d) so 'n persoon nie as 'n algemene verpleegster/verpleër, of as 'n psigiatrisee verpleegster/verpleër, of as 'n verpleegster/verpleër vir sielsiektes geregistreer is nie, maar onder ander as 'n verpleegster/verpleër vir swaksinniges geregistreer is, word lige saksieblou epaulette gedra;

(e) so 'n persoon nie as 'n algemene verpleegster/verpleër, of as 'n psigiatrisee verpleegster/verpleër, of as 'n verpleegster/verpleër vir sielsiektes, of as 'n verpleegster/verpleër vir swaksinniges geregistreer is nie, maar onder ander as 'n verpleegster vir siek kinders geregistreer is, word ligpers epaulette gedra;

(f) so 'n persoon nie as 'n algemene verpleegster/verpleër, of as 'n psigiatrisee verpleegster/verpleër, of as 'n verpleegster/verpleër vir sielsiektes, of as 'n verpleegster/verpleër vir swaksinniges, of as 'n verpleegster vir siek kinders geregistreer is nie, maar onder ander as 'n koorsverpleegster geregistreer is, word geel epaulette gedra".

Skrap.

4. Hierdie wysigings tree in werking ses (6) maande na die datum van publikasie.

## THE SOUTH AFRICAN NURSING COUNCIL

AMENDMENT OF THE REGULATIONS REGARDING THE DISTINGUISHING DEVICES AND UNIFORMS FOR REGISTERED NURSES AND MIDWIVES AND REGISTERED STUDENT NURSES AND STUDENT MIDWIVES

The Minister of Health, in terms of section 11 (1) of the Nursing Act (Act 69 of 1957), has approved the following amendments to the regulations regarding distinguishing devices and uniforms for registered nurses and midwives and registered student nurses and student midwives, made by the South African Nursing Council and published under Government Notice R. 1201 of 31 July 1970:

## 1. Regulation 1

For the words "regulations 4 and 7" substitute the words "regulation 7".

## 2. Regulation 3

(a) *Paragraph (1).*—Delete the words "General nurse (male): Brown".

(b) *Paragraph (3).*—For the existing paragraph, substitute the following paragraph:

"(3) Where a person is registered in two or more branches of nursing or as a midwife and in one or more branches of nursing, and where—

(a) such person is, *inter alia*, registered as a general nurse, dull cherry epaulettes shall be worn;

(b) such person is not registered as a general nurse, but is, *inter alia*, registered as a psychiatric nurse, navy blue epaulettes shall be worn;

(c) such person is not registered as a general nurse, or as a psychiatric nurse, but is, *inter alia*, registered as a mental nurse, dark saxe blue epaulettes shall be worn;

(d) such person is not registered as a general nurse, or as a psychiatric nurse, or as a mental nurse, but is, *inter alia*, registered as a nurse for mental defectives, light saxe blue epaulettes shall be worn;

(e) such person is not registered as a general nurse, or as a psychiatric nurse, or as a mental nurse, or as a nurse for mental defectives, but is, *inter alia*, registered as a sick children's nurse, mauve epaulettes shall be worn;

(f) such person is not registered as a general nurse, or as a psychiatric nurse, or as a mental nurse, or as a nurse for mental defectives, or as a sick children's nurse, but is, *inter alia*, registered as a fever nurse, yellow epaulettes shall be worn".

## 3. Regulation 4

Delete.

4. These amendments shall come into operation six (6) months after the date of publication.

5. These amendments shall also apply in the Territory of South-West Africa.

## 2. Regulasie 7

## 1. Regulasie 6

(a) *Paragraaf (2).*—Vervang die bestaande paragraaf deur die volgende paragraaf:

"(2) Die kliniese onderrig en praktika in die sale en afdelings moet minstens insluit (die tydperke hoef nie aaneenlopend te wees nie)—

- (a) mediese verpleging: Vier (4) maande;
- (b) chirurgiese verpleging: Vier (4) maande;
- (c) ongevalle en buitepasiënte: Een (1) maand;
- (d) operasiesaal: Twee (2) maande;

## AMENDMENT OF THE REGULATIONS FOR THE COURSE FOR THE DIPLOMA FOR REGISTRATION AS A MIDWIFE

The Minister of Health, in terms of section 11 (1) of the Nursing Act (Act 69 of 1957), has approved of the following amendments to the regulations for the course for the diploma for registration as a midwife made by the South African Nursing Council and published under Government Notice R. 84 of 16 January 1970:

## 1. Regulation 6 (4)

For the existing paragraph, substitute the following paragraph:

"(4) A student shall receive clinical instruction, including practica in the wards and departments in delivering and nursing patients at night, for at least a twelfth ( $\frac{1}{12}$ ) and for not more than a quarter ( $\frac{1}{4}$ ) of the prescribed period for the course. Periods of instruction at night need not be continuous."

## 2. Regulation 7

Insert the following paragraph after paragraph (3):

"(3A) A student who is an enrolled auxiliary nurse may be admitted to the preliminary examination after completion of at least six (6) months of the course."

## 3. Regulation 11

(a) *Paragraph (2).*—For the words "7 January, 7 May and 7 September" substitute the words "7 December, 7 April and 7 August".

(b) *Paragraph (3).*—For the words "7 December, 7 April and 7 August" substitute the words "7 November, 7 March and 7 July".

4. The amendments under paragraph 3 shall come into operation in respect of examinations conducted after 31 December 1971.

5. These amendments shall also apply in the Territory of South-West Africa.

## THE SOUTH AFRICAN NURSING COUNCIL

## AMENDMENT OF THE REGULATIONS FOR THE COURSE FOR THE DIPLOMA FOR REGISTRATION AS A GENERAL NURSE AND MIDWIFE

The Minister of Health, in terms of section 11 (1) of the Nursing Act (Act 69 of 1957), has approved the following amendments to the regulations for the course for the diploma for registration as a general nurse and midwife, made by the South African Nursing Council and published under Government Notice R. 3793 of 28 November 1969:

## 1. Regulation 6

(a) *Paragraph (2).*—For the existing paragraph, substitute the following paragraph:

"(2) The clinical instruction and practica in the wards and departments shall include at least (the periods need not be continuous)—

- (a) medical nursing: Four (4) months;
- (b) surgical nursing: Four (4) months;
- (c) casualties and out-patients: One (1) month;
- (d) operating theatre: Two (2) months;

## (e) pediatriese verpleging (medies en chirurgies):

Drie (3) maande;

(vi) five (5) rectal examinations by the student personally. The findings shall be checked by a medical practitioner or a midwife;

(vii) nursing of thirty (30) lying-in women and thirty (30) infants for at least seven (7) days after the delivery."

## THE SOUTH AFRICAN NURSING COUNCIL

### AMENDMENT OF THE REGULATIONS FOR THE COURSE FOR THE DIPLOMA IN PSYCHIATRIC NURSING

The Minister of Health, in terms of section 11 (1) of the Nursing Act (Act 69 of 1957), has approved the following amendments to the regulations for the course for the diploma in psychiatric nursing made by the South African Nursing Council and published under Government Notice R. 8 of 2 January 1970:

#### 1. Regulation 6 (4) (a)

For the existing subparagraph, substitute the following subparagraph:

“(a) A student shall receive clinical instruction, including practica in the wards and departments in the care of patients at night, for at least a twelfth ( $\frac{1}{12}$ ) and for not more than a quarter ( $\frac{1}{4}$ ) of the prescribed period for the course.”.

#### 2. Regulation 7

Insert the following paragraph after paragraph (8):

“(8A) A student who is an enrolled auxiliary nurse may be admitted to the preliminary examination after completion of at least six (6) months of the course.”.

#### 3. Regulation 11 (2) and (3)

For the words “7 January, 7 May and 7 September” substitute the words “7 December, 7 April and 7 August”.

4. The amendments under paragraph 3 shall come into operation in respect of examinations conducted after 31 December 1971.

5. These amendments shall also apply in the territory of South-West Africa.
