ORDINANCE, 1973: PROMULGATION OF

ORDONNANSIE 1973: UITVAARDIGING VAN

The Administrator has been pleased to assent, in terms of section 27 of the South West Africa Constitution Act, 1968 (Act 39 of 1968) to the following Ordinance which is hereby published for general information in terms of section 29 of the said Act.

ADDITIONAL APPROPRIATION ORDINANCE, 1973

(Assented to 27 February 1973).
(Afrikaans text signed by the Administrator).
(Date of Commencement 28 February 1973).

ORDINANCE

To apply a further sum not exceeding one million seven hundred and eighty-eight thousand five hundred and fifteen rand towards the service of the Territory of South West Africa for the financial year ending on the thirty-first day of March, 1973.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, with the consent of the State President previously obtained and communicated to the Assembly by message from the Administrator, as follows:—

Territory Revenue Fund charged with R1 788 515 on Revenue Account.

1. The Territory Revenue Fund is hereby charged with the sum of one million seven hundred and eighty-eight thousand five hundred and fifteen rand on Revenue Account as shown in the Schedule to meet certain expenditure over and above the amounts appropriated for the service of the financial year ending on the 31st March, 1973, as specified in Ordinance 8 of 1972.

Application of money.

2. The money appropriated by this Ordinance shall be applied to the services detailed in the Schedule to this Ordinance and more particularly specified in the Additional Estimates of Expenditure (S.W.A. 2-1973) as approved by the Legislative Assembly, and to no other purpose.

With approval of Administrator-in-Executive Committee savings may be made available to meet expenses.

3. With the approval of the Administrator-in-Executive Committee, a saving on any sub-head of a Vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head of the same Vote: Provided that the sums appearing in column 2 of the Schedule to Ordinance 8 of 1972 shall not be exceeded, nor shall savings thereon be available for any purpose other than that for which the money was granted as indicated in the said Schedule.

Short title.

4. This Ordinance shall be called the Additional Appropriation Ordinance, 1973.
