APPOINTMENT OF DELIMITATION COMMISSION

AANSTELLING VAN AFBAKENINGSKOMMISSIE

The State President has, in terms of section 10 of the South West Africa Constitution Act, 1968 (Act 39 of 1968), appointed the Honourable Petrus Malan Cillie, Judge President of the Transvaal Provincial Division of the Supreme Court of South Africa, the Honourable Frans Hendrik Badenhorst, Judge President of the South West Africa Division of the Supreme court of South Africa and the Honourable Rudolf Philip Botha Erasmus, Judge of the Orange Free State Provincial Division of the Supreme Court of South Africa with effect from the 2nd July, 1973 as a Delimitation Commission to undertake the delimitation of the territory of South West Africa into electoral divisions in terms of section 10 of the said Act.

Die Staatspresident het kragtens artikel 10 van die Wet op die Konstitusie van Suidwes-Afrika, 1968 (Wet 39 van 1968), die Edelagbare Petrus Malan Cillie, regter-president van die Transvaalse Provinsiale Afdeling van die Hooggeregshof van Suid-Afrika, die Edelagbare Frans Hendrik Badenhorst, regter-president van die Suidwes-Afrika-afdeling van die Hooggeregshof van Suid-Afrika, en die Edelagbare Rudolf Philip Botha Erasmus, regter van die Oranje-Vrystaatse Provinsiale Afdeling van die Hooggeregshof van Suid-Afrika, met ingang van 2 Julie 1973 aangestel as 'n afbakeningskommissie om kragtens artikel 10 van genoemde Wet die afbakening van die gebied Suidwes-Afrika in kiesafdelings te onderneem.

The Honourable Petrus Malan Cillie has been designated Chairman of the said Commission.

Die Edelagbare Petrus Malan Cillie is as voorsitter van gemelde kommissie benoem.

Mr. B. R. Buys, Department of the Interior, has been appointed Secretary of the said Commission.

Mnr. B. R. Buys, Departement van Binnelandse Sake, is as sekretaris van gemelde kommissie aangestel.
