Nademaal die Kommissarisse, benoem ingevolge die bepalings van artikel 10 (1) van die Wet op die Konstitusie van Suidwes-Afrika, 1968 (Wet 39 van 1968), die gebied Suidwes-Afrika in 18 kiesafdelings verdeel het wat elkeen 'n lid van die Wetgewende Vergadering van Suidwes-Afrika kies, en in ses kiesafdelings wat elkeen 'n Volksraadslid kies ingevolge die bepalings van die Wysigingswet op Aangeleenthede van Suidwes-Afrika, 1949 (Wet 23 van 1949);

En nademaal bedoelde Kommissarisse 'n lys van die kiesafdelings waarin hulle die voormelde Gebied verdeel het en ook die naam wat hulle aan elke kiesafdeling gegee het en 'n beskrywing van die grense van elke kiesafdeling aan die Staatspresident, ingevolge artikel 10 (6) van die Wet op die Konstitusie van Suidwes-Afrika, 1968, voorgelê het;

En nademaal daarby artikel 10 (9) van laasgenoemde Wet bepaal word dat die Staatspresident die name en die grense van die kiesafdelings soos finaal voorgestel, in die *Staatskoerant* en in die *Offisiële Koerant* van die Gebied Suidwes-Afrika moet bekend maak;

So is dit dat ek, kragtens die bevoegdheid my verleen soos voormeld, hierby verklaar dat die name en grense van die verskillende kiesafdelings, soos finaal deur voormelde Kommissarisse vasgestel en gesertifiseer, dié is wat beskryf word in die Bylae van die verslag van die Kommissarisse wat in hierdie *Staatskoerant* of *Offisiële Koerant*, na gelang van die geval, verskyn.

## PROCLAMATION

by the State President of the Republic of  
South Africa

No. 14, 1974

Whereas the Commissioners appointed under the provisions of section 10 (1) of the South West Africa Constitution Act, 1968 (Act 39 of 1968), have divided the Territory of South-West Africa into 18 electoral divisions each electing one member to the Legislative Assembly of South-West Africa and into six electoral divisions each electing one member to the House of Assembly, as provided by the South West Africa Affairs Amendment Act, 1949 (Act 23 of 1949);

And whereas such Commissioners have, as provided by section 10 (6) of the South West Africa Constitution Act, 1968, submitted to the State President a list of the electoral divisions into which they have divided the said Territory, together with the name given by them to and a description of the boundaries of every such division;

And whereas by section 10 (9) of the last mentioned Act it is provided that the State President shall publish in the *Gazette* and in the *Official Gazette* of the Territory of South-West Africa the names and the boundaries of the electoral divisions as finally settled;

Now, therefore, under and by virtue of the powers and authority vested in me as aforesaid, I do hereby declare that the names and boundaries of the several electoral divisions as finally settled and certified by the Commissioners aforesaid shall be those described in the Schedules to the Report of the Commissioners that appears in this *Gazette* or *Official Gazette*, as the case may be.

## VERSLAG AAN DIE STAATSPRESIDENT

## MAG DIT U BEHAAG:

1. Die ondergetekendes is met ingang 2 Julie 1973, kragtens die bepalings van artikel tien (10) van die "Wet op die Konstitusie van Suidwes-Afrika, No. 39 van 1968" deur U, Meneer die Staatspresident, as 'n Kommissie aangestel om die gebied van Suidwes-Afrika in kiesafdelings te verdeel vir die verkiesing van lede van die Wetgewende Vergadering van genoemde gebied en van lede van die Volksraad van die Republiek van Suid-Afrika.

2. Ingevolge genoemde artikel tien (10) van Wet 39 van 1968, moet U Kommissie die gebied verdeel in 18 kiesafdelings wat elkeen 'n lid van die Wetgewende Vergadering kies en in ses kiesafdelings (bestaande in elke geval uit drie van die voormelde kiesafdelings) wat elkeen 'n lid van die Volksraad van die Republiek van Suid-Afrika kies, die verdeling sodanig te wees dat daar sover moontlik 'n gelyke aantal kiesers (genoem die kwota) in elke kiesafdeling is. U Kommissie moet daarby rekening hou met die gemeenskap of verskil van belange, die verkeersmiddele, natuurlike kenmerke, en dunheid of digtheid van bevolking met dien verstande dat, hoewel die kwota van kiesers die grondslag van verdeling vorm, U Kommissie nogtans, wanneer dit nodig geag word, daarvan kan afwyk met hoogstens 15 persent bo of 15 persent onder die kwota.

3. Ingevolge artikel agt (8) van die Wet tot Konsolidasie van die Kieswette, Wet 46 van 1946, soos gewysig, het daar gedurende Julie/Augustus 1972 in hierdie Gebied 'n algemene registrasie van kiesers plaasgevind en die kieserslyste ten opsigte van die jongste aanvullende registrasie het op 1 Mei 1973 in werking getree. Die kieserslyste is aangesuiwer tot op 31 Mei 1973.

4. U Kommissie het besluit om die getal kiesers wat op 31 Mei 1973 in Suidwes-Afrika geregistreer was, te gebruik as grondslag vir die afbakening van die Gebied. Hierdie besluit is 'n geruime tyd voor U Kommissie se eerste openbare vergadering te Windhoek aan belanghebendes bekend gemaak. Die Streekvertegenwoordiger van die Departement van Binnelandse Sake in Suidwes-Afrika het gesertifiseer dat daar op 31 Mei 1973 ses-en-veertig duisend sewehonderd-en-nege (46 709) kiesers in Suidwes-Afrika geregistreer was. Die kwota vir die Wetgewende Vergadering-kiesafdelings is dus 2 594 en dié vir die Volksraad-kiesafdelings 7 784.

5. By die vorige afbakening in 1965 was die getal geregistreerde kiesers 37 264. Die kwota vir die Wetgewende Vergadering-kiesafdelings was derhalwe 2 070 en die vir die Volksraad-kiesafdelings 6 211. Daar dien dus op gelet te word dat die aantal kiesers in die Gebied aansienlik vermeerder het en dat die kwota, soos reeds aangedui, nou heelwat hoër is.

6. Ten spyte van die aanwas in kieserstal het ses kiesafdelings van die Wetgewende Vergadering meer as 15 persent onder die kwota gedaal en moes hulle dus kiesers bekry. Die kiesafdelings wat meer as 15 persent onder die kwota was, is die volgende:

Lüderitz.....	16,4	persent onder die kwota.
Warmbad.....	29,2	persent onder die kwota.
Maltahöhe.....	18,2	persent onder die kwota.
Stampriet.....	38,5	persent onder die kwota.
Gobabis.....	16,1	persent onder die kwota.
Okahandja.....	18	persent onder die kwota.

7. Die kiesafdelings Tsumeb, Khomas-Hochland en Walvisbaai daarenteen het kieserstalle getoon wat die kwota met meer as 15 persent oorskry. Die posisie in daardie kiesafdelings was soos volg:

Tsumeb.....	28,5	persent bo die kwota.
Khomas-Hochland.....	133,9	persent bo die kwota.
Walvisbaai.....	18,7	persent bo die kwota.

## REPORT TO THE STATE PRESIDENT

## MAY IT PLEASE YOU:

1. Under the provisions of section ten (10) of the South-West Africa Constitution Act, No. 39 of 1968, the undersigned were appointed by you, Mr State President, with effect from 2 July 1973, to be a Commission to divide the Territory of South-West Africa into electoral divisions for the election of members to the Legislative Assembly of the said Territory and of members to the Parliament of the Republic of South Africa.

2. In terms of the said section ten (10) of Act 39 of 1968, Your Commission has to divide the said Territory into 18 electoral divisions, each electing a member to the Legislative Assembly, and into six electoral divisions (consisting in each case of three of the above-mentioned electoral divisions), each electing a member to the Parliament of the Republic of South Africa, the division to be such that there will as far as possible be an equal number of voters (called the quota) in each electoral division. Your Commission, in doing this, has to give consideration to community or diversity of interests, means of communication, physical features, and sparsity or density of population, with the proviso that your Commission, while taking the quota of voters as the basis of division, may nevertheless, when it is deemed necessary, depart from it by not more than 15 per cent above or 15 per cent below the quota.

3. In terms of section eight (8) of the Electoral Consolidation Act, Act 46 of 1946 (as amended), a general registration of voters took place in this Territory during July/August 1972, and the voters' rolls in respect of the latest supplementary registration took effect on 1 May 1973. The voters' rolls were amended up to 31 May 1973.

4. Your Commission decided to use the number of voters registered in South-West Africa on 31 May 1973 as the basis for the delimitation of the Territory. This decision was communicated to interested parties some considerable time before Your Commission's first meeting in Windhoek. The Regional Representative of the Department of the Interior in South-West Africa certified that on 31 May 1973 there were forty-six thousand seven hundred and nine (46 709) voters registered in South-West Africa. The quota for the Legislative Assembly electoral divisions is therefore 2 594 and that for the Parliamentary electoral divisions 7 784.

5. At the previous delimitation in 1965 the number of registered voters was 37 264. The quota for the Legislative Assembly electoral divisions was consequently 2 070 and that for the Parliamentary electoral divisions 6 211. It should therefore be noted that the number of voters in the Territory has increased considerably and that the quota, as already pointed out, is appreciably higher.

6. In spite of the increase in voters, six electoral divisions of the Legislative Assembly showed a drop of more than 15 per cent below quota and had to receive additional voters. The electoral divisions that were more than 15 per cent below quota were the following:

Lüderitz.....	16,4	per cent below quota
Warmbad.....	29,2	per cent below quota
Maltahöhe.....	18,2	per cent below quota
Stampriet.....	38,5	per cent below quota
Gobabis.....	16,1	per cent below quota
Okahandja.....	18	per cent below quota

7. In the electoral divisions of Tsumeb, Khomas-Hochland and Walvis Bay, on the other hand, the number of voters exceeded the quota by more than 15 per cent. The position in those electoral divisions was as follows:

Tsumeb.....	28,5	per cent above quota
Khomas-Hochland.....	133,9	per cent above quota
Walvis Bay.....	18,7	per cent above quota

Voornoemde afname en toename in persentasies onderskeidelik onder en bo die kwota, sowel as die feit dat die aantal geregistreerde kiesers in die stad Windhoek die skepping van 'n vierde suiver stedelike Wetgewende Vergadering-kiesafdeling geregverdig het, het die onvermydelike gevolg gehad dat veranderinge aan bestaande grense aangebring moes word. U Kommissie het egter probeer om die betrokke grense so min as moontlik te verander en die verskuiwing van kiesers tot 'n minimum te beperk.

8. Hoewel die Wet dit nie as 'n vereiste stel nie, het U Kommissie die kiesafdelings se grense waar dit enigszins moontlik was laat ooreenslaan met die grense van landdrosdistrikte omdat dit die administratiewe werk-saamhede in verband met die registrasie van kiesers en die hou van verkiesings vergemaklik.

9. Na behoorlike kennisgewing het U Kommissie op 15 Oktober 1973 te Windhoek 'n openbare vergadering gehou waarop verteenwoordigers van die twee politieke partye in die Gebied en ander belanghebbende persone die geleentheid gegee is om skemas vir die afbakening van die Gebied voor te lê en om voorstelle te doen wat U Kommissie sou kan help in die uitvoering van sy opdrag.

10. In sy taak het U Kommissie die voordeel gehad van die volledige en doeltreffende referate, gesteun deur landkaarte, wat deur verteenwoordigers van die twee politieke partye van die Gebied gelewer is. Die landkaarte, en die redes wat ter toeligting van die onderskeie skemas aangevoer is, was van groot hulp en is deur U Kommissie hoog op prys gestel.

11. Nadat U Kommissie die argumente van die partye aangehoor het, is 'n inspeksiereis per motor onderneem vanaf Windhoek na Walvisbaai. Die reis daarheen het langs die dorpe Okahandja, Karibib, Usakos, die strandoord Hentiesbaai en Swakopmund gegaan. Kaap Kruis is ook besoek en Windhoek self is bestudeer. Die genoemde inspeksiereis per motor het U Kommissie 'n uitnemende geleentheid verskaf om 'n deel van die Gebied se verkeersmiddele, riviere, berge en woestyn-gebied te leer ken.

12. Dit is alom bekend dat boerdery die Gebied se vernaamste bedryf is. Die suidelike deel van die Gebied, dit wil sê die deel wat strek van die Oranjerivier in die suide tot by die lyn wat van wes na oos die grens van Rehoboth aandui, beslaan 'n streek waarin skaapboerdery, naamlik die teel van karakoelskape, die vernaamste bedryf is. In die noorde, dit wil sê die gebied wat van die dorp Okahandja af noord tot by die Etoshapan strek, is beesboerdery die vernaamste bedryf, terwyl in die sentrale deel, met uitsondering van die stad Windhoek, die twee bedrywe (skaapboerdery en beesboerdery) blykbaar gesamentlik beoefen word. Indien Windhoek en die gelokaliseerde nywerhede ten opsigte van diamant, koper, lood en vishuite rekening gelaat word, lewer gemeenskaplike belange dus geen werklike vraagstuk op nie aangesien boerdery die oorheersende belang van die inwoners uitmaak.

13. U Kommissie is daarvan oortuig dat die bestaande netwerk van paaie en spoorweë genoegsaam is om die verskillende dele van die Gebied te verbind. Daar is trouens ook deur niemand beweer dat verkeersmiddele enige probleem skep wat besondere aandag vereis nie behalwe in die geval van 'n paar plase in Stemdistrib 30 waarna later meer in die besonder verwys sal word. Aangesien daar geen standhoudende riviere in Suidwes-Afrika is wat verbinding bemoeilik nie, is daar rekening gehou slegs met die Visrivierafgronde suid van Klein Karas en die paar hoë bergreekse wat in die Gebied voorkom.

The above-mentioned decreases and increases below and above the quota, respectively, together with the fact that the number of registered voters in the City of Windhoek justified the creation of a fourth purely urban Legislative Assembly electoral division, had the inevitable consequence that the existing boundaries had to be changed. Your Commission endeavoured, however, to change the boundaries in question as little as possible and to restrict the movement of voters to a minimum.

8. Although it is not a requirement of the Act, Your Commission made the boundaries of the electoral divisions coincide, wherever possible, with those of magisterial districts, because this facilitates the administrative work connected with the registration of voters and the holding of elections.

9. After due notice, Your Commission held a public meeting in Windhoek on 15 October 1973 at which representatives of the two political parties in the Territory and other interested persons were afforded an opportunity of submitting schemes for the delimitation of the Territory and of putting forward suggestions that might assist Your Commission in carrying out its terms of reference.

10. In the discharge of its task Your Commission had the benefit of the complete and effective statements, supported by maps, submitted by representatives of the two political parties in the Territory. The maps, and the reasons given in explanation of the respective schemes, were of great assistance to and were much appreciated by Your Commission.

11. After Your Commission had heard the arguments of the parties, it undertook a journey of inspection by car from Windhoek to Walvis Bay. The outward journey took in the Towns of Okahandja, Karibib, Usakos, the coastal resort of Henties Bay, and Swakopmund. Cape Cross was also visited, and Windhoek itself was investigated. This journey of inspection by car afforded Your Commission an excellent opportunity to acquaint itself with the means of communication, rivers, mountains, and desert region of part of the Territory.

12. It is common knowledge that farming is the Territory's main industry. The southern part of the Territory, that is, the part extending from the Orange River in the south to the line that runs from west to east and forms the boundary of Rehoboth, covers a region in which sheep farming, namely the breeding of Karakul sheep, is the chief industry. In the north, that is, the area extending northwards from the Town of Okahandja to the Etosha Pan, cattle farming is the principal industry, while in the central part, excluding the City of Windhoek, the two industries (sheep and cattle farming) are apparently combined. If Windhoek and the localised diamond, copper, lead and fishing industries are left out of account, community of interests does therefore constitute no actual problem, because farming is the predominant interest of the inhabitants.

13. Your Commission is satisfied that the existing road and rail network provides adequate communication between the various parts of the Territory. For that matter no one asserted that means of communication constituted any problem deserving special attention except in the case of a few farms in Polling District 20 to which reference in greater detail will be made later. As there are no perennial rivers in South-West Africa that complicate communications, only the Fish River Canyon south of Klein Karas and the small number of high mountain ranges in the Territory were taken into account.

14. U Kommissie het van die standpuntuutgegaan dat wat dunheid en digtheid van bevolking betref, die wetgewer bedoel het dat by die toepassing van die bepalinge van artikel tien (10) van Wet 39 van 1968, dunbevolkte kiesafdelings ontlai en digbevolkte kiesafdelings belai behoort te word. Afgesien daarvan dat U Kommissie die ander faktore wat deur artikel tien (10) van gemelde Wet voorgeskryf word in ag geneem het, is ook aanvaar dat by die skepping van nuwe kiesafdelings of die verandering van die grense van die bestaande kiesafdelings die uitgangspunt steeds behoort te wees dat die afbakening so moet geskied dat verteenwoordigers hulle kiesers ten beste kan verteenwoordig.

15. Die beginsel van 'n gelyke aantal kiesers in elke kiesafdeling is deur U Kommissie aanvaar, maar hy het die groter digtheid van bevolking in die stad Windhoek, Walvisbaai en die sentrale gedeelte van die Gebied laat balanseer deur hierdie gebiede waar nodig te belai en die ander gebiede te ontlai. 'n Mate van moeilikheid word natuurlik geskep deurdat daar dorpe lê in die gebiede waarin oorwegend boerdery beoefen word, maar aangesien hierdie dorpe as "boeredorpe" beskryf kan word, het U Kommissie die bestaan daarvan nie as 'n baie gewichtige faktor beskou by die bepaling van die mate van belading en ontlading nie.

16. Die twee politieke partye het uiteenlopende skemas vir die afbakening van die Gebied aan die hand gedoen. Daar is onder andere voorgestel dat sekere kiesafdelings moet verdwyn, dat ander geskep moet word en dat die name van sekere kiesafdelings verander moet word. U Kommissie het egter na ernstige oorweging tot die gevolgtrekking gekom dat dit nie prakties moontlik is om enige van die voormelde skemas in die geheel te aanvaar nie.

17. Albei partye was dit eens dat vyf Wetgewende Vergadering-kiesafdelings, waarvan vier suiwer stedelike kiesafdelings moet wees, in Windhoek en sy onmiddellike omgewing afgebaken moet word en daarmee gaan U Kommissie akkoord.

18. Op 15 Oktober 1973 het die partye voorgestel dat Stemdistrak 4 van die Wetgewende Vergadering-kiesafdeling Tsumeb, d.i. feitlik die hele Bantoeuisland Ovambo met 602 kiesers, by die kiesafdeling Eronto ingedeel moet word. U Kommissie het egter besluit om daardie kiesers oor te plaas na die Wetgewende Vergadering-kiesafdeling Grootfontein in 'n poging om die Bantoeuislande Ovambo, Kavango, Hereroland-Wes, Hereroland-Oos en Boesmanland saam in een kiesafdeling te groepeer. Die gevolg was ongelukkig dat die Grootfontein-kiesafdeling op dié manier 'n baie groot oppervlakte gekry het en dat kiesers van die landdrosdistrak Grootfontein in die noorde met kiesers van die landdrosdistrak Gobabis in die sentrale deel van die Gebied saamgegroepeer moes word. U Kommissie het ernstige bedenkinge oor die deugdelikheid van hierdie kiesafdeling gehad, maar het nietemin voortgegaan en 'n voorlopige afbakingsplan opgestel.

19. Op Saterdag 20 Oktober 1973, nadat U Kommissie van die inspeksiereis hierbo vermeld teruggekeer het, is die voorlopige afbakingsplan aan die verteenwoordigers van die partye voorgelê en is hulle 'n geleentheid gegee om verdere verhoë aan U Kommissie te rig. Die een party was tevrede met die voorlopige plan, maar die ander party het sekere besware geopper. Laasgenoemde party het onder andere aangevoer dat die kiesafdeling Grootfontein 'n te groot oppervlakte dek en dat dit verkeerd was van U Kommissie om kiesers van die landdrosdistrak Gobabis met kiesers van die landdrosdistrak Grootfontein saam te groepeer. U Kommissie het tot die slotsom geraak dat die beswaar gegrond is en het besluit om die Grootfontein-kiesafdeling en die ander Wetgewende Vergadering-kiesafdelings wat daardeur geraak sou word, opnuut af te baken.

14. Your Commission took the view that by "sparsity and density of population" the Legislator meant that, for the purposes of the provisions of section ten (10) of Act 39 of 1968, sparsely populated electoral divisions should be unloaded and densely populated electoral divisions loaded. Apart from the fact that Your Commission had regard to the other factors prescribed by section ten (10) of the said Act, it also assumed that, in creating new electoral divisions or changing the boundaries of existing electoral divisions, it should always proceed from the standpoint that delimitation should be such that representatives will be able to represent their electorate in the best possible way.

15. Your Commission accepted the principle of an equal number of voters in each electoral division, but it balanced the greater density in population in the City of Windhoek, Walvis Bay, and the central part of the Territory by loading these areas where necessary and unloading the other areas. Naturally, some difficulty arises from the fact that there are towns in the predominantly farming areas, but as these towns may be described as "country towns" Your Commission did not regard their existence as a very important factor in determining the extent of load and unload.

16. The two political parties put forward divergent schemes for the delimitation of the Territory. It was suggested, *inter alia*, that certain electoral divisions should be abolished, that new ones be created, and that the names of certain electoral divisions be changed. But after serious consideration Your Commission came to the conclusion that it was not practicable to accept any of the said schemes in their entirety.

17. Both parties were agreed that five Legislative Assembly electoral divisions, four of which being purely urban electoral divisions, should be delimited in Windhoek and its immediate environs. Your Commission agrees.

18. On 15 October 1973 the parties proposed that Polling District 4 in the Tsumeb Legislative Assembly electoral division, i.e. almost the entire Ovambo Bantu Homeland with 602 voters, be incorporated in the Erongo electoral division. But Your Commission decided to transfer those voters to the Grootfontein Legislative Assembly electoral division in an endeavour to group the Bantu Homelands of Ovambo, Kavango, Hereroland West, Hereroland East, and Bushmanland together in one electoral division. Unfortunately the result of this was that the Grootfontein electoral division was given a very large area and that voters in the Grootfontein Magisterial District in the north had to be grouped with voters in the Magisterial District of Gobabis in the central part of the Territory. Your Commission had serious misgivings about the feasibility of this electoral division, but nonetheless proceeded with the preparation of a provisional delimitation plan.

19. On Saturday, 20 October 1973, after Your Commission had returned from the afore-mentioned journey of inspection, the provisional delimitation plan was submitted to the representatives of the parties, who were afforded an opportunity of making further representations to Your Commission. One of the parties was satisfied with the provisional plan, but the other party raised certain objections. The latter party contended, *inter alia*, that the Grootfontein electoral division covered too large an area, and that Your Commission had erred in grouping voters from the Gobabis Magisterial District with voters from the Grootfontein Magisterial District. Your Commission came to the conclusion that the objection was valid and decided upon a new delimitation of the Grootfontein electoral division and of the other Legislative Assembly electoral divisions that would be affected.

20. U Kommissie behandel vervolgens die afsonderlike kiesafdelings soos hulle finaal afgebaken is.

21. Die kieserstal van die Wetgewende Vergadering-kiesafdeling Lüderitz was met die vorige afbakening 2 083, 'n belading van 0,6 persent. Hierdie kiesafdeling het op 31 Mei 1973, waarna later in hierdie verslag verwyd sal word as die vasgestelde datum, 2 169 geregistreerde kiesers gehad en dit was dus nodig om die getal aan te vul. U Kommissie het dit gerade geag om gedeeltes van Stemdistrikte 51 en 52 met onderskeidelik 32 en 13 kiesers in die Wetgewende Vergadering-kiesafdeling Keetmanshoop by die kieserstal van Lüderitz te voeg. U Kommissie het ook besluit om gedeeltes van Stemdistrikt 56 met 0 kiesers in die kiesafdeling Lüderitz by die kiesafdeling Walvisbaai en Khomas-Hochland onderskeidelik te voeg met die gevolg dat die noordelike grens van die kiesafdeling Lüderitz waar dit oor die Namibwoestyn gaan asook die oostelike grens nou met die Lüderitz-landdrostrikgrens ooreenslaan. Lüderitz het nou 2 214 kiesers, 'n ontlading van 14,7 persent. Weens die feit dat hierdie kiesafdeling feitlik bestaan uit die myndorpie Rosh Pinah en die twee dorpe Oranjemund en Lüderitz, wat ongeveer 256 kilometer van mekaar geleë is, en 'n aantal verspreide kiesers elders in die kiesafdeling, is 'n ontlading van 14,7 persent geregverdig.

22 (a) Aangaande die afbakening van die Wetgewende Vergadering-kiesafdelings Keetmanshoop en Warmbad het die een party aangevoer dat alhoewel 'n hoë ontlading in die dunbewoonde suidelike deel van die Gebied geregverdig is, dit nogtans tot gevolg sal hê dat Warmbad 'n nog groter oppervlakte sal dek as wat tans die geval is, iets wat U Kommissie behoort te vermy. As alternatief is voorgestel dat die dorp Keetmanshoop langs Kaiserstraat van wes na oos verdeel moet word, dat twee nuwe kiesafdelings elk waarvan 'n deel van die dorp Keetmanshoop se kiesers sal hê, geskep moet word en dat die kiesafdelings Keetmanshoop en Warmbad moet verdwyn. Op hierdie manier so is geargumenteer, sal die oppervlakte van die mees suidelike Wetgewende Vergadering-kiesafdeling in die Gebied aansienlik beperk kan word. Die ander party het hierdie voorstel teengestaan. U Kommissie is van mening dat 'n dorp se kiesers nie verdeel behoort te word indien daar 'n aanneemlike alternatief is nie. Die feit dat 'n kiesafdeling oor 'n groot oppervlakte strek is iets wat nie vreemd is in hierdie Gebied nie en maak op sigself 'n kiesafdeling nie onaanvaarbaar nie. U Kommissie het derhalwe besluit om nie aan die versoek te voldoen om die dorp Keetmanshoop se kiesers te verdeel nie.

(b) Op die vasgestelde datum het die Wetgewende Vergadering-kiesafdeling Keetmanshoop 'n geregistreerde kieserstal van 2 239 gehad. Soos hierbo gemeld, moes hierdie kiesafdeling gedeeltes van Stemdistrikte 51 en 52 met 32 en 13 kiesers onderskeidelik aan die kiesafdeling Lüderitz afstaan. Dit was ook nodig om die bestaande kieserstal van die kiesafdeling Warmbad waar daar sedert die vorige afbakening 'n afname in die kieserstal was, aan te vul en U Kommissie het dit gerade geag om die deel van Stemdistrikt 62, suid van en insluitende die plase Neckartal 1, Coenbalt 158, Gobas 134, Hariros 133, Hainabis 132, Ditsem 156, Eisenstein 136, Gareb 137 en Stampriet met 82 kiesers wat aan die kiesafdeling Warmbad grens na laasgenoemde kiesafdeling oor te plaas, wat veroorsaak het dat daar slegs 2 112 kiesers, d.w.s. meer as 15 persent onder die kwota, in die Keetmanshoop-kiesafdeling oorgebly het. Laasgenoemde getal kiesers is toe aangevul met 141 kiesers uit Stemdistrikt 50 van die Wetgewende Vergadering-kiesafdeling Stampriet. Die kieserstal

20. Your Commission will now proceed to deal with the separate electoral divisions as finally delimited.

21. At the previous delimitation the Legislative Assembly electoral division of Lüderitz had 2 083 voters, a load of 0,6 per cent. On 31 May 1973, hereinafter referred to as the fixed date, this electoral division had 2 169 registered voters, and it was consequently necessary to re-inforce this number. Your Commission deemed it advisable to add 32 and 13 voters from parts of Polling Districts 51 and 52, respectively, in the Legislative Assembly electoral division of Keetmanshoop to the number of voters in Lüderitz. Your Commission also decided to add parts of Polling District 56 with 0 voters in the Lüderitz electoral division to the electoral division of Walvis Bay and to that of Khomas-Hochland, the result being that the northern boundary of the Lüderitz electoral division, where it passes over the Namib Desert, and its eastern boundary, now coincide with the boundaries of the Lüderitz Magisterial District. Lüderitz now has 2 214 voters, an unload of 14,7 per cent. The fact that this electoral division consists almost entirely of the Rosh Pinah mining village, the two towns of Lüderitz and Oranjemund, which are some 256 kilometres apart, and a number of scattered voters elsewhere in the electoral division, is justification for an unload of 14,7 per cent.

22. (a) In regard to the delimitation of the Legislative Assembly electoral divisions of Keetmanshoop and Warmbad one of the parties submitted that, although a considerable unloading in the sparsely populated southern part of the Territory was justified, it would result in Warmbad's having an even greater area than at present, something that Your Commission should avoid. As an alternative it was proposed that the Town of Keetmanshoop should be divided from west to east along Kaiser Street, that two new electoral divisions, each of which would have a part of the voters of the Town of Keetmanshoop, should be created, and that the electoral divisions of Keetmanshoop and Warmbad should be done away with. In this way, it was argued, it would be possible to effect a considerable reduction in the area of the southernmost Legislative Assembly electoral division in the Territory. The other party opposed this proposal. Your Commission is of the opinion that a town's voters should not be divided if there is an acceptable alternative. An electoral division extending over a large area is something that is not unusual in this Territory and this in itself does not make an electoral division unacceptable. Your Commission therefore decided not to accede to the request to divide the voters of the Town of Keetmanshoop.

(b) On the fixed date the Legislative Assembly electoral division of Keetmanshoop had 2 239 registered voters. As mentioned above, this electoral division had to surrender part of Polling Districts 51 and 52 with 32 and 13 voters respectively, to the electoral division of Lüderitz. It was also necessary to supplement the existing number of voters in the electoral division of Warmbad where, since the previous delimitation, there had been a decrease in the number of voters, and Your Commission deemed it advisable to transfer to this electoral division the part of Polling District 62, south of and including the farms Neckartal 1, Coenbalt 158, Gobas 134, Hariros 133, Hainabis 132, Ditsem 156, Eisenstein 136, Gareb 137 and Stampriet, with its 82 voters on the borders of the electoral division of Warmbad, which in consequence meant that only 2 112 voters, i.e. more than 15 per cent below the quota, remained in the Keetmanshoop electoral division. The latter number

van die Keetmanshoop-kiesafdeling is dus nou 2 253, 'n ontlading van 13,2 persent wat as gepas beskou word. Op 20 Oktober 1973 het een van die partye weer eens versoek dat die dorp Keetmanshoop se kiesers verdeel moet word, maar U Kommissie het na verdere oorweging besluit om nie aan daardie versoek te voldoen nie. Daar is ook beswaar teen gemaak dat die 82 kiesers van Stemdistrrik 62 na die kiesafdeling Warmbad oorgeplaas is, maar ook hierdie beswaar is afgewys.

23. Met die vorige afbakening was die kieserstal van die kiesafdeling Warmbad 1 946, 'n ontlading van 6,0 persent. Op die vasgestelde datum was die aantal geregistreerde kiesers van hierdie kiesafdeling 1 836 en U Kommissie was verplig om hierdie getal kiesers, wat nou meer as 15 persent onder die kwota was, aan te vul. Selfs nadat laasgenoemde getal kiesers aangevul is met die 82 kiesers uit Stemdistrrik 62 in die Keetmanshoop-kiesafdeling was die kieserstal nog meer as 15 persent onder die kwota en moes 'n verdere toevoeging van kiesers tot hierdie kiesafdeling gemaak word. Die enigste aanneemlike moontlikheid wat hom voorgedoen het, was om Stemdistrrikte 65 en 66 met onderskeidelik 123 en 176 kiesers van die kiesafdeling Stampriet by Warmbad in te deel. Hierdie kiesafdeling het nou 2 217 kiesers, 'n ontlading van 14,7 persent wat as gepas beskou word in hierdie uitgestrekte kiesafdeling met sy yl-verspreide bevolking. Die uitgestrekte suide met sy relatiewe klein getal kiesers bring mee dat die grense van hierdie Wetgewende Vergadering-kiesafdeling noodgedwonge aan die oostekant verder noord verskuif moes word.

24. Op die vasgestelde datum was die getal kiesers wat in die Wetgewende Vergadering-kiesafdeling Stampriet geregistreer was 1 596. Dit beteken dat die geregistreerde kiesers in hierdie kiesafdeling sedert die laaste afbakening met 346 verminder het. Soos reeds hierbo aangedui, was U Kommissie verplig om die 299 kiesers in die Stemdistrrikte 65 en 66 van Stampriet suidwaarts te verskuif om Warmbad se kieserstal aan te vul en Stemdistrrik 50 met 141 kiesers na Keetmanshoop oor te plaas. Daar is voorgestel dat Stampriet moes verdwyn maar U Kommissie het na ernstige oorweging besluit dat die kiesafdeling Stampriet behou moet word en het toe die oorblywende getal kiesers in hierdie kiesafdeling aangevul met Stemdistrrikte 53 en 85 van die kiesafdeling Maltahöhe met onderskeidelik 1 120 en 109 kiesers. Die Wetgewende Vergadering-kiesafdeling Stampriet het nou 2 385 kiesers, 'n ontlading van 8,0 persent.

25. Op die vasgestelde datum het die kiesafdeling Windhoek-Oos 2 330 kiesers gehad en U Kommissie was van mening dat hierdie digbevolkte kiesafdeling kiesers moet bykry. Aangesien die toevoeging van Blokke 13, 14 en 98 van Stemdistrrik 39 van die Windhoek-Suid- tot die Windhoek-Oos-kiesafdeling die minste grensverandering sou veroorsaak, is besluit om die 522 kiesers van genoemde blokke daarheen oor te plaas. So het die kieserstal van hierdie kiesafdeling op 2 882 te staan gekom, 'n belading van 11,0 persent, wat vir hierdie digbevolkte kiesafdeling as gepas beskou word.

26. Op die vasgestelde datum was Windhoek-Wes se kieserstal 2 774. Dit is ook 'n digbevolkte kiesafdeling en U Kommissie was van mening dat dit nog kiesers behoort by te kry. Gevolglik is Blok 25 van Stemdistrrik 39 en Blok 64 van Stemdistrrik 35 met onderskeidelik 74 en 60 kiesers na Windhoek-Wes oorgeplaas. Die grensverandering wat as gevolg hiervan plaasgevind het, is gering. Hierdie kiesafdeling se kieserstal is dus nou 2 908, 'n belading van 12,0 persent.

of voters was then supplemented by 141 voters from Polling District 50 on the Legislative Assembly electoral division of Stampriet. The number of voters in the electoral division of Keetmanshoop is now therefore 2 253, an unload of 13,2 per cent which is regarded as suitable. On 20 October 1973 one of the parties again requested that the voters of the Town of Keetmanshoop be divided, but Your Commission, after further consideration, decided not to comply with that request. Objection was also made to the transfer of 82 voters from Polling District 62 to the electoral division of Warmbad, but this objection was also rejected.

23. In the previous delimitation the number of voters in the electoral division of Warmbad was 1 946, an unload of 6,0 per cent. On the fixed date the number of registered voters in this electoral division was 1 836 and your Commission was obliged to supplement this number of voters, which was now more than 15 per cent below quota. Even after this number of voters was re-inforced with the 82 voters from Polling District 62 in the electoral division of Keetmanshoop, the tally of voters was still more than 15 per cent below quota and a further addition of voters had to be made to this constituency. The only acceptable possibility that presented itself was to incorporate Polling Districts 65 and 66 with 123 and 176 voters, respectively, of the electoral division of Stampriet in Warmbad. This electoral division now has 2 217 voters, an unload of 14,7 per cent which is regarded as suitable in this extensive electoral division with its sparsely distributed population. The vastness of the south with its relatively small number of voters necessarily entails that the boundaries of this Legislative Assembly electoral division be shifted further north on the eastern side.

24. On the fixed date the number of voters registered in the Legislative Assembly electoral division of Stampriet was 1 596. This means that since the last delimitation the number of registered voters in this constituency has decreased by 346. As already indicated above, your Commission was obliged to shift the 299 voters in Polling Districts 65 and 66 of Stampriet southwards to supplement the number of voters in Warmbad and to transfer Polling District 50 with 141 voters to Keetmanshoop. It was proposed that Stampriet disappear, but Your Commission decided after serious consideration that the electoral division of Stampriet be retained and proceeded to supplement the remaining number of voters in this constituency by 1 120 and 109 voters, respectively, from Polling Districts 53 and 85 in the electoral division of Maltahöhe. The Legislative Assembly electoral division of Stampriet now has 2 385 voters, an unload of 8,0 per cent.

25. On the fixed date the constituency of Windhoek East had 2 330 voters, and Your Commission was of the opinion that this densely populated electoral division should receive more voters. Since the addition to Windhoek East of Blocks 13, 14 and 98 of Polling District 39 of the Windhoek South electoral division would entail the least change in boundaries, it was decided to transfer the 522 voters from the said blocks accordingly. Hence the number of voters in this electoral division amounted to 2 882, a load of 11 per cent, which is regarded as suitable for this densely populated electoral division.

26. On the fixed date Windhoek West had 2 774 voters. This is also a densely populated constituency and your Commission was of the opinion that it should gain voters. Consequently Block 25 of Polling District 39 and Block 64 of Polling District 35, with 74 and 60 voters, respectively, were transferred to Windhoek West. The change in boundaries that resulted from this was slight. This constituency now has, therefore, 2 908 voters, a load of 12 per cent.

27. In die kiesafdeling Windhoek-Suid was op die vasgestelde datum 2 208 kiesers geregistreer. Nadat Windhoek-Suid Blokke 13, 14 en 98 van Stemdistrrik 39 met altesaam 552 kiesers aan die kiesafdeling Windhoek-Oos afgestaan het en 74 kiesers in Blok 25 van Stemdistrrik 39 na Windhoek-Wes oorgeplaas is, was die kieserstal van die Windhoek-Suid-kiesafdeling 1 582 en 'n aanvulling was dus noodsaaklik. Om nie onnodige grensveranderinge en verskuiwing van kiesers te veroorsaak nie, het U Kommissie die betrokke getal kiesers aangevul met Blokke 15, 17, 18, 19, 20, 30, 37, 61, 62 en 80 van Stemdistrrik 73 van die kiesafdeling Khomas-Hochland wat aan die suidekant van Windhoek-Suid grens en altesaam 1 317 stedelike kiesers het. Windhoek-Suid het nou 2 899 kiesers, 'n belading van 11,7 persent, wat gepas is vir hierdie suiwer stedelike kiesafdeling.

28. Die Wetgewende Vergadering-kiesafdeling Khomas-Hochland se geregistreerde kieserstal was op die vasgestelde datum 6 066. Hierdie kiesafdeling sluit dié deel van die munisipale gebied Windhoek in wat bekend staan as Pionierspark en Academia, en dit was vir U Kommissie geen moeilike taak om Pionierspark se kiesers en 'n deel van Academia s'n saam te groepeer en 'n nuwe suiwer stedelike Wetgewende Vergadering-kiesafdeling te skep nie. Hierdie kiesafdeling, wat voortaan bekend sal staan as Pionierspark, sal bestaan uit Blokke 75, 76, 77, 78 en 79 van Stemdistrrik 47 met altesaam 748 kiesers en Stemdistrrik 86 met 2 120 kiesers van Khomas-Hochland. Weens die feit dat die grenslyn van noord na suid tussen Stemdistrrikte 73 en 41 in Khomas-Hochland en Klein-Windhoek onderskeidelik deur die tans onbeboude voorstad Olympia gaan, waar daar nog geen kiesers geregistreer is nie, is dit gerade geag om daardie deel van die voorstad Olympia in Stemdistrrik 41 wat ten ooste van gemelde grenslyn val, met 0 kiesers, oor te plaas na Khomas-Hochland. Dit bring die kieserstal van die kiesafdeling Pionierspark te staan op 2 868, 'n belading van 10,5 persent wat U Kommissie as gepas beskou vir so 'n digbewoonde gebied. Hierdie kiesafdeling is swaar belaaï omdat al die dele binne sy grense reeds hoog ontwikkel is.

29. Die kiesafdeling Klein-Windhoek, wat 'n semi-stedelike kiesafdeling is, se geregistreerde kieserstal was op die vasgestelde datum 2 663, 'n belading van 2,7 persent. U Kommissie was van oordeel dat in die geval van hierdie kiesafdeling waarvan die kiesers baie gekonsentreerd is en merendeels saamgetrek is in die deel van Windhoek bekend as Klein-Windhoek, die kieserstal aangevul behoort te word en het dit gerade geag om die gedeelte van Stemdistrrik 35 van die kiesafdeling Khomas-Hochland bestaande uit Brakwater 48 en Nubuamis 37 met 195 kiesers by die kiesafdeling Klein-Windhoek te voeg. Die meerderheid van hierdie 195 kiesers is bewoners van kleinhoewes aan beide kante van die spoorlyn ten noorde van die stad Windhoek en het gemeenskaplike belange met 'n aantal kiesers wat ook op kleinhoewes woon en reeds in die kiesafdeling Klein-Windhoek val. Die gemelde 195 kiesers pas derhalwe beter in by die kiesafdeling Klein-Windhoek as by Khomas-Hochland. Soos reeds aangedui, is die gedeelte van die voorstad Olympia in Stemdistrrik 41 wat ten ooste van die grenslyn van noord na suid tussen Stemdistrrikte 41 en 73 val, met 0 kiesers na Khomas-Hochland oorgeplaas. Klein-Windhoek se kieserstal is dus nou 2 858, 'n belading van 10,1 persent. Die redelike hoë belading in hierdie kompakte kiesafdeling beskou U Kommissie as geregtig.

27. The electoral division of Windhoek South had 2 208 registered voters on the fixed date. After Windhoek South had surrendered Blocks 13, 14 and 98 of Polling District 39, with 552 voters in all, to the electoral division of Windhoek East and 74 voters in Block 25 of Polling District 39 had been transferred to Windhoek West, the number of voters in the Windhoek South electoral division was 1 582, and supplementation was therefore essential. So as not to give rise to unnecessary boundary changes and movement of voters, Your Commission supplemented the number of voters concerned by the addition of Blocks 15, 17, 18, 19, 20, 30, 37, 61, 62 and 80 from Polling District 73 of the electoral division of Khomas-Hochland which lies on the southern border of Windhoek South and has 1 317 urban voters in all. Windhoek South now has 2 899 voters, a load of 11,7 per cent, which is suitable for this purely urban constituency.

28. On the fixed date the number of registered voters in the Legislative Assembly electoral division of Khomas-Hochland was 6 066. This electoral division includes that part of municipal area of Windhoek known as Pionierspark and Academia, and it was no difficult task for Your Commission to group the voters of Pionierspark and part of Academia together and to form a new purely urban Legislative Assembly electoral division. This electoral division, which will henceforth be known as Pionierspark, will consist of Blocks 75, 76, 77, 78 and 79 of Polling District 47, with 748 voters in all, and Polling District 86 with 2 120 voters from Khomas-Hochland. Owing to the fact that the north to south border between Polling Districts 73 and 41 in Khomas-Hochland and Klein Windhoek, respectively, passes through the now undeveloped suburb of Olympia, where no voters have been registered as yet, it was deemed advisable to transfer that part of the suburb of Olympia in Polling District 41 lying to the east of the said boundary, with 0 voters, to Khomas-Hochland. This brings the number of voters in the electoral division of Pionierspark to 2 868, a load of 10,5 per cent which your Commission regards as suitable for so densely populated an area. This constituency is heavily loaded because all the parts within its boundaries are already highly developed.

29. On the fixed date the number of registered voters in the electoral division of Klein Windhoek, which is a semi-urban constituency, was 2 663, a load of 2,7 per cent. Your Commission was of the opinion that, in the case of this electoral division where the voters are very concentrated and clustered mainly in the part of Windhoek known as Klein Windhoek, the number of voters should be supplemented, and it deemed it advisable to add the part of Polling District 35 of the electoral division of Khomas-Hochland, comprising Brakwater 48 and Nubuamis 37, with 195 voters, to the electoral division of Klein Windhoek. The majority of these 195 voters reside on small holdings on both sides of the railway line to the north of the City of Windhoek and have common interests with a number of voters who also live on small holdings and already fall in the electoral division of Klein Windhoek. The said 195 voters therefore fit in better in the constituency of Klein Windhoek than in that of Khomas-Hochland. As already indicated, the part of the suburb of Olympia in Polling District 41 which lies to the east of the border from north to south between Polling Districts 41 and 73, was transferred to Khomas-Hochland with 0 voters. Klein Windhoek therefore now has 2 858 voters, a load of 10,1 per cent. Your Commission regards the relatively high load in this compact electoral division as justified.

30. Nadat die Wetgewende Vergadering-kiesafdeling Khomas-Hochland Blokke 15, 17, 18, 19, 20, 30, 37, 61, 62 en 80 van Stemdistrrik 73 met altesaam 1 317 kiesers aan Windhoek-Suid afgegee het en Blok 64 van Stemdistrrik 35 met 60 kiesers aan Windhoek-Wes sowel as Blokke 75, 76, 77, 78 en 79 van Stemdistrrik 47 en Stemdistrrik 86 met altesaam 2 868 kiesers aan Pionierspark asook daardie gedeelte van Stemdistrrik 35 bestaande uit Brakwater 48 en Nubuamis 37 met 195 kiesers aan Klein-Windhoek, is die 6 066 kiesers wat op die vasgestelde datum in Khomas-Hochland geregistreer was, verminder na 1 626. Laasgenoemde getal kiesers moes dus aangevul word en dit kon slegs uit die aangrensende kiesafdeling Maltahöhe gedoen word. Stemdistrrikke 44, 46, 48 en 84 van die Wetgewende Vergadering-kiesafdeling Maltahöhe met altesaam 893 kiesers is gevolglik daarheen oorgeplaas en Khomas-Hochland se kieserstal is nou 2 519, 'n ontlasting van 2,9 persent. Ongelukkig moes 'n deel van Academia bestaande uit Blok 74 van Stemdistrrik 47 met 147 stedelike kiesers by die kiesafdeling Khomas-Hochland gevoeg word, maar ten gevolge van hierdie afbakingsplan wat deur U Kommissie vir die Gebied as gepas beskou word, was hierdie groepering onvermydelik. Trouens, daar was geen aanneemlike alternatief nie. Khomas-Hochland het ook gedeelte van Stemdistrrik 56 met 0 kiesers van Lüderitz bygekry.

31. Die Wetgewende Vergadering-kiesafdeling Maltahöhe se geregistreerde kieserstal was op die vasgestelde datum 2 122. Soos reeds aangedui, het Maltahöhe 893 kiesers aan Khomas-Hochland afgestaan en 1 229 aan Stampriet en die kiesafdeling Maltahöhe het dus verdwyn.

32. Op die vasgestelde datum was Walvisbaai se getal kiesers 3 080 wat almal gekonsentreer is in die dorp Walvisbaai. Sedert die vorige afbakening het Walvisbaai se kieserstalle sodanig aangegroei dat 'n gedeelte van die dorp se kiesers afgestaan moet word. U Kommissie het dit gerade geag om die 253 kiesers in Blok 4 van Stemdistrrik 36 oor te plaas na die Swakopmund-kiesafdeling. Alhoewel Swakopmund 'n gevestigde administratiewe dorp sowel as 'n vakansie-oord is en Walvisbaai 'n hawe- en fabrieksdorp, is hulle op 'n besondere wyse deur die woestyn afgesonder en het hulle kiesers heelwat gemeenskaplike belange. Die grensverandering in hierdie kiesafdeling is gering. Die verdeling van Walvisbaai is reeds deur die afbakingskommissie in 1965 goedgekeur as gevolg van sy ligging en omgewing en U Kommissie het geen ander keuse gehad as om die verdeling so te laat nie. U Kommissie wil egter onmiddellik daarop wys dat die posisie wat hier ontstaan het, glad nie vergelykbaar is met die voorstel waarmee U Kommissie in Keetmanshoop te doen gehad het nie. In die geval van Keetmanshoop was daar 'n aanneemlike alternatief, wat in die geval van Walvisbaai ontbreek het. Walvisbaai het 'n gedeelte van Stemdistrrik 56 met 0 kiesers van Lüderitz bygekry. Walvisbaai se kieserstal is nou 2 827, 'n belading van 8,9 persent wat as gepas beskou word.

33. Die wetgewende Vergadering-kiesafdeling Swakopmund se kieserstal was op die vasgestelde datum 2 582. U Kommissie het hierdie getal, soos reeds aangedui, aangevul met Blok 4 van Stemdistrrik 36 van Walvisbaai met 253 kiesers. Daarbenewens is die gedeelte van Stemdistrrik 20 van die Wetgewende Vergadering-kiesafdeling Erongo bestaande uit Brabant 168, Schlucht en Niewoudt (deel in die landdrosdistrrik Karibib) met vier kiesers ook oorgeplaas na Swakopmund. Laasgenoemde vier kiesers is by Swakopmund gevoeg aangesien hulle weens swak verkeersmiddele en geografiese versperrings dit moeilik vind om in Stemdistrrik 20 te stem. Die kieserstal van

30. After the Legislative Assembly electoral division of Khomas-Hochland surrendered Blocks 15, 17, 18, 19, 20, 30, 37, 61, 62 and 80 of Polling District 73, with 1 317 voters in all, to Windhoek South, and Block 64 of Polling District 35, with 60 voters, to Windhoek West, as well as Blocks 75, 76, 77, 78 and 79 of Polling District 47 and Polling District 86, with 2 868 voters in all, to Pionierspark, as well as that portion of Polling District 35, comprising Brakwater 48 and Nubuamis 37, with 195 voters, to Klein Windhoek, the number of the 6 066 voters registered in Khomas-Hochland on the fixed date was reduced to 1 626. This number of voters therefore had to be supplemented, and this could be done only from the adjoining electoral division of Maltahöhe. Polling Districts 44, 46, 48 and 84 of the Legislative Assembly electoral division of Maltahöhe, with 893 voters in all, was consequently transferred to it and Khomas-Hochland now has 2 519 voters, an unload of 2,9 per cent. Unfortunately a part of Academia comprising Block 74 of Polling District 47, with 147 urban voters, had to be added to the electoral division of Khomas-Hochland, but in consequence of this delimitation plan regarded by Your Commission as suitable for the Territory, this grouping was unavoidable. Indeed, there was no acceptable alternative. Khomas-Hochland also received parts of Polling District 56 with 0 voters from Lüderitz.

31. On the fixed date the Legislative Assembly electoral division of Maltahöhe has 2 122 registered voters. As already indicated, Maltahöhe surrendered 893 voters to Khomas-Hochland and 1 229 to Stampriet, and the electoral division of Maltahöhe therefore disappeared.

32. On the fixed date Walvis Bay had 3 080 voters, all concentrated in the Town of Walvis Bay. Since the previous delimitation the number of voters in Walvis Bay has grown to such an extent that a part of the town's voters had to be surrendered. Your Commission deemed it advisable to transfer the 253 voters in Block 4 of Polling District 36 to the Swakopmund electoral division. Although Swakopmund is an established administrative town as well as a holiday resort, and Walvis Bay is a harbour and factory town, they are isolated by the desert in a singular way and their voters have a considerable community of interests. The boundary change in this electoral division is slight. The division of Walvis Bay was approved by the delimitation commission in 1965 already as a result of its situation and surroundings, and Your Commission had no other choice but to leave it so divided. Here Your Commission wishes to point out, however, that the position which arose here was not at all comparable with the proposition with which Your Commission had to deal in Keetmanshoop. In the case of Keetmanshoop there was an acceptable alternative, which was lacking in the case of Walvis Bay. Walvis Bay received a part of Polling District 56 with 0 voters from Lüderitz, and its number of voters is now 2 827, a load of 8,9 per cent which is regarded as suitable.

33. The Legislative Assembly electoral division of Swakopmund had 2 582 voters on the fixed date. As already indicated, Your Commission supplemented this number by Block 4 of Polling District 36 of Walvis Bay, which had 253 voters. In addition the part of Polling District 20 of the Legislative Assembly electoral division of Erongo, comprising Brabant 168, Schlucht and Niewoudt (part in the Magisterial District of Karibib), with 4 voters, also transferred to Swakopmund. These four voters were added to Swakopmund since, because of poor transport and geographical barriers, they found it difficult to vote in Polling District 20. Swakopmund now has 2 839 voters, a load of 9,4 per

Swakopmund is nou 2 839, 'n belading van 9,4 persent wat as geregverdig beskou word aangesien die meeste van Swakopmund se kiesers in die dorp Swakopmund gekonsentreer is. Ook in hierdie kiesafdeling was die grensverandering maar gering.

34. Op die vasgestelde datum was die geregistreerde kieserstal van die Tsumeb-kiesafdeling 3 333 en die getal moes dus verminder word. Stemdistrrik 4 met 602 kiesers wat hoofsaaklik Ovambo, 'n Bantoeuistand, insluit, behoort as gevolg van beter verbindingsmiddele in werklikheid by die Tsumeb-kiesafdeling, maar aangesien Tsumeb alreeds 28,5 persent bo die kwota was, moes kiesers weggeneem word, en albei partye was dit eens dat Stemdistrrik 4 weggeneem en by die kiesafdeling Erongo gevoeg behoort te word. U Kommissie het na oorweging dit gerade geag om Stemdistrrik 4 met 602 kiesers aan die kiesafdeling Erongo, waarin die Bantoeuistande Kaokoland en Damaraland geleë is, eersgenoemde waarvan aan Ovambo grens, af te staan. Nadat Tsumeb ook 177 kiesers van Stemdistrrik 5 en gedeelte van Stemdistrrik 6 met 23 kiesers wes van die oostelike grens van die Etoshapan aan Otjiwarongo gegee het, het hierdie kiesafdeling se getal kiesers te staan gekom op 2 571. Die Tsumeb-kiesafdeling is baie kompak en aangesien die meerderheid van die kiesers in die dorp Tsumeb woon, het U Kommissie besluit om laasgenoemde getal kiesers verder aan te vul met Stemdistrrik 11 van die kiesafdeling Grootfontein, se 142 kiesers. Tsumeb het dus nou 'n kieserstal van 2 673, 'n belading van 3 persent, wat as gepas beskou word. Daarbenewens het U Kommissie 'n gedeelte van Stemdistrrik 6, die gedeelte geleë in die landdrosdistrrik Ovambo met 0 kiesers en 'n deel van Stemdistrrik 81 in die distrrik Ovambo met 0 kiesers aan die kiesafdeling Erongo afgestaan asook 'n deel van Stemdistrrik 81 in die landdrosdistrrik Kavango met 0 kiesers aan die kiesafdeling Grootfontein.

35. Nadat die kiesafdeling Erongo Stemdistrrik 4 met 602 kiesers van die Wetgewende Vergadering-kiesafdeling Tsumeb bygekry het, en vier kiesers in Stemdistrrik 20 deur Erongo aan Swakopmund afgestaan is, was sy kieserstal 2 892. Erongo het nou te veel kiesers gehad en die oorblywende deel van Stemdistrrik 20 met 252 kiesers en Stemdistrrik 21 met 90 kiesers is gevolglik aan Okahandja afgestaan. Soos reeds aangedui, is die gedeeltes van Stemdistrrikte 6 en 81 in die kiesafdeling Tsumeb wat in die landdrosdistrrik Ovambo val en gedeelte van Stemdistrrik 13 in die kiesafdeling Grootfontein wat ook in die landdrosdistrrik Ovambo val, almal met 0 kiesers, ook by Erongo gevoeg. Laasgenoemde kiesafdeling se kieserstal is nou 2 550, 'n ontlading van 1,7 persent, wat U Kommissie as gepas beskou. Die buite grense van hierdie kiesafdeling is slegs verander omdat U Kommissie die 602 kiesers van Stemdistrrik 4 in die kiesafdeling Tsumeb na Erongo, die enigste kiesafdeling waarby hulle gevoeg kon word, oorgeplaas het.

36. Op die vasgestelde datum was die geregistreerde kieserstal in die kiesafdeling Otjiwarongo 2 410. Die meerderheid van hierdie kiesers is gekonsentreer in die dorp Otjiwarongo. U Kommissie was van mening dat die getal kiesers in hierdie kiesafdeling wat as plattelandse Wetgewende Vergadering-kiesafdeling in vergelyking met baie van die ander plattelandse kiesafdelings redelik kompak is meer kiesers behoort te hê en 177 kiesers in Stemdistrrik 5 en 23 kiesers in die gedeelte van Stemdistrrik 6 ten weste van die oostelike grens van die Etoshapan in

cent which is regarded as justified since most of the voters of Swakopmund are concentrated in the Town of Swakopmund. In the case of this constituency too, there was only a slight boundary change.

34. On the fixed date the Tsumeb electoral division had a total of 3 333 registered voters, and this had to be reduced. Polling District 4 with 602 voters, comprising mainly Ovambo, a Bantu homeland, should actually because of better communications belong to the Tsumeb electoral division, but since Tsumeb was already 28,5 per cent above quota, voters had to be taken away, and both parties were agreed that Polling District 4 should be taken away and should be added to the electoral division of Erongo. After consideration Your Commission deemed it advisable to surrender Polling District 4, with 602 voters, to the electoral division of Erongo, in which the Bantu homelands of Kaokoland and Damaraland are situated, the former of which borders on Ovambo. After Tsumeb had also given 177 voters of Polling District 5 and part of Polling District 6, with 23 voters, to the west of the eastern boundary of the Etosha Pan to Otjiwarongo, the number of voters in this electoral division stood at 2 571. The Tsumeb electoral division is very compact and since the majority of the voters live in the Town of Tsumeb, Your Commission decided to supplement the last mentioned number of voters by the 142 voters from Polling District 11 of the electoral division of Grootfontein. Tsumeb now has, therefore, 2 673 voters, a load of 3 per cent, which is regarded as suitable. In addition Your Commission ceded a part of Polling District 6, the part situated in the Magisterial District of Ovambo, with 0 voters, and a part of Polling District 81 in the District of Ovambo, with 0 voters, to the electoral division of Erongo, as well as part of the Polling District 81 in the Magisterial District of Kavango, with 0 voters, to the electoral division of Grootfontein.

35. After the electoral division of Erongo received Polling District 4, with 602 voters, from the Legislative Assembly electoral division of Tsumeb, and 4 voters in Polling District 20 were surrendered by Erongo to Swakopmund, its tally of voters was 2 892. Erongo now had too many voters and the remaining part of Polling District 20, with 252 voters, and Polling District 21, with 90 voters, were consequently surrendered to Okahandja. As already indicated, the parts of Polling Districts 6 and 81 in the constituency of Tsumeb which fall in the Magisterial District of Ovambo and part of Polling District 13 in the constituency of Grootfontein, which also falls in the Magisterial District of Ovambo, all with 0 voters, were also added to Erongo. The Erongo electoral division now has 2 550 voters, an unload of 1,7 per cent, which Your Commission regards as suitable. The outer boundaries of this electoral division were altered only because Your Commission transferred 602 voters of Polling District 4 in the electoral division of Tsumeb to Erongo, the only electoral division to which they could be added.

36. On the fixed date the number of registered voters in the electoral division of Otjiwarongo was 2 410. Most of these voters are concentrated in the Town of Otjiwarongo. Your Commission was of the opinion that the number of voters in this constituency which, as a rural Legislative Assembly electoral division was fairly compact in comparison with many of the other rural constituencies, should have more voters, and consequently 177 voters in Polling District 5 and 23 voters in the part

die kiesafdeling Tsumeb, is gevolglik na Otjiwarongo oorgeplaas. Aangesien die 39 kiesers in die gedeelte van Stemdistrk 15 in die kiesafdeling Otjiwarongo wat in die landdrosdistrk Hereroland-Wes val beter by die kiesafdeling Grootfontein inpas, is hulle daarheen oorgeplaas. Die kieserstal van Otjiwarongo is nou 2 571, 'n ontlading van 0,9 persent. Dit is 'n geringe ontlading vir 'n plattelandse kiesafdeling, maar soos hierbo gemeld, is baie van die kiesers woonagtig in die dorp Otjiwarongo.

37. Die Wetgewende Vergadering-kiesafdeling Grootfontein se geregistreerde kieserstal was op die vasgestelde datum 2 702. Van laasgenoemde getal kiesers is Stemdistrk 11 met 142 kiesers aan die kiesafdeling Tsumeb afgestaan en 'n gedeelte van Stemdistrk 13 met 0 kiesers in die landdrosdistrk Ovambo aan die kiesafdeling Erongo. Daarna het Grootfontein 2 560 kiesers gehad. Laasgenoemde is toe aangevul met gedeeltes van Stemdistrk 82, in die kiesafdeling Gobabis wat in die landdrosdistrkte Hereroland-Oos en Hereroland-Wes val met nege kiesers, met 'n gedeelte van Stemdistrk 81 in die kiesafdeling Tsumeb geleë in die landdrosdistrk Kavango met 0 kiesers, en met 'n gedeelte van Stemdistrk 15 in die kiesafdeling Otjiwarongo geleë in die landdrosdistrk Hereroland-Wes met 39 kiesers. Grootfontein het dus nou 2 608 kiesers, 'n belading van 0,5 persent. Daar sal opgemerk word dat die Bantoeuistande Kavango, Hereroland-Wes, Hereroland-Oos en Boesmanland nou saam in hierdie kiesafdeling gegroepeer is. Benewens die feit dat daar 'n groot konsentrasie kiesers op Grootfontein is, is die meerderheid van hierdie kiesers in die Bantoeuistande en Boesmanland op 'n paar plekke saamgetrek en die geringe belading in hierdie uitgestrekte kiesafdeling is dus geregverdig.

38. Die kiesafdeling Okahandja se geregistreerde kieserstal was op die vasgestelde datum 2 128. Nadat Okahandja Stemdistrk 21 van die kiesafdeling Erongo met 90 kiesers en die gedeelte van Stemdistrk 20 uitgesonder Brabant 168, Schlucht en deel van Niewoudt in die distrk Karibib met 252 kiesers van die kiesafdeling Erongo bygekry het, was Okahandja se kieserstal 2 470, wat vir hierdie kiesafdeling te groot was en U Kommissie het dit gevolglik gerade geag om Stemdistrk 25 en 154 kiesers van Okahandja by die kiesafdeling Gobabis te voeg. Okahandja se kieserstal is nou 2 316, 'n ontlading van 10,8 persent wat as gepas beskou word.

39. Die Wetgewende Vergadering-kiesafdeling Gobabis het op die vasgestelde datum 'n geregistreerde kieserstal van 2 177 gehad. Soos reeds hierbo aangetoon, het dit nege kiesers uit Stemdistrk 82 geleë in die landdrosdistrk Hereroland-Oos, aan Grootfontein afgestaan. Saam met die 154 kiesers in Stemdistrk 25 wat hy van die kiesafdeling Okahandja ontvang het, is die kieserstal nou 2 322, 'n ontlading van 10,5 persent wat vir hierdie plattelandse kiesafdeling as geregverdig beskou word.

40. Die wysigings wat U Kommissie gerade geag het en wat in die voorgaande paragrawe meer volledig uiteengesit is, het die gevolg dat die Wetgewende Vergadering-kiesafdeling Maltahöhe verdwyn. In die plek daarvan is daar nou die kiesafdeling Pionierspark.

41. U Kommissie heg hierby aan—

(a) as Aanhangsel 1, 'n lys van Wetgewende Vergadering-kiesafdelings;

(b) as Aanhangsel 2, 'n lys van Volksraad-kiesafdelings aantonende die drie Wetgewende Vergadering-kiesafdelings waaruit elke Volksraad-kiesafdeling saamgestel is;

of Polling District 6 to the west of the eastern boundary of the Etosha Pan in the electoral division of Tsumeb were transferred to Otjiwarongo. Because the 39 voters in the part of Polling District 15 in the electoral division of Otjiwarongo, which falls in the Magisterial District of Hereroland West, fit in better in the electoral division of Grootfontein, they were transferred there. The number of voters in Otjiwarongo is now 2 571, an unload of 0,9 per cent. This is a small unload for a rural constituency, but, as mentioned above, many of the voters are resident in the Town of Otjiwarongo.

37. On the fixed date the Legislative Assembly electoral division of Grootfontein had 2 702 registered voters. Of this number 142 voters of Polling District 11 were surrendered to the constituency of Tsumeb and 0 voters in a part of Polling District 13 in the Magisterial District of Ovambo were surrendered to the electoral division of Erongo. After this Grootfontein had 2 560 voters. This division was then supplemented by parts of Polling District 82, in the electoral division of Gobabis, which falls in the Magisterial Districts of Hereroland East and Hereroland West, with 9 voters, together with a part of Polling District 81 in the electoral division of Tsumeb, situated in the Magisterial District of Kavango, with 0 voters, and together with part of Polling District 15, in the electoral division of Otjiwarongo, situated in the Magisterial District of Hereroland West, with 39 voters. Grootfontein therefore now has 2 608 voters, a load of 0,5 per cent. It will be observed that Bushmanland and the Bantu homelands of Kavango, Hereroland West and Hereroland East are now grouped in this constituency. Apart from the fact that there is a large concentration of voters at Grootfontein, the majority of these voters in the Bantu homelands and Bushmanland are clustered in a few places and the small loading in this extensive electoral division is therefore justified.

38. On the fixed date the number of registered voters in the electoral division of Okahandja was 2 128. After the addition of Polling District 21 from the electoral division of Erongo, with 90 voters, and the part of Polling District 20, excluding Brabant 168, Schlucht and part of Niewoudt in the District of Karibib, with 252 voters, from the electoral division of Erongo, Okahandja had a voting strength of 2 470, which was too big for this constituency and Your Commission consequently deemed it advisable to add Polling District 25, with 154 voters, of Okahandja to the electoral division of Gobabis. Okahandja now has 2 316 voters, an unload of 10,8 per cent which is regarded as suitable.

39. On the fixed date the Legislative Assembly electoral division of Gobabis had 2 177 registered voters. As indicated above, it surrendered 9 voters from Polling District 82 situated in the Magisterial District of Hereroland East to Grootfontein. Together with the 154 voters in Polling District 25 which it received from the electoral division of Okahandja, its number of voters is now 2 322, an unload of 10,5 per cent which for this rural constituency was regarded as justified.

40. As a result of the modifications which Your Commission deemed advisable and which have been set forth more fully in the preceding paragraphs, the Legislative Assembly electoral division of Maltahöhe disappears. In its place there is now the electoral division of Pionierspark.

41. Your Commission hereby attaches—

(a) as Appendix 1, a list of Legislative Assembly electoral divisions;

(b) as Appendix 2, a list of House of Assembly electoral divisions showing the three Legislative Assembly electoral divisions comprising each House of Assembly electoral division;

(c) as Aanhangsel 3, landkaart van—

- (i) Suidwes-Afrika;
- (ii) Windhoek; en
- (iii) Walvisbaai.

(d) as Aanhangsel 4, beskrywings van die grense van die Wetgewende Vergadering-kiesafdelings opgestel deur die Landmeter-Generaal, Windhoek, volgens landkaarte wat deur U Kommissie aan hom verstrekk is; die beskrywings is deur die Landmeter-Generaal as korrek gesertifiseer.

42. Weens die feit dat 'n nuwe Wetgewende Vergadering-kiesafdeling tot stand gekom het en 'n ander verdwyn het, het dit onvermydelik gevolg dat daar 'n hergroepering in ten minste een van die Volksraad-kiesafdelings moes plaasvind. Behalwe dat die nuwe Wetgewende Vergadering-kiesafdeling Pionierspark, nou saam met die kiesafdelings Khomas-Hochland en Stampriet die Volksraad-kiesafdeling Mariental sal uitmaak, bly die groepering in die ander Volksraad-kiesafdelings presies dieselfde. Geeneen van die Volksraad-kiesafdelings het van naam verander nie. Die veranderinge waarna hierbo verwys word, sowel as die getalle kiesers en die persentasies van belading en ontlading word volledig in die derde Bylae uiteengesit.

43. Die lede van die Kommissie maak met waardering gewag van die hulp deur die Administrasie van die Gebied verleen, van die fasiliteite deur hulle verstrekk asook van die hulp wat deur die Landmeter-Generaal verleen is.

44. Waardering word ook uitgespreek vir die hulpvaardigheid en die bekwame bystand verleen deur mnr. W. W. Blomerus, die Streekvertegenwoordiger van die Departement van Binnelandse Sake in Suidwes-Afrika. Hy het die Kommissie op sy inspeksiereis vergesel en gedurende die reis te alle tye die Kommissie ywerig bygestaan.

45. U Kommissie wil ook sy besondere waardering uitspreek vir die bekwame, ywerige en getroue werk verrig deur die Sekretaris, mnr. B. R. Buys, wat met sy uitgebreide ondervinding U Kommissie se taak baie vergemaklik het.

46. Mej. W. Grobler het ook haar werk op pligsgetroue wyse gedoen. Sy word bedank.

47. U Kommissie het die eer, Meneer die Staatspresident, om hulself U onderdanige en dienswillige dienare te noem.

Owing to the fact that a new Legislative Assembly electoral division came into being and another disappeared, an inevitable consequence was that there had to be a regrouping in at least one of the House of Assembly electoral divisions. Apart from the fact that the new Legislative Assembly electoral division of Pionierspark, together with the electoral divisions of Khomas-Hochland and Stampriet, will now comprise the House of Assembly electoral division of Mariental, the grouping in the other House of Assembly electoral divisions remains exactly the same. There was no change of name in the House of Assembly electoral divisions. The changes referred to above as well as the numbers of voters and the percentages of loading and unloading are set forth fully in the third Schedule.

43. The members of the Commission wish to acknowledge with appreciation the help given by the Administration of the Territory, the facilities furnished by it as well as the help given by the Surveyor-General.

44. The Commission also wishes to express its appreciation of the co-operation and able assistance of Mr W. W. Blomerus, the Regional Representative of the Department of the Interior in South-West Africa. He accompanied the Commission on its tour of inspection and during the tour assisted the Commission diligently at all times.

45. Your Commission would, also in particular like to express its appreciation of the efficient, diligent and faithful work done by the Secretary, Mr B. R. Buys, who, with his extensive experience made Your Commission's task much easier.

46. Miss W. Grobler also acquitted herself of her task conscientiously, for which she is thanked.

47. Mr State President, Your Commission have the honour to subscribe themselves your humble and obedient servants.
