BY THE STATE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA

No. 97 of 1974 (Republic)]

GENERAL ELECTION OF SENATORS IN SOUTH-WEST AFRICA

WHEREAS the Senate, constituted in terms of section 28 of the Republic of South Africa Constitution Act, 1961 (Act 32 of 1961), has, by my Proclamation 94 dated 10 May 1974, been dissolved in terms of section 33 of the said act:

AND WHEREAS it is expedient to proceed to the election of Senators:

NOW, THEREFORE, under and by virtue of the Powers and Authority vested in me by paragraph 5(1)(A) of the regulations for the election of Senators in the territory of South West Africa, published under Government Notice R.1342 of 2 September 1960, I do hereby declare —

1. That Thursday, the thirtieth day of May 1974, shall be the day on which a sitting of all members of the House of Assembly elected for the territory of South-West Africa and of the Legislative Assembly of the said territory shall be held for the purpose of the election of Senators:

2. Dat voormelde sitting gehou moet word om 10-uur in die voormiddag van voormelde dag: en
2. That the aforesaid sitting shall be held at 10 o'clock in the forenoon on the aforesaid day: and
3. Dat voormelde sitting gehou moet word in die vergaderingsaal van die Wetgewende Vergadering, Windhoek.
3. That the sitting shall be held in the Chamber of the Legislative Assembly, Windhoek.
