### ORDONNANSIE 1974: UITVAARDIGING VAN

### ORDINANCE, 1974: PROMULGATION OF

Dit behaag die Waarnemende Administrateur om sy goedkeuring te heg, ooreenkomstig artikel 27 van die Wet op die Konstitusie van Suidwes-Afrika, 1968 (Wet 39 van 1968) aan die volgende Ordonnansie wat hierby vir algemene inligting gepubliseer word, ooreenkomstig artikel 29 van gemelde Wet:-

**BENEFITS (SUPPLEMENTARY) ORDINANCE,  
1974.**

*(Assented to 10 July 1974.)*

*(English text signed by the Deputy Administrator.)*

*(Date of commencement 15 July 1974.)*

**ORDINANCE**

To provide for certain benefits for certain employees in the service of the Administration of South West Africa; and to provide for incidental matters.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:-

1. Notwithstanding anything to the contrary in any law contained, every person indicated as a beneficiary in an item of the Schedule to this Ordinance shall be entitled to the benefit specified in that item.

Granting of certain benefits.

2. Notwithstanding anything to the contrary in the Income Tax Ordinance, 1974, contained, any amount specified in the Schedule to this Ordinance, shall be exempt from any tax leviable under the said Income Tax Ordinance, 1974.

Benefits exempt from tax.

3. This Ordinance shall be called the Benefits (Supplementary) Ordinance, 1974.

Short title.

**SCHEDULE.**

1. On behalf of LORENZ MICHAEL HESSE, Senior Nature Conservator in the service of the Administration of South West Africa, the amount of R1 767,18 shall be paid to a retirement annuity fund approved by the Secretary for South West Africa.

2. On behalf of HEINZ WALTER JASPERT, Fitter and Turner in the service of the Administration of South West Africa, the amount of R2 238,61 shall be paid to a retirement annuity fund approved by the Secretary for South West Africa.

3. On behalf of JOHANNES AUGUSTUS VAN DEN HEEVER, Tourist Officer in the service of the Administration of South West Africa, the amount of R1 497,45 shall be paid to a retirement annuity fund approved by the Secretary for South West Africa.
