**SECOND ROAD TRAFFIC AMENDMENT ORDINANCE, 1974.**

(Assented to 24 July 1974.)  
*(English text signed by the Administrator.)*  
*(Date of commencement 26 July 1974.)*

**ORDINANCE**

To amend the Road Traffic Ordinance, 1967, so as to further define certain expressions.

**BE IT ORDAINED** by the Legislative Assembly for the Territory of South West Africa, as follows:-

1. Section 1 of the Road Traffic Ordinance, 1967 (Ordinance 30 of 1967), is hereby amended —

Amendment of section 1 of Ordinance 30 of 1967, as amended by section 1 of Ordinance 19 of 1968, section 2 of Ordinance 25 of 1969, section 2 of Ordinance 18 of 1970, section 2 of Ordinance 18 of 1971 and section 2 of Ordinance 16 of 1972.

(a) by the substitution for the definition of "examiner for drivers' licences" of the following definition:

" "examiner for drivers' licences" means an examiner for drivers' licences appointed in terms of section 3;";

(b) by the substitution for the definition of "examiner of vehicles" of the following definition:

" "examiner of vehicles" means an examiner of vehicles appointed in terms of section 3;"; and

(c) by the substitution for the definition of "inspector of licences" of the following definition:

" "inspector of licences" means an inspector of licences appointed in terms of section 3;".

2. This Ordinance shall be called the Second Road Traffic Amendment Ordinance, 1974. Short title
