FINANCE AND AUDIT AMENDMENT ORDINANCE, 1974.

*(Assented to 24 July 1974.)*  
*(English text signed by the Administrator.)*  
*(Date of commencement 1 April 1974.)*

## ORDINANCE

To amend the Finance and Audit Ordinance, 1926, in regard to the promulgation of regulations; and to provide for the issue of financial instructions.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:-

1. The Finance and Audit Ordinance, 1926 (Ordinance 1 of 1926), is hereby amended by the substitution for section 26 of the following section:

Amendment of section 26 of Ordinance 1 of 1926.

"Regulations and instructions.

26. (1) The Executive Committee may make regulations (to be known as Financial Regulations of the Administration) —

- (a) prescribing the duties and responsibilities of the Accounting Officer;
- (b) providing for the nomination of an officer as the Chief Collection Officer of the Administration and prescribing his duties and responsibilities as such;
- (c) providing for the system to be followed in the collection, receipt, banking, custody, payment, expenditure, accounting for, control and supervision of public moneys,

and generally for the better carrying out of the provisions of this Ordinance and the achievement of the objects thereof.

FINANCE AND AUDIT AMENDMENT ORDINANCE, 1974. No. 13 of 1974.

(2) The Executive Committee may from time to time issue instructions (to be known as Financial Instructions of the Administration) not inconsistent with the provisions of the Financial Regulations of the Administration, relating to the form of estimates required for presentation to the Legislative Assembly, the collection, receipt, banking, custody, payment, expenditure, accounting for and control and supervision of public moneys and the control and stocktaking of securities, stamps, supplies or other property.”.

2. This Ordinance shall be called the Finance and Audit Amendment Ordinance, 1974, and shall be deemed to have come into operation on the first day of April, 1974.
