The Executive Committee has under and by virtue of the provisions of section 243 of the Municipal Ordinance, 1963 (Ordinance 13 of 1963) approved the following amendment of the regulations promulgated by Government Notice 104 of 1927, as amended by Government Notices 64 of 1928, 114 of 1952, 166 of 1958, 28 of 1969 122 and 257 of 1973:

1. Substitute the following for regulation 2bis:

“2bis Schedule of Tariffs

- (a) Compiling of a diagram of an erf R5,00
- Copy of erf diagram R0,25 per copy
- (b) Scrutinising of plans of any building, structure or advertising sign submitted in terms of these regulations for approval:
- (i) Basic charge for any plan or any structure or building R7,50
- (ii) Additional amount payable based on floor area of building or structure, unlimited R0,35 per square meter
- (iii) Advertising signs R5,00 per sign
- (c) Re-scrutinising of plans where approval has lapsed by effluxion of time or where faults on the plans which were pointed out to the applicant have not been rectified entirely upon resubmission R5,00 per re-scrutinisation
- (d) Re-inspection after final inspection for purpose of rectifying anomalies as regards -
