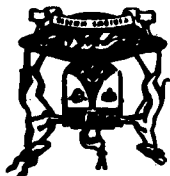

WYSIGING VAN REGULASIES INSAKE RAAD-  
 PLEGENDE KOMITEES VIR KLEURLING-  
 DORPE.

AMENDMENT OF REGULATIONS RELATING  
 TO CONSULTATIVE COMMITTEES FOR  
 COLOURED TOWNSHIPS.

Die Uitvoerende Komitee het kragtens en ingevolge die bepaling van artikel 4 van die Ordonnansie op die instelling van Bestuursvorme in Kleurlingdorpe, 1965 (Ordonnansie 34 van 1965) die onderstaande wysiging goedgekeur van die regulasies afgekondig by Goewermentskennisgewing 151 van 1966 soos gewysig by Goewermentskennisgewing 142 van 1972:

The Executive Committee has under and by virtue of the provisions of section 4 of the Establishment of Local Government in Coloured Townships Ordinance, 1965 (Ordinance 34 of 1965) approved the following amendment of the regulations promulgated under Government Notice 151 of 1966 as amended by Government Notice 142 of 1972:

Verang regulasie 4(1) deur die volgende:

Substitute the following for regulation 4(1):

“4(1) Op die datum van inwerkingtreding van hierdie regulasies geskied daar ’n algemene aanstelling van lede van alle komitees wat op genoemde datum ingestel is en daarna geskied daar ’n tweejaarlikse algemene aanstelling van die lede van alle komitees: Met dien verstande dat die Uitvoerende Komitee die ampstermyn van enige komitee te eniger tyd kan verleng vir die tydperk wat hy dienstig ag.”

“4(1) On the date on which these regulations come into force, a general appointment of members of all committees instituted on that date shall take place and thereafter a general appointment of members of all committees shall take place every two years: Provided that the Executive Committee may at any time extend the term of office of any committee for the period which it deems fit.”
