VERDELING VAN DIE GEBIED SUIDWES-AFRIKA IN KIESAFDELINGS VIR DIE VERKIESING VAN LEDE VAN DIE GEKOSE KLEURLINGRAAD VAN SUIDWES-AFRIKA

## PROCLAMATION

*by the State President of the Republic of South Africa*

No. 158, 1974 (Republic)

DIVISION OF THE TERRITORY SOUTH-WEST AFRICA INTO ELECTORAL DIVISIONS FOR THE ELECTION OF MEMBERS OF THE ELECTED COLOURED COUNCIL OF SOUTH WEST AFRICA

I, Jacobus Johannes Fouché, State President of the Republic of South Africa, hereby declare in terms of the provisions of section 8 (6) of the Establishment of an Elected Coloured Council for South West Africa Ordinance, 1966 (Ordinance 29 of 1966), that the names and boundaries of the several electoral divisions as finally fixed and certified by the Commission appointed in terms of the provisions of section 8 (1) of the aforesaid Ordinance is as named and described in the Schedules to the report of that Commission that appears in this Official Gazette.

REPORT TO THE STATE PRESIDENT BY THE DELIMITATION COMMISSION APPOINTED IN TERMS OF SECTION 8 OF THE ESTABLISHMENT OF AN ELECTED COLOURED COUNCIL FOR SOUTH-WEST AFRICA ORDINANCE (No. 29 OF 1966)

FIRST DELIMITATION, 1974

## MAY IT PLEASE YOU

1. In terms of the provisions of section 8 of Ordinance 29 of 1966 the undersigned was appointed by You, Mr State President, to be a Commission, with effect from 7 June 1974, to divide the Territory of South-West Africa into electoral divisions for the election of members of the Elected Coloured Council (hereinafter called "the Council").

2. Ingevolge gemelde artikel 8 van Ordonnansie 29 van 1966 moet die Gebied in ses (6) kiesafdelings verdeel word. Vir die doeleindes van so 'n verdeling word die kwota van stemgeregtigdes per kiesafdeling verkry deur die totale getal kiesers in die Gebied, soos vasgestel uit 'n ondersoek van die geldende kieserslys, te deel deur die getal kiesafdelings waarin die Gebied verdeel moet word. Die Gebied word op so 'n wyse afgebaken dat die getal op die Kleurlingkieserslys geregistreerde persone wat in elke kiesafdeling woon so na as moontlik met die bogenelde kwota gelykstaan: Met dien verstande dat die Kommissie, met inagneming van gemeenskaplikheid of verskeidenheid van belange, verkeersmiddele, natuurlike kenmerke en huidige of toekomstige ylheid of digtheid van bevolking waaroor gegewens beskikbaar is, in enige geval van die kwota kan afwyk, maar in geen geval in groter mate as 15 persent bo of 15 persent benede die kwota nie.

3. Ingevolge artikel agt (8) van die Wet tot Konsolidasie van die Kieswette, Wet 46 van 1946, soos gewysig, het daar gedurende die tydperk 24 April 1972 tot 24 Julie 1972 'n algemene registrasie van kiesers in hierdie Gebied plaasgevind. Kieserslyste is opgestel en aangevul by wyse van supplementêre registrasies.

4. U Kommissie het besluit om die getal kiesers wat op 28 Februarie 1974, hierna genoem vasgestelde datum, in Suidwes-Afrika geregistreer was te gebruik as grondslag vir die afbakening van die Gebied. Hierdie besluit is 'n geruime tyd voor U Kommissie se openbare vergadering te Khomasdal, Windhoek, aan belanghebbendes bekendgemaak.

5. Die Streekvertegenwoordiger van die Departement van Binnelandse Sake in Suidwes-Afrika het gesertifiseer dat daar 4 871 Kleurlingkiesers op 28 Februarie 1974 in die Gebied geregistreer was. Die kwota vir 'n kiesafdeling is dus 812. Die maksimum getal kiesers vir 'n kiesafdeling is 934 terwyl die minimum 690 is.

6. Aangesien dit die eerste Afbakening van hierdie Gebied sou wees, het U Kommissie 'n voorlopige afbakening gedoen. Daarna is deur middel van nuusblaaie en die Suid-Afrikaanse Uitsaaikorporasie se Streeknuus vir Suidwes-Afrika bekendgemaak waar die stukke ten opsigte van bedoelde voorlopige afbakening ter insae sou lê en waar en wanneer vertoë in verband daarmee tot die Kommissie gerig kon word. U Kommissie het op Saterdag 15 Junie 1974 'n openbare sitting te Khomasdal, Windhoek gehou waar die voorlopige afbakening aan alle belanghebbendes voorgelê is en hulle die geleentheid gegee is om hulle eie skemas vir die afbakening van die Gebied voor te lê en om voorstelle te doen wat U Kommissie sou kan help in die uitvoering van sy opdrag. Tydens daardie sitting is geen alternatiewe skemas vir die afbakening voorgestel nie en almal wat teenwoordig was, het aangedui dat hulle tevrede is met die voorlopige afbakening.

7. U Kommissie is daarvan oortuig dat die bestaande netwerk van paaie en spoorweë genoegsaam is om die verskillende dele van die Gebied doeltreffend te verbind. Daar is trouens ook deur niemand beweer dat verkeersmiddele—U Kommissie sou in die Ordonnansie die woord verkeersweë verkies het—enige probleem skep wat besondere aandag vereis nie. U Kommissie het ook geen rede om te glo dat gemeenskaplikheid of verskeidenheid van belange moeilikhede sal lewer ten opsigte van die wyse waarop die Gebied afgebaken is nie.

8. U Kommissie het die beginsel van 'n gelyke aantal kiesers in elke kiesafdeling aanvaar en het van die standpunt uitgegaan dat by die skepping van kiesafdelings die afbakening so behoort te geskied dat verteenwoordigers hulle kiesers tot die beste kan verteenwoordig. So ook is U Kommissie van mening dat 'n dorp se kiesers nie verdeel behoort te word indien daar 'n aanneemlike alternatief is nie.

2. In accordance with the above-mentioned section 8 of Ordinance 29 of 1966 the Territory has to be divided into six (6) electoral divisions. For the purposes of such division the quota of voters per electoral division has to be obtained by dividing the total number of voters in the Territory, as ascertained from an examination of the current voters' roll, by the number of electoral divisions into which the Territory is to be divided. The Territory shall be delimited in such a way that the number of persons registered on the Coloured voters' roll residing in each electoral division will as near as may be approximate the above-mentioned quota: Provided that the Commission may, in any case, with due regard to community or diversity of interests, means of communication, physical features and existing or future sparsity or density of population in respect of which information is available, depart from the quota, but in no case to any greater extent than 15 per cent above or 15 per cent below the quota.

3. In accordance with section eight (8) of the Electoral Consolidation Act, No. 46 of 1946, as amended, a general registration of voters took place in this Territory during the period 24 April 1972 to 24 July 1972. Voters' rolls were prepared and added to by means of supplementary registrations.

4. Your Commission decided to use the number of voters registered in South-West Africa on 28 February 1974 (hereinafter called the "fixed date") as the basis for the delimitation of the Territory. This decision was made known to interested parties some considerable time before Your Commission's public meeting at Khomasdal, Windhoek.

5. The Regional Representative of the Department of the Interior in South-West Africa certified that there were 4 871 registered Coloured voters in the Territory on 28 February 1974. The quota for an electoral division is therefore 812. The maximum number of voters for an electoral division is 934 and the minimum 690.

6. Since this would be the first delimitation of this Territory Your Commission carried out a provisional delimitation. Next an announcement was made through the medium of the press and the South African Broadcasting Corporation's Regional News for South-West Africa about as to where the documents in respect of the said provisional delimitation would lie for inspection and where and when representations in this regard could be made to the Commission. Your Commission held a public meeting at Khomasdal, Windhoek, on Saturday, 15 June 1974, and here the provisional delimitation was submitted to all interested parties who were given an opportunity of submitting their own schemes for the delimitation of the Territory and of making proposals which would be of assistance to Your Commission in carrying out its terms of reference. At the time of this sitting no alternative schemes for the delimitation were proposed and all present indicated that they were satisfied with the provisionaal delimitation.

7. Your Commission is satisfied that the existing network of roads and railways is adequate for connecting the various parts of the Territory effectively. In fact, no one contended that the means of communication created any problem requiring special attention. Moreover, Your Commission has no reason to believe that community or diversity of interests will present difficulties in respect of the way in which the Territory has been delimited.

8. Your Commission accepted the principle of an equal number of voters in each electoral division and took the view that in creating electoral divisions the delimitation ought to be such that representatives would best be able to represent their voters. Your Commission is also of opinion that the voters in any town should not be divided if there is an acceptable alternative.

9. U Kommissie het die Gebied op so 'n wyse verdeel dat die getal op die Kleurlingkieserslys geregistreerde persone wat in elke kiesafdeling woon so na as moontlik met die kwota gelykstaan, maar het van sodanige kwota afgewyk waar dit geregverdig was deur die faktore wat in artikel 8 van Ordonnansie 29 van 1966 gemeld word.

10. Alle stembdistrikte wat gebruik is om die grense van kiesafdelings vir die verkiesing van lede van die Gekose Kleurlingraad te omskryf, is soos in die derde afbakening vir blanke kiesers bepaal.

11. Na die besprekings met die belanghebbendes op die openbare sitting op 15 Junie 1974 te Khomasdal, is voortgegaan met die finale afbakening van die Gebied in kiesafdelings.

12. Vervolgens word die afsonderlike kiesafdelings behandel:

(i) In daardie gedeelte van Stembdistrik 56 waarin die dorp Nautilus geleë is was daar op die vasgestelde datum 365 kiesers geregistreer. U Kommissie het dit gerade geag om daardie getal kiesers saam te groepeer met die 453 kiesers van Stembdistrikte 58, 60, 61, 63, 68, 69, 70, 71, 72, 74, 75 en 76 en 'n kiesafdeling te skep wat bekend sal staan as NAUTILUS. Hierdie kiesafdeling sal 818 kiesers hê. Dit is wel 'n geringe belading maar U Kommissie beskou dit as gepas.

(ii) Op die vasgestelde datum was daar 844 kiesers in Stembdistrik 62 geregistreer. Behalwe 35 kiesers wat in die deel van Stembdistrik 62 wat bekend staan as die Berseba-Reservaat en 'n paar kiesers wat op plase in die nabye omgewing van Keetmanshoop geregistreer is, is al die ander kiesers van Stembdistrik 62 saamgetrek in die dorp Krönlein. U Kommissie was van oordeel dat die 35 kiesers in die Berseba-Reservaat beter sou inpas by die kiesafdeling EMPELHEIM, waarmee onmiddellik hieronder gehandel sal word, en nadat daardie 35 kiesers van Stembdistrik 62 aan die kiesafdeling Empelheim afgestaan is, het U Kommissie besluit om 'n kiesafdeling met die oorblywende 809 kiesers te skep wat bekend sal staan as Krönlein. Hierdie kiesafdeling is effens ontlai maar dit word as gepas beskou.

(iii) Vervolgens het U Kommissie die 790 kiesers wat saamgetrek is in Stembdistrikte 46, 48, 50, 51, 52, 53, 54, 55, 59, gedeelte van Stembdistrik 62 met 35 kiesers, 64, 65, 66, 67 en 85 saamgegroepeer. Nadat gedeeltes van Stembdistrikte 36 en 56 beide met geen kiesers by bogenoemde stembdistrikte gevoeg is, is 'n kiesafdeling afgebaken wat bekend sal staan as EMPELHEIM. Hierdie kiesafdeling is ook effens ontlai, maar in hierdie groot plattelandse kiesafdeling word dit as gepas beskou.

(iv) Nadat die voornoemde kiesafdelings afgebaken is, was daar nog 2 454 kiesers oor vir die drie oorblywende kiesafdelings wat afgebaken moes word. Van daardie getal was 906 op die vasgestelde datum in die dorp Narraville in Stembdistrik 24 saamgetrek en 913 in die dorp Khomasdal en omliggende kleinhoues in Stembdistrik 35. In Narraville sowel as Khomasdal was dus op die vasgestelde datum minder kiesers geregistreer as die maksimum toelaatbare getal kiesers vir 'n kiesafdeling en U Kommissie sou graag indien dit enigsins moontlik was, albei as afsonderlike kiesafdelings wou afgebaken het. Dit sou egter beteken het dat die oorblywende kiesafdeling slegs 635 kiesers sou hê, wat minder as die minimum toelaatbare getal kiesers vir 'n kiesafdeling is en U Kommissie was dus verplig om of Narraville of Khomasdal se kiesers te verdeel. Na baie ernstige oorweging het U Kommissie tot die slotsom geraak dat Narraville, wat op 'n besondere wyse deur die woestyn afgesonder is, se kiesers nie verdeel behoort te word nie. Nadat 'n gedeelte van Stembdistrik 36 met geen kiesers by Stembdistrik 24 met 906 kiesers gevoeg is, is 'n kiesafdeling afgebaken wat bekend sal staan as Narraville.

9. Your Commission divided the Territory in such a way that the number of persons registered on the Coloured voters' roll residing in each electoral division would as near as may be approximate the quota, but departed from such quota where the factors mentioned in section 8 of Ordinance 29 of 1966 justified such departure.

10. All polling districts used in defining the boundaries of electoral divisions for the election of members of the Elected Coloured Council are as determined in the third delimitation for White voters.

11. After discussions with interested parties at the public meeting on 15 June 1974 the Commission proceeded to the final delimitation of the Territory into electoral divisions.

12. Next the individual electoral divisions will be dealt with:

(i) In that portion of Polling District 56 in which the town of Nautilus is situated there were 365 registered voters on the fixed date. Your Commission deemed it fit to group these voters with the 453 voters of Polling Districts 58, 60, 61, 63, 68, 69, 70, 71, 72, 74, 75 and 76 and to create an electoral division to be known as NAUTILUS. This electoral division will have 818 voters. This electoral division was unloaded slightly, but this is considered appropriate.

(ii) On the fixed date there were 844 registered voters in Polling District 62. With the exception of 35 voters registered in that portion of Polling District 62 which is known as the Berseba Reserve and a few voters registered on farms in the vicinity of Keetmanshoop, all the other voters of Polling District 62 are concentrated in the town of Krönlein. Your Commission was of opinion that the 35 voters in the Berseba Reserve would fit in better with the electoral division of EMPELHEIM which will be dealt with immediately below, and when those 35 voters of Polling District 62 had been surrendered to the electoral division of Empelheim, Your Commission decided to create an electoral division comprising the remaining 809 voters, which would be known as Krönlein. This electoral division has been unloaded slightly but the unload is considered appropriate.

(iii) Next Your Commission grouped the 790 voters concentrated in Polling Districts 46, 48, 50, 51, 52, 53, 54, 55, 59, portion of Polling District 62 with 35 voters, 64, 65, 66, 67 and 85. When portions of Polling Districts 36 and 56, both without any voters at all, had been added to the above-mentioned polling districts an electoral division was delimited, to be known as EMPELHEIM. This electoral division was also unloaded slightly, but in this large rural electoral division the unload is regarded as appropriate.

(iv) After the delimitation of the aforementioned electoral divisions there were still 2 454 voters left for the three remaining electoral divisions that had to be delimited; 906 of these were concentrated in the town of Narraville in Polling District 24 on the fixed date, and 913 in the town of Khomasdal and surrounding small holdings in Polling District 35. This means, therefore, that in Narraville as well as Khomasdal the registered voters on the fixed date were less than the maximum permissible number of voters for an electoral division, and Your Commission would have liked to delimit both as separate electoral divisions if it had been at all possible. However, this would have meant that the remaining electoral division would have had only 635 voters—less than the minimum permissible number of voters for an electoral division, and Your Commission was therefore obliged to divide the voters of either Narraville or Khomasdal. After serious consideration Your Commission came to the conclusion that the voters of Narraville, which is isolated by the desert in a peculiar way, ought not to be divided. When a portion of Polling District 36 with no voters at all had been added to Polling District 24 with 906 voters an electoral division to be known as Narraville was delimited.

Hierdie kiesafdeling is hoog belaaï maar in al die omstandighede van die geval word dit as gepas beskou.

(v) In die noordelike en sentrale gedeeltes van die gebied was daar in Stemdistribte 1 tot 23, 25, 26, 28, 33, 34, 49, 78, 79, 80, 81 en 82 op die vasgestelde datum 318 kiesers geregistreer en U Kommissie was verplig om hierdie getal aan te vul. Dit kon slegs gedoen word deur die 418 kiesers van Blokke 1, 2, 3 en 9 van stemdistrik 35 by daardie getal te voeg. Saam met die oorblywende gedeelte van Stemdistribte 35 met geen kiesers, het U Kommissie besluit om met hierdie 736 kiesers 'n kiesafdeling te skep wat bekend sal staan as TAMARISKIA. Hierdie kiesafdeling is heelwat ontlaaï maar dit strek oor 'n baie groot gebied en die ontlading word as gepas beskou.

(vi) Nadat bogenoemde vyf kiesafdelings afgebaken is, was die posisie as volg: In Blokke 4, 5, 6, 7, 8 en 10 van stemdistrik 35 was daar 485 kiesers oor terwyl daar 10 kiesers was wat op die vasgestelde datum op kleinhoues in die omgewing van Brakwater noord van Windhoek, in die oorblywende gedeelte van stemdistrik 35 geregistreer was. U Kommissie het hierdie 495 kiesers saamgegroeper met die 317 kiesers in Stemdistribte 27, 30, 31, 32, 37, 38, 39, 40, 41, 42, 43, 44, 45, 47, 73, 83, 84, 86 en 87 en 'n kiesafdeling geskep met 812 kiesers wat bekend sal staan as Khomasdal. Dit was met spyt dat die kiesers van Khomasdal verdeel is maar U Kommissie het geen ander keuse gehad nie.

### 13. U Kommissie heg hierby aan:

(i) 'n Alfabetiese lys (aansangsel A) van die verskillende kiesafdelings soos deur U Kommissie afgebaken tesame met 'n beskrywing van die grense daarvan wat deur die Landmeter-generaal van Suidwes-Afrika verstrekk is; en

(ii) die volgende kaart soos hulle deur die Landmeter-generaal gemerk is volgens inligting deur U Kommissie verstrekk en waarop die juiste afbakening van die verskillende kiesafdelings aangedui is:

- (1) Suidwes-Afrika.
- (2) Khomasdal.

14. Waardering word uitgespreek vir die hulpvaardigheid en die bekwaame bystand verleen deur Mnr. W. W. Blomerus, Streekvertegenwoordiger van die Departement van Binnelandse Sake, wat ook as sekretaris opgetree het. Die Landmeter-generaal word ook bedank vir sy waardevolle medewerking en hulp.

15. U Kommissie het die eer, Meneer die Staatspresident om hom u onderdanige en dienswillige dienaar te noem.

This electoral division was heavily loaded but, in view of all the circumstances of the case, this load is regarded as appropriate.

(v) In the northern and central parts of the Territory 318 voters were found to be registered in Polling Districts 1 to 23, 25, 26, 28, 33, 34, 49, 78, 79, 80, 81 and 82 on the fixed date, and Your Commission was obliged to supplement this number. This could be done only by the addition of the 418 voters of Blocks 1, 2, 3 and 9 of Polling District 35 to this number. Your Commission decided to create an electoral division comprising these 736 voters, together with the remaining portion of Polling District 35 where there are no voters, and to call this electoral division TAMARISKIA. This electoral division was unloaded to a considerable extent, but it covers a very large area and the unload is regarded as appropriate.

(vi) After the delimitation of the above-mentioned five electoral divisions the position was as follows:

In Blocks 4, 5, 6, 7, 8 and 10 of Polling District 35 there were 485 voters left while on the fixed date there were 10 voters who were registered on small holdings in the vicinity of Brakwater north of Windhoek in the remaining portion of Polling District 35. Your Commission grouped these 495 voters with the 317 voters in Polling Districts 27, 30, 31, 32, 37, 38, 39, 40, 41, 42, 43, 44, 45, 47, 73, 83, 84, 86 and 87 and created an electoral division with 812 voters to be known as Khomasdal. Your Commission regretted having to divide the voters of Khomasdal but had no option.

### 13. Your Commission is attaching the following:

(i) An alphabetical list (Annexure A) of the various electoral divisions as delimited by Your Commission, together with a description of the boundaries of such divisions supplied by the Surveyor-General of South-West Africa; and

(ii) the following diagrams as marked by the Surveyor-General according to information supplied by Your Commission, on which the exact delimitation of the various electoral divisions is indicated:

- (1) South-West Africa.
- (2) Khomasdal.

14. The Commission would like to express its appreciation of the co-operativeness displayed by, and the efficient assistance rendered by, Mr W. W. Blomerus, Regional Representative of the Department of the Interior, who also acted as Secretary. Thanks are also due to the Surveyor-General for his valuable co-operation and assistance.
