ELECTED COLOURED COUNCIL OF SOUTH WEST AFRICA.—DIVISION OF ELECTORAL DIVISIONS INTO POLLING DISTRICTS

I, Jacobus Johannes Fouché, State President of the Republic of South Africa, declare in terms of section 40 (1) of the Electoral Consolidation Act, 1946 (Act 46 of 1946), read with Section 9 of the Establishment of an Elected Coloured Council for South West Africa Ordinance, 1966 (Ordinance 29 of 1966), that the several electoral divisions in the Territory of South-West Africa, as delimited by the First Delimitation Commission for the election of members of the Elected Coloured Council of South West Africa, and proclaimed by my Proclamation 158 of 30 August 1974, are hereby divided into polling districts as set out in the Annexure hereto.

Given under my Hand and the Seal of the Republic of South Africa at Cape Town this Thirtieth day of August, One thousand Nine hundred and Seventy-four.

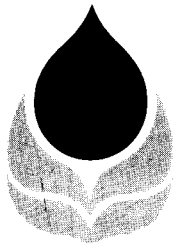

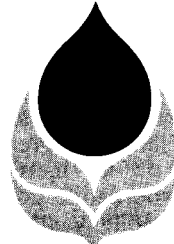
