ORDINANCE, 1975: PROMULGATION OF

LAND TAX ABOLITION ORDINANCE.

*(Assented to 25 March 1975.)**(English text signed by the Administrator.)**(Date of commencement 1 April 1975.)***ORDINANCE**

To provide for the abolition of Land tax; and to provide for incidental matters.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:-

Repeal of laws.

1. The laws specified in the Schedule are hereby repealed: Provided that any tax or penalty which but for such repeal would have been capable of being levied, assessed or recovered and which has not been levied, assessed or recovered at the commencement of this Ordinance, may be levied, assessed or recovered as if such repeal had not been effected.

Short title and commencement.

2. This Ordinance shall be called the Land Tax Abolition Ordinance, 1975, and shall come into operation on the first day of April, 1975.
