RESERVATION OF STATE LAND FOR NATIVES
AMENDMENT ORDINANCE, 1975.

(Assented to 4 July 1975).

ORDINANCE

To amend the Reservation of State Land for Natives Ordinance, 1967, to provide for the setting apart and reservation of further state land for the use and occupation of Natives.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, with the consent of the State President, in so far as such consent is necessary, previously obtained and communicated to the Legislative Assembly by message from the Administrator, as follows:-

1. The Schedule to the Reservation of State Land for Natives Ordinance, 1967 (Ordinance 35 of 1967), is hereby amended by the substitution for paragraph (2) under the heading "UNSURVEYED STATE LAND" of the following paragraph:

Amendment of Schedule to Ordinance 35 of 1967, as amended by section 2 of Ordinance 5 of 1969, section 1 of Ordinance 19 of 1971 and section 1 of Ordinance 16 of 1974.

"(2) Commencing at a point where the east line of longitude 18° 15' intersects the northern boundary of farm No. 1058, district of Grootfontein; thence westwards along the northern boundaries of farms No. 1058, No. 1059, district of Grootfontein, No. 1061, No. 1062, Last Hope No. 880 and Tsintsabis No. 881, district of Tsumeb, to the northwestern corner beacon of the said farm Tsintsabis No. 881; thence southwards along the western boundary of the said farm Tsintsabis No. 881 to the northeastern corner beacon of farm Rushof No. 878, district of Tsumeb; thence westwards along the northern boundaries of farms Rushof No. 878, Concordia No. 876, Vaalwater No. 875, No. 1075, No. 1074, No. 1073, No. 1072, No. 1071, No. 1070, No. 1069, No. 1068 and No. 1067, district of Tsumeb, to a point where the southwestern road reserve boundary of trunk road 1, section 10, intersects the northern boundary of the said farm No. 1067; thence northwestwards along the southwestern road reserve boundary of trunk road 1, section 10, to a point where the southwestern road reserve boundary of trunk road 1, section 10, intersects the southern boundary of the magisterial district of Ovamboland; thence eastwards along the southern boundaries of the magisterial districts of Ovamb-

boland and Okavangoland to a point where the east line of longitude 18° 15' intersects the southern boundary of the magisterial district of Okavangoland; thence southwards along the east line of longitude 18° 15' to the point of commencement."

Short title.

2. This Ordinance shall be called the Reservation of State Land for Natives Amendment Ordinance, 1975.
