CRIMINAL PROCEDURE AMENDMENT ORDINANCE, 1975.

*(Assented to 24 September 1975).

ORDINANCE

To amend the Criminal Procedure Ordinance, 1963, in relation to the constitution of superior courts for the trial of criminal cases and the application of certain provisions in respect of certain offences and sentences.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, with the consent of the State President previously obtained and communicated to the Assembly by message from the Administrator, as follows:-

Amendment of section 113 of Ordinance 34 of 1963, as substituted by section 9 of Ordinance 35 of 1965 and amended by section 1 of Ordinance 19 of 1967.

1. Section 113 of the Criminal Procedure Ordinance, 1963 (Ordinance 34 of 1963) — hereinafter referred to as the principal Ordinance — is hereby amended by the substitution for the proviso to subsection 1 of the following proviso:

“Provided that the judge presiding at the trial may appoint two assessors to sit with him at the trial.”.

2. The following section is hereby inserted in the principal Ordinance after section 340:

“Application of certain provisions in respect of certain offences.

340A. In die application of section 233, 234, 290 or 337 in respect of an offence under the National Supplies Procurement Act, 1970 (Act 89 of 1970), a reference in the section in question to an amount of one hundred rand shall be construed as a reference to an amount of five hundred rand.”.

3. This Ordinance shall be called the Criminal Procedure Amendment Ordinance, 1975.
