The Executive Committee has under and by virtue of the provisions of section 40 of the Peri-Urban Development Board Ordinance, 1970 (Ordinance 19 of 1970) approved the following amendments of the regulations promulgated by Government Notice 32 of 1972, as amended by Government Notices 153 of 1972, 64 and 266 of 1973, 67 of 1974 and 35 and 228 of 1976.

Substitute the following for Tariff 1 of Schedule B:

"1. For water consumed:

(a) *Hentiesbaai*: R0,19 per m³ or part thereof with a minimum monthly payment of R1,00 per erf, whether water is consumed or not, payable on all erven.

(b) *Kalkrand*:

(i) *Basic*: Payable on all erven whether water is consumed or not. R2,10 p.m.

(ii) *Consumption*: Per m³ or part of a m³ for water consumed. R0,20

(c) *Kamanjab*: R0,20 per m³ or part thereof with a minimum monthly payment of R1,50 per erf, whether water is consumed or not, payable on all erven."

**PADVERKEERSREGULASIES 1967 : WYSIGING
VAN REGULASIES 1, 63, 77 EN 161.**

Die Uitvoerende Komitee het kragtens en ingevolge die bepalings van artikel 165 van die Ordonnansie op Padverkeer, 1967 (Ordonnansie 30 van 1967) die Padverkeersregulasies 1967 soos afgekondig by Goewermentskennisgewing 95 van 1 Julie 1967, soos gewysig, gewysig -

(a) deur in regulasie 1 die woordbepaling van "bruto aseenheidmassalas" deur die volgende woordbepaling te vervang:

"'bruto aseenheidmassalas', met betrekking tot 'n motorvoertuig, die maksimum massalas van 'n besondere aseenheid van sodanige voertuig soos deur die vervaardiger daarvan gespesifiseer of, by ontstentenis van sodanige spesifikasie, soos deur die registrasie-owerheid bepaal;"

(b) deur die uitdrukking "1 Julie 1975" in paragraaf (a) van subregulasie (2) van regulasie 63 deur die uitdrukking "1 Julie 1976" te vervang;

(c) deur regulasie 77 deur die volgende regulasie te vervang:

"Driver's view to be unobstructed and rear-view mirror.

77. No person shall operate on a public road any motor vehicle -

(a) which is not so constructed and maintained as to afford the driver thereof a full and clear view of the roadway ahead and generally to his right and left when the vehicle is in use;

(b) which is not fitted with a rearview mirror or mirrors which will enable the driver of such vehicle when he is in the driving position to see in clear weather a clear reflection of traffic to the rear: Provided that the provisions of this paragraph shall not apply in respect of a tractor; and

(c) which, according to the registration certificate thereof, was registered for the first time after the Year 1977, and which is fitted with a rearview mirror, whether it is required to be so fitted in terms of paragraph (b) or not, of which the average radius of curvature is less than 1 200 mm."; and

(d) by the substitution in subregulation (1) of regulation 161 for the description of the regulatory sign R 14 A of the following description:

"R 14 A - Permissible maximum vehicle mass:

To indicate that any vehicle with its load exceeding the permissible maximum vehicle mass in metric tons on the sign is prohibited from using the roadway."

(c) wat, volgens die registrasiesertifikaat daarvan, na die jaar 1977 vir die eerste maal geregistreer is, en wat voorsien is van 'n truspieël, hetsy dit vereis word om ingevolge paragraaf (b) aldus voorsien te word aldan nie, waarvan die gemiddelde krommingsradius minder as 1 200 mm is nie."; en

(d) deur die beskrywing van reëlingsteken R 14 A in subregulasie (1) van regulasie 161 deur die volgende beskrywing te vervang:

"R 14 A - Toelaatbare maksimum voertuigmassa:

Om aan te dui dat enige voertuig met sy vrag wat die toelaatbare maksimum voertuigmassa in metrieke ton op die teken aangetoon, oorskry, verbied word om die ryvlak te gebruik."
