### AMENDMENT OF REGULATIONS MADE UNDER THE REFERENDUM ORDINANCE, 1977

### WYSIGING VAN REGULASIES UITGEVAARDIG KRAGTENS DIE ORDONNANSIE OP DIE VOLKSTEMMING, 1977

The Executive Committee has, under section 6(1) of the Referendum Ordinance, 1977 (Ordinance 3 of 1977), amended the regulations promulgated under Government Notice 115 of 23 March 1977 by the addition at the end of Schedule 2 of the following paragraph:

Die Uitvoerende Komitee het kragtens artikel 6(1) van die Ordonnansie op die Volkstemming, 1977 (Ordonnansie 3 van 1977), die regulasies afgekondig by Goewermentskennisgewing 115 van 23 Maart 1977 gewysig deur die volgende paragraaf aan die einde van Bylae 2 by te voeg:

“(c) in the case of the list of forms, envelopes and labels used at an election which is set out in Schedule B, by the substitution for the letters ‘EF’ wherever it occurs of the letters ‘SEF’.”

“(c) in die geval van die lys van vorms, koerte en etikette wat by ’n verkiesing gebruik word en wat in Bylae B uiteengesit word, deur die letters ‘EF’ oral waar dit voorkom deur die letters ‘SEF’ te vervang.”
