KIESERS INGEVOLGE DIE WET OP SELFREGE-
RING VIR REHOBOTH, 1976 (WET 56 VAN 1976)

Kennis word hiermee gegee ingevolge regulasie 14A van die regulasies in verband met die registrasie van kiesers vir die verkiesing van 'n Kaptein en lede van 'n Volksraad vir Rehoboth en die hou van sodanige verkiesings ingevolge die Wet op Selfregering vir Rehoboth, 1976 (Wet 56 van 1976) afgekondig by Goewermentskennisgewing R2478 van 17 Desember 1976 in Regulasioekoerant 2404 van 17 Desember 1976 soos gewysig; dat

- (a) a special supplementary registration of voters shall take place as from the date of promulgation of this notice to 23 August, 1977; and
- (b) a copy of the relevant special supplementary voters' list shall lie for inspection at the Magistrate's Office, Rehoboth, and the Police Station, Rehoboth, during the period 21 August 1977 to 2 September 1977; and
- (c) claims lodged in respect of inclusion in the special supplementary voters' list and objections to entries on the special supplementary voters' list shall be submitted during the period 6 September 1977 to 15 September 1977; and
- (d) such claims and objections if any shall be heard and determined by the Revision Court on 16 September 1977 in the Court room at Rehoboth at 10h00.
- (a) 'n spesiale aanvullende registrasie van kiesers plaasvind vanaf die datum van afkondiging van hierdie regulasie tot 23 Augustus 1977; en
- (b) 'n afskrif van die betrokke spesiale aanvullende kieserslys vir inspeksie lê by die Landdroskantoor, Rehoboth, en die Polisiestasie, Rehoboth, gedurende die tydperk 24 Augustus 1977 tot 2 September 1977; en
- (c) aansprake om op die spesiale aanvullende kieserslys geplaas te word en besware teen inskrywings op die spesiale aanvullende kieserslys ingedien moet word gedurende die tydperk 6 September 1977 tot 15 September 1977; en
- (d) sodanige aansprake en besware, indien enige, aangehoor en beslis word by die Hersieningshof op 16 September 1977 in die hofsaal te Rehoboth om 10h00 uur.
