ment Notice 203, dated 2 November 1942, are hereby

word hierby gewysig deur na regulasie 16(f) van hoofstuk 1 die volgende by te voeg:—

amended by the addition after regulation 16(f) of Chapter 1 of the following:—

(g) Houer van 'n woonpermit ten opsigte van 'n luukse munisipale 5 kamerhuis Tipe E3 R28,50 per maand of gedeelte daarvan: Met dien verstande dat die bewoner addisioneel vir water en elektrisiteit volgens meterverbruik, teen die tarief van tyd tot tyd deur die Raad by regulasie bepaal, moet betaal.

(g) Holder of a residential permit in respect of a luxury 5 roomed municipal house Type E3 R28,50 per month or portion thereof: Provided that the resident shall pay extra for water and electricity according to meter consumption at the tariff laid down by the Council by regulation from time to time.
