Wysiging van artikel 3 van Proklamasie AG. 9 van 1977

Amendment of section 3 of Proclamation AG. 9 of 1977

1. Artikel 3 van die Proklamasie op Veiligheidsdistrikte, 1977, word hierby gewysig —

1. Section 3 of the Security Districts Proclamation, 1977, is hereby amended —

(a) deur by paragraaf (a) van subartikel (1) die volgende subparagraaf by te voeg:

(a) by the addition to paragraph (a) of subsection (1) of the following subparagraph:

“(vi) wat enige persoon verbied om te eniger tyd gedurende die nag op enige plek binne 'n

“(vi) prohibiting any person from putting in motion or driving or travelling by any vehicle,

veiligheidsdistrik in die bevel genoem, of op enige plek binne 'n gebied wat in 'n veiligheidsdistrik geleë en in die bevel aangedui is, 'n voertuig in beweging te bring of te bestuur of daarvan te reis of in of op 'n bewegende voertuig te wees."; en

or being in or upon any vehicle that is in motion, at any time during the night at any place within a security district mentioned in the order, or at any place within an area situated in a security district and indicated in the order."; and

- (b) deur in paragraaf (c) van genoemde subartikel (1) die uitdrukking "paragraaf (a)(v)" deur die uitdrukking "subparagrawe (a)(v) en (vi)" te vervang.

- (b) by the substitution in paragraph (c) of the said subsection (1) for the expression "paragraph (a)(v)" of the expression "subparagraphs (a)(v) and (vi)".

ORDER UNDER SECURITY DISTRICTS PROCLAMATION, 1977, IN RELATION TO THE MOVEMENT OF PERSONS IN VEHICLES IN OWAMBO

Under the powers vested in me by section 3 of the Security Districts Proclamation, 1977 (Proclamation AG. 9 of 1977), I hereby order that no person shall put in motion, drive or travel by any vehicle, or be therein or thereon, at any time during the night in the district of Owambo without the permission in writing of a peace officer, as defined in section 1 of the Criminal Procedure Act, 1977 (Act 51 of 1977), or any officer of the security forces.
