BYLAE

1. Aanhangsel I.D.1 by die regulasies afgekondig in die *Offisiële Koerant* by kennisgewing 231 van 1 Augustus 1953 (hieronder die regulasies genoem), word hierby gewysig deur paragraaf 3(g) deur die volgende paragraaf te vervang:

AMENDMENT OF REGULATIONS MADE
UNDER THE WAGE AND INDUSTRIAL
CONCILIATION ORDINANCE, 1952
(ORDINANCE 35 OF 1952)

The Administrator-General has under section 75 of the Wage and Industrial Conciliation Ordinance, 1952 (Ordinance 35 of 1952), made the following regulations.

SCHEDULE

1. Annexure I.D.1 to the regulations published in the *Official Gazette* under notice 231 of 1 August 1953 (hereinafter referred to as the regulations) is hereby amended by the substitution for paragraph 3(g) of the following paragraph:

"(g) the membership of the union, the standing of members, and the number of persons eligible for membership, but not enrolled, are as at this date:

3. Aanhangsel I.D.6 by die regulasies word hierby gewysig deur die woorde "(d) Persone wat deur die woordbepaling 'werkneem' uitgesluit word, is/is nie in die geskil betrokke nie" en die voetnota te skrap terwyl paragraaf (e) paragraaf (d) word.

4. Aanhangsel G.1 by die regulasies word hierby gewysig deur die woorde "(7) By die toepassing van hierdie artikel sluit die woorde 'werkneem' 'n inboorling, soos bepaal by artikel agt-en-veertig van die Ordonnansie, uit" te skrap.

5. Aanhangsel G.5 by die regulasies word hierby gewysig deur die syfer "4" en die woorde "Ras (Blanke, Kleurling, Asiaat of Naturel)" in kolom 4 te skrap terwyl kolomme 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 en 19, onderskeidelik, kolomme 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17 en 18 word.

2. Annexure I.D.2 to the regulations is hereby amended by the substitution for paragraph 3(g) of the following paragraph:

"(g) The membership of the organization, the standing of members and the number of persons eligible for membership, but not enrolled, are at this date:

3. Annexure I.D.6 to the regulations is hereby amended by the deletion of the words "(d) Persons excluded from the definition of 'employee' are/are not involved in the dispute" and the footnote while paragraph (e) becomes paragraph (d).

4. Annexure G.1 to the regulations is hereby amended by the deletion of the words "(7) For the purposes of this section the term 'employee' shall not include any Native as defined by section forty-eight of the 'Ordinance'".

5. Annexure G.5 to the regulations is hereby amended by the deletion in column 4 of the figure "4" and the words "Race (European, Coloured, Asiatic or Native)" while columns 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19 become columns 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17 and 18, respectively.
