Wysiging van artikel 1 van Ordonnansie 34 van 1965

1. Artikel 1 van die Ordonnansie op die Instelling van Bestuursvorme in Kleurlingdorpe, 1965 (hieronder die Ordonnansie genoem), word hierby gewysig —

AMENDMENT OF THE ESTABLISHMENT OF
LOCAL GOVERNMENT IN COLOURED TOWN-
SHIPS ORDINANCE, 1965 (ORDINANCE 34 OF
1965)

SCHEDULE

Amendment of section 1 of Ordinance 34 of 1965

1. Section 1 of the Establishment of Local Government in Coloured Townships Ordinance, 1965 (hereinafter referred to as the Ordinance), is hereby amended —

- (a) by the substitution for the definition of "Coloured township" of the following definition:

"Coloured township" means an approved township as defined in section one of the Townships and Division of Land Ordinance,

1963 (Ordinance 11 of 1963), of which the erven are subject to a condition, imposed under section six of the said Townships and Division of Land Ordinance, 1963, that only Coloureds or Coloureds and any other group or class of persons may be permitted to own or occupy the erven in question;"; and

(b) deur in die omskrywing van "plaaslike bestuur" die woorde "munisipale raad" deur die woord "munisipaliteit" te vervang.

(b) by the substitution in the Afrikaans text in the definition of "plaaslike bestuur" for the words "munisipale raad" of the word "munisipaliteit".

Wysiging van artikel 3 van Ordonnansie 34 van 1965

Amendment of section 3 of Ordinance 34 of 1965

2. Artikel 3 van die Ordonnansie word hierby gewysig deur in subartikel (1) die woorde "waarvoor 'n bestuurskomitee ingevolge artikel twee ingestel is" te skrap.

2. Section 3 of the Ordinance is hereby amended by the deletion in subsection (1) of the words "for which a management committee has been established in terms of section two".
