AMENDMENT OF THE PROCLAMATION THAT  
PROVIDES FOR THE ESTABLISHMENT OF A  
NAMA COUNCIL, TRIBAL AUTHORITIES AND  
VILLAGE MANAGEMENT BOARDS IN  
NAMALAND

Under the powers vested in me by Proclamation 181 of 19 August 1977, I hereby amend section 6 of Proclamation 160 of 11 July 1975, by the substitution in subsection (1) for the word "four" of the word "three".

This Proclamation shall be deemed to have come into operation on 1 January 1978.
