MENTAL HEALTH ACT, 1973 (ACT 18 OF 1973): DESIGNATION OF CERTAIN MEMBERS OF THE PRISON SERVICE TO SIGN ORDERS, WARRANTS AND DOCUMENTS

Under section 74 of the Mental Health Act, 1973 (Act 18 of 1973), I hereby authorise the Commissioner of Prisons and any Chief Deputy Commissioner, Deputy Commissioner or Assistant Commissioner of Prisons and the Regional Commissioner of Prisons for the territory of South West Africa to sign any order, warrant or document which may be issued by me under sections 28 and 30 to 41 of the said Act.

Government Notice 1601 of 22 August 1975 is hereby repealed.
